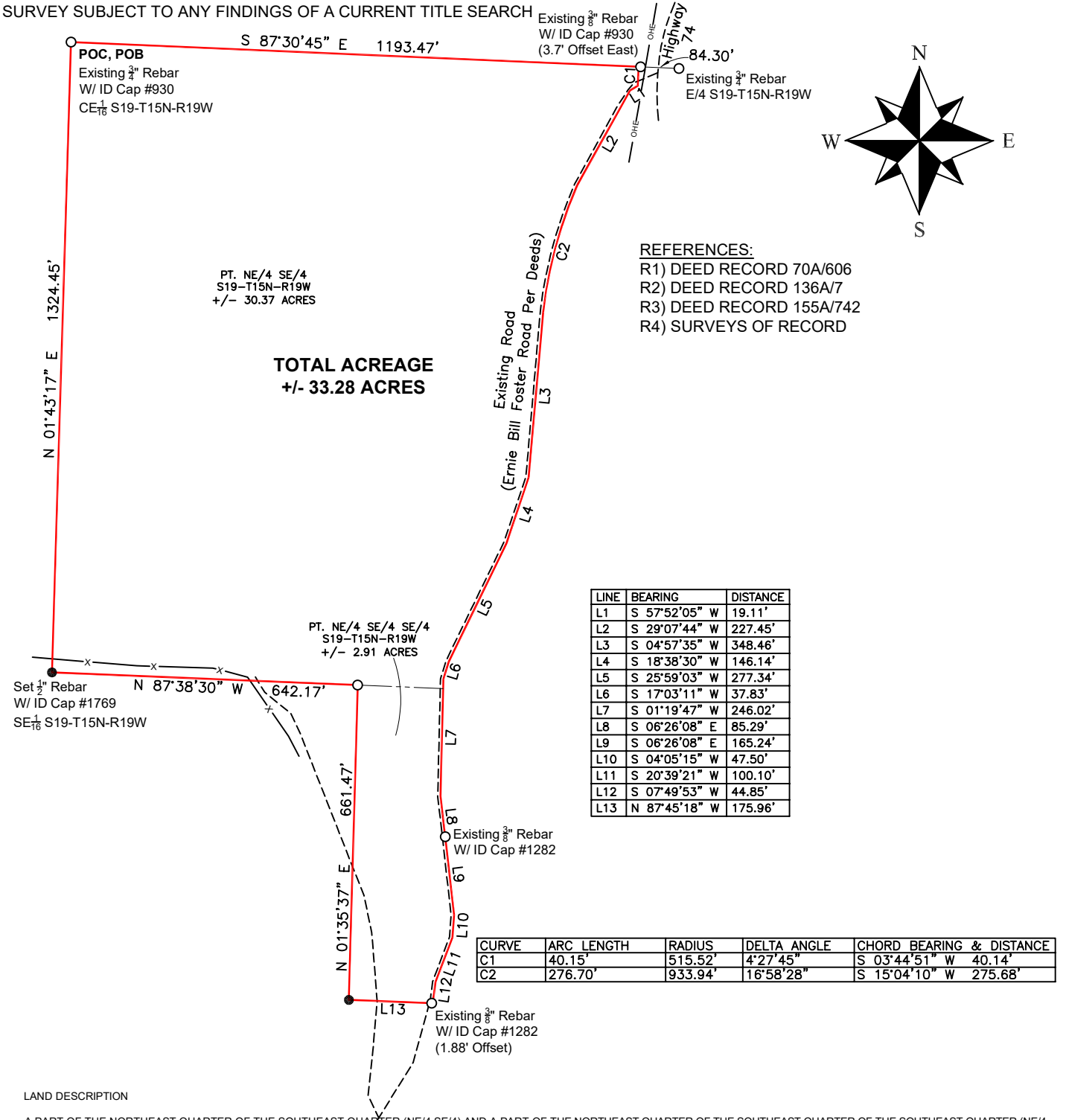


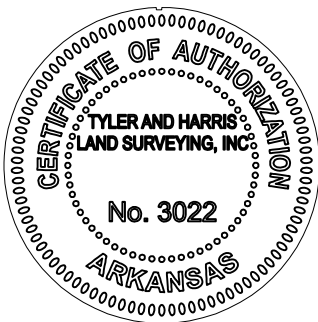
SURVEY SUBJECT TO ANY FINDINGS OF A CURRENT TITLE SEARCH



LAND DESCRIPTION

A PART OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE/4 SE/4) AND A PART OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER (NE/4 SE/4 SE/4) OF SECTION NINETEEN (19), TOWNSHIP FIFTEEN (15) NORTH, RANGE NINETEEN (19) WEST OF THE FIFTH PRINCIPAL MERIDIAN, NEWTON COUNTY, ARKANSAS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING THREE-QUARTER INCH REBAR WITH ID CAP #930 MARKING THE NORTHWEST CORNER OF THE NE/4 SE/4 OF SAID SECTION 19, SAID POINT ALSO BEING THE POINT OF BEGINNING OF TRACT BEING DESCRIBED, THENCE ALONG THE NORTH LINE OF SAID NE/4 SE/4 SOUTH 87° 30' 45" EAST (BEARINGS BASED ON GRID NORTH NAD 83) 1193.47 FEET (DISTANCES ARE GROUND DISTANCE) TO A POINT ON THE WESTERLY RIGHT OF WAY OF HIGHWAY 74, SAID POINT ALSO BEING ON THE ARC OF A CURVE CONCAVE EAST, HAVING A RADIUS OF 515.52 FEET AND A CHORD BEARING AND DISTANCE OF SOUTH 03° 44' 51" WEST 40.14, THEN LEAVING SAID NORTH LINE AND ALONG SAID RIGHT OF WAY AND ARC OF SAID CURVE 40.15 TO A POINT ON THE EAST SIDE OF AN EXISTING ROAD (ALSO KNOWN AS ERNIE BILL FOSTER ROAD), THENCE LEAVING SAID RIGHT OF WAY AND ALONG SAID EAST SIDE OF EXISTING ROAD THE FOLLOWING COURSES: SOUTH 57° 52' 05" WEST 19.11 FEET, SOUTH 29° 07' 44" WEST 227.45 FEET TO THE BEGINNING OF A CURVE CONCAVE EAST, HAVING A RADIUS OF 933.94 FEET AND A CHORD BEARING AND DISTANCE OF SOUTH 15° 04' 10" WEST 275.68 FEET, THEN CONTINUING ALONG SAID EAST SIDE AND ARC OF SAID CURVE 276.70 FEET TO A POINT, THENCE CONTINUING ALONG SAID EAST SIDE THE FOLLOWING COURSES: SOUTH 04° 57' 35" WEST 348.46 FEET, SOUTH 18° 38' 30" WEST 146.14 FEET, SOUTH 25° 59' 03" WEST 277.34 FEET, SOUTH 17° 03' 11" WEST 37.83 FEET, SOUTH 01° 19' 47" WEST 246.02 FEET, SOUTH 06° 26' 08" EAST 85.29 FEET TO AN EXISTING THREE-EIGHTHS INCH REBAR WITH ID CAP #1282, SOUTH 06° 26' 08" EAST 165.24 FEET, SOUTH 04° 05' 15" WEST 47.50 FEET, SOUTH 20° 39' 21" WEST 100.10 FEET, SOUTH 07° 49' 53" WEST 44.85 FEET TO A POINT ON THE SOUTH LINE OF THE NE/4 SE/4 SE/4 OF SAID SECTION 19, THENCE LEAVING SAID EAST SIDE OF ROAD NORTH 87° 45' 18" WEST 175.96 FEET TO A SET ONE-HALF INCH REBAR WITH ID CAP #1769 MARKING THE SOUTHWEST CORNER OF SAID NE/4 SE/4 SE/4, THENCE NORTH 01° 35' 57" EAST 661.47 FEET TO AN EXISTING THREE-EIGHTHS INCH REBAR WITH ID CAP #930 MARKING THE NORTHWEST CORNER OF SAID NE/4 SE/4 SE/4, THENCE NORTH 87° 38' 30" WEST 642.17 FEET TO A SET ONE-HALF INCH REBAR WITH ID CAP #1769 MARKING THE SOUTHWEST CORNER OF SAID NE/4 SE/4, THENCE NORTH 01° 43' 17" EAST 1324.45 FEET TO THE POINT OF BEGINNING, CONTAINING 33.28 ACRES AGGREGATE, MORE OR LESS.
