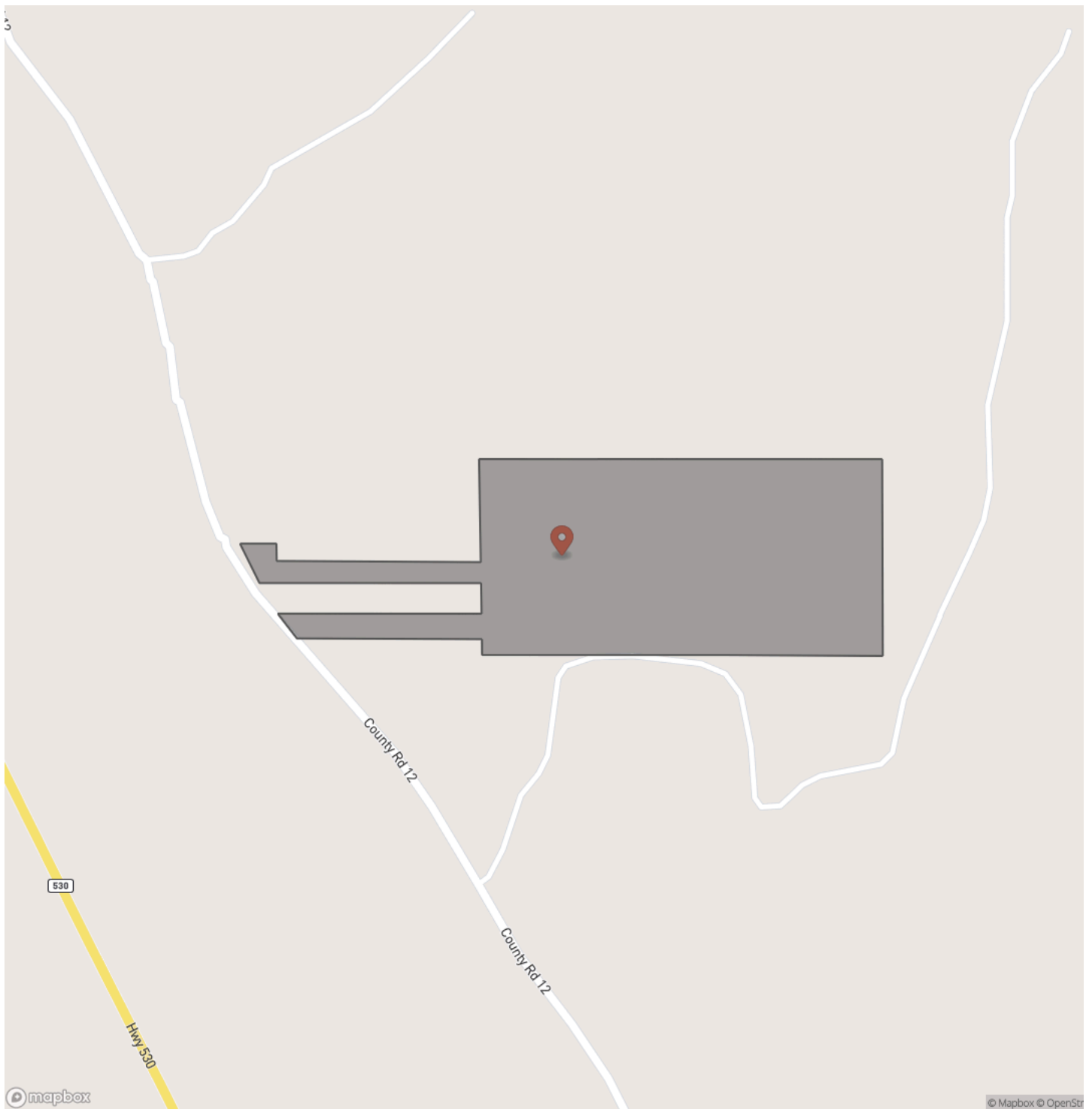

PROPERTY DESCRIPTION

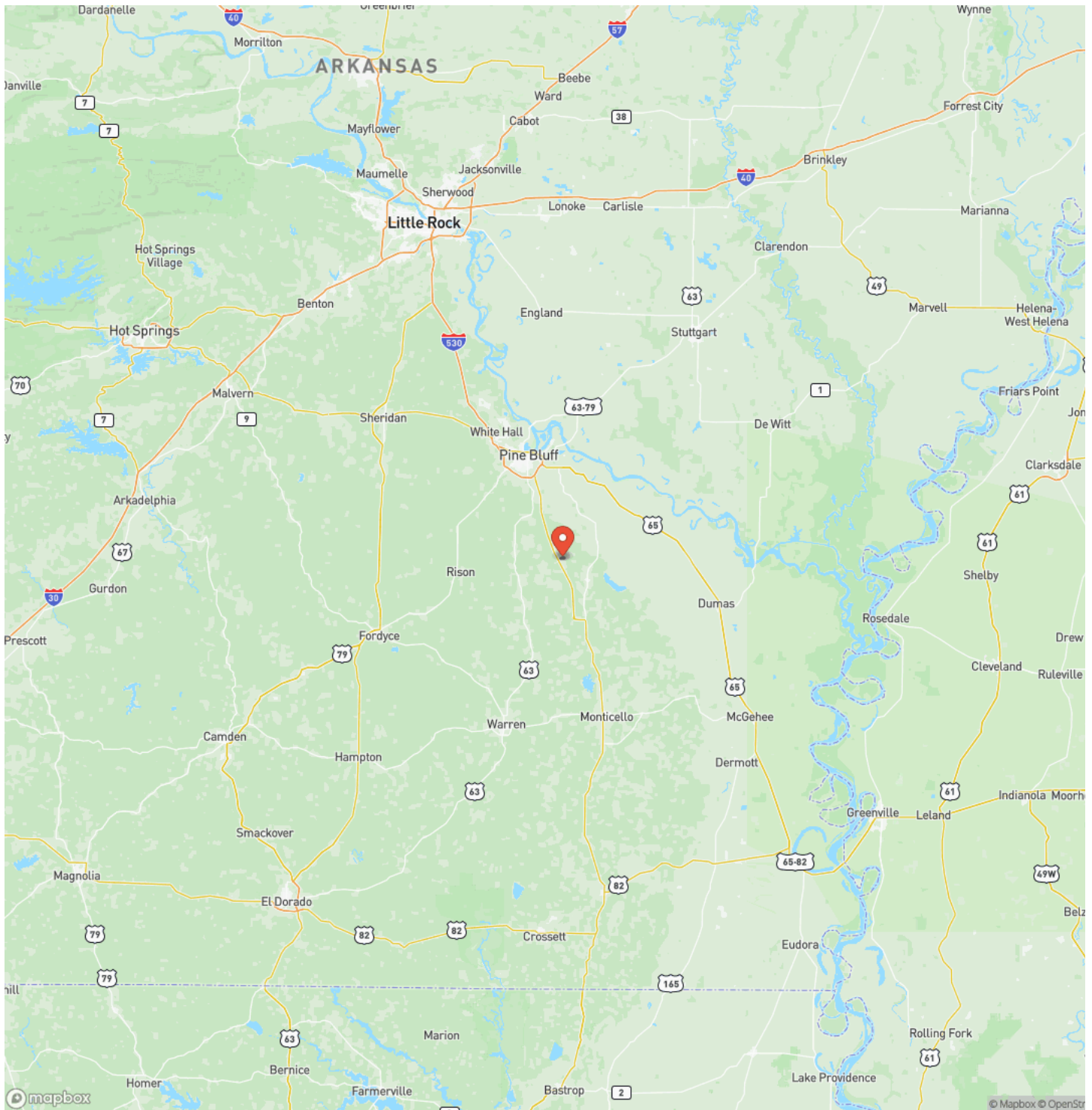
