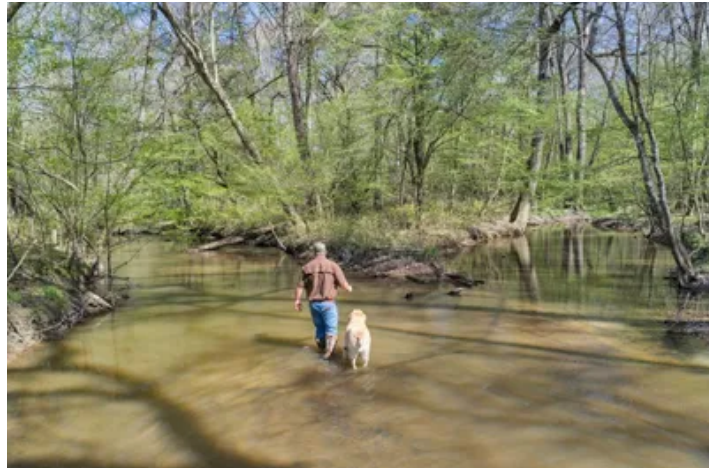

From the large Oak and Pecan trees casting shadows over an established road, you pass by a vacant pasture primed for livestock or your forever home. 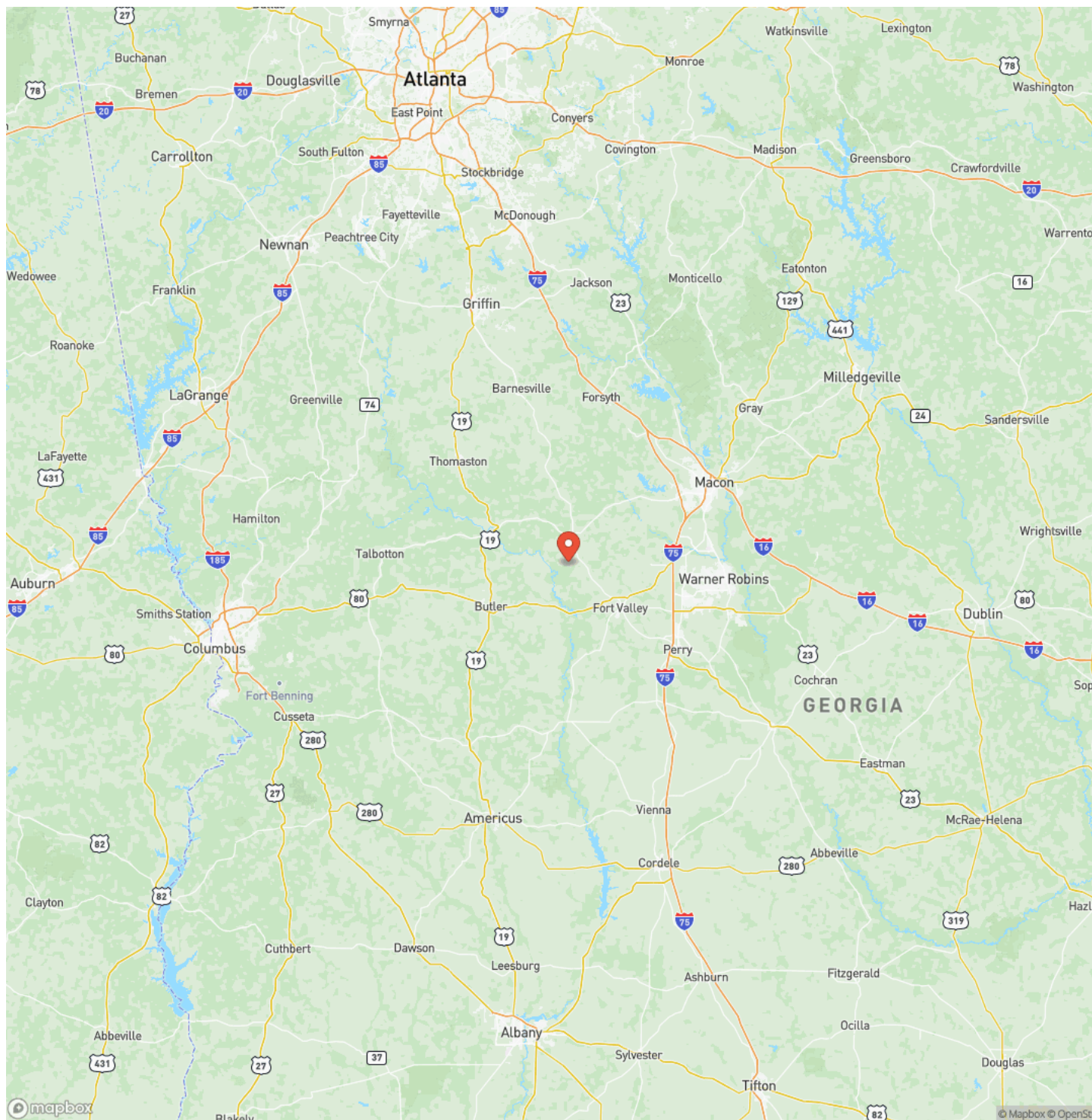
