Nearly 30 Acres - Piatt County Timber, Two Shops, and Real Deer Traffic

This is what peace and quiet actually means. Nearly 30 mostly wooded acres, sitting right out in the middle of the fields, where all you hear is the birds. No through traffic, no close neighbors - just timber, trails, and room to think.

The house is a fixer-upper: good bones, a new roof, poured concrete foundation, and a whole-property backup generator already in place. Bring your own vision and make it whatever you want it to be - the hard infrastructure is already handled.

For equipment and projects, there's a 30x50 shed with a concrete floor, electricity, and 3 electric overhead doors - ready to work out of from day one. A second building, 40x60, is built for livestock or tractor storage, with room to spare for hay, equipment, or a growing operation.

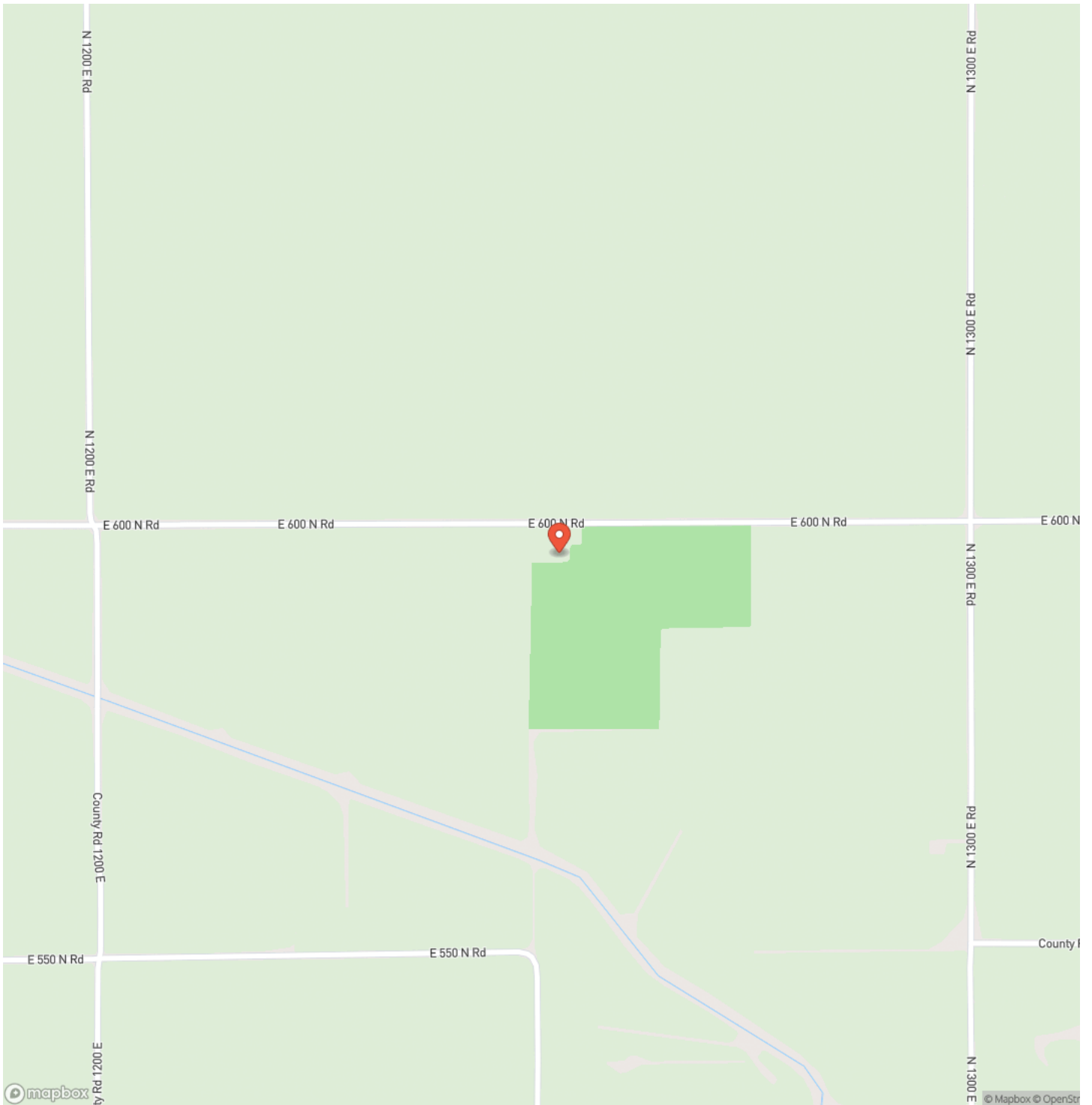
Hunters will want to look closely at this one. The timber runs a good mix of species with plenty of deer sign throughout, and the whitetail here follow the nearby Lake Fork tributary as a travel corridor, moving through the property on a consistent pattern. Trails are cut wide enough for a mid-size tractor, so getting back into the timber - for a hunt, for firewood, or just to check on things - is never a chore.

Whether you're a farmer who needs more ground and storage, a hunter after a property with real, established deer movement, or someone who just wants acreage, quiet, and a place to make your own - this one's worth a look.

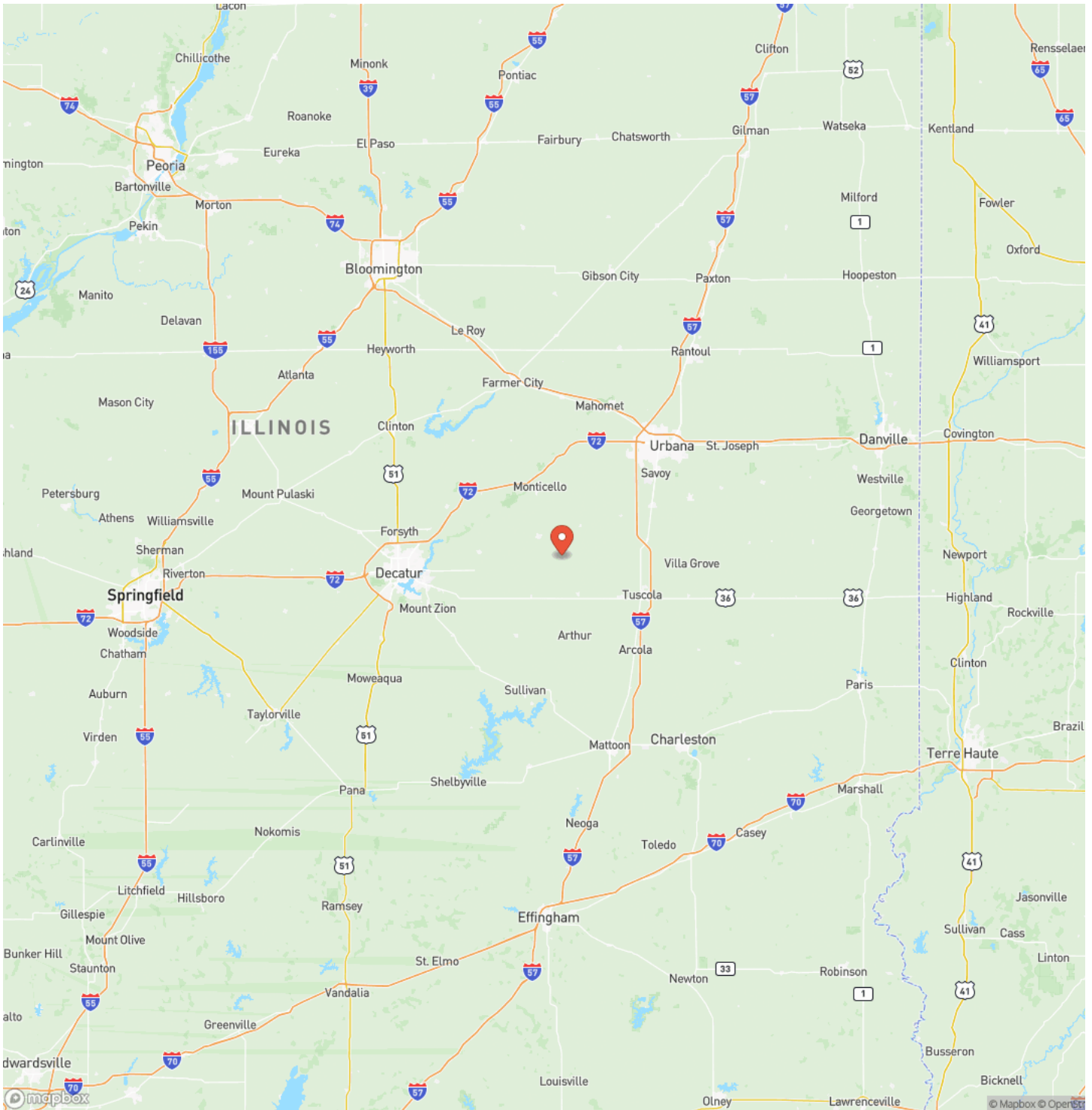

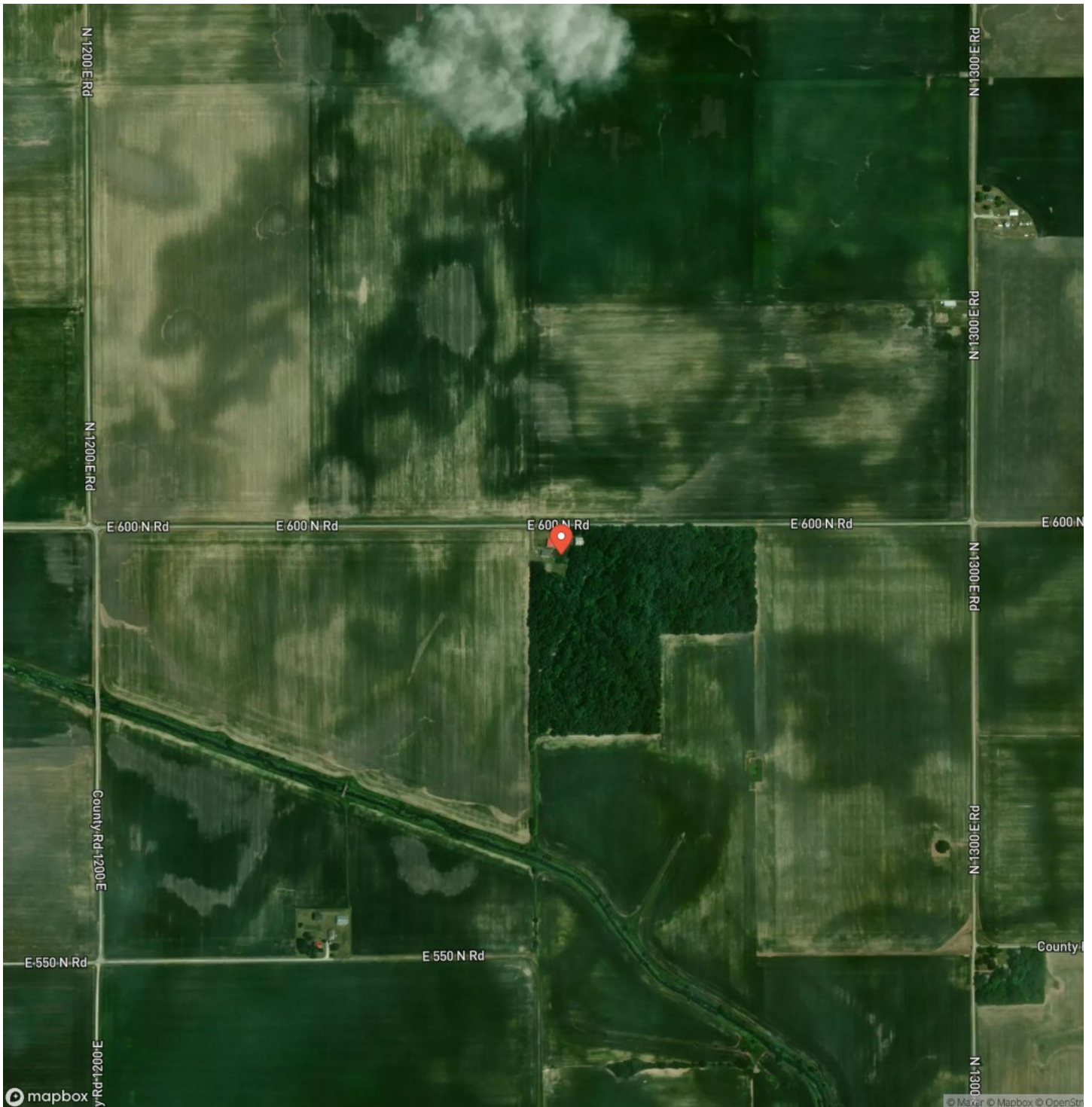
Locator Map
