A 10.33+/- acre tract of land in Section 140, Block 6, I.&G.N. RR. Co. Survey, Randall County, Texas, being a portion of that certain 314.08 acre tract of land being described in that certain instrument recorded under Clerk's File No. 2024000121 of the Official Public Records of Randall County, Texas, (OPRR) said 10.33+/- acre tract of land having been surveyed on the ground on March 17, 2026 by Furman Land Surveyors, Inc. and being described by metes and bounds as follows:

COMMENCING at a 1/2 inch iron rod with cap (FURMAN) found, of record, in the North Right-of-Way line of Cemetery Road as dedicated per plat of Canyon Draw Prairie Unit No. 1, a rural subdivision to Randall County, according to the map or plat thereof, recorded under Clerk's File No. 2023011692 (OPRR), for the most South Southeast corner of Lot 2, said Canyon Draw Prairie Unit No. 1, from whence a fence post found, of record, for the Southwest corner of said Canyon Draw Prairie Unit No. 1 bears S. 89° 56' 39" W. (Base line) 634.05 feet;

THENCE N. 89° 56' 39" E. 24.70 feet on the North Right-of-Way line of said Cemetery Road to the most South Southwest and BEGINNING CORNER of this tract of land;

THENCE N. 00° 03' 21" W. 1341.00 feet to the Northeast corner of that certain 10.17+/- acre tract of land surveyed simultaneously, same being an interior corner of this tract of land;

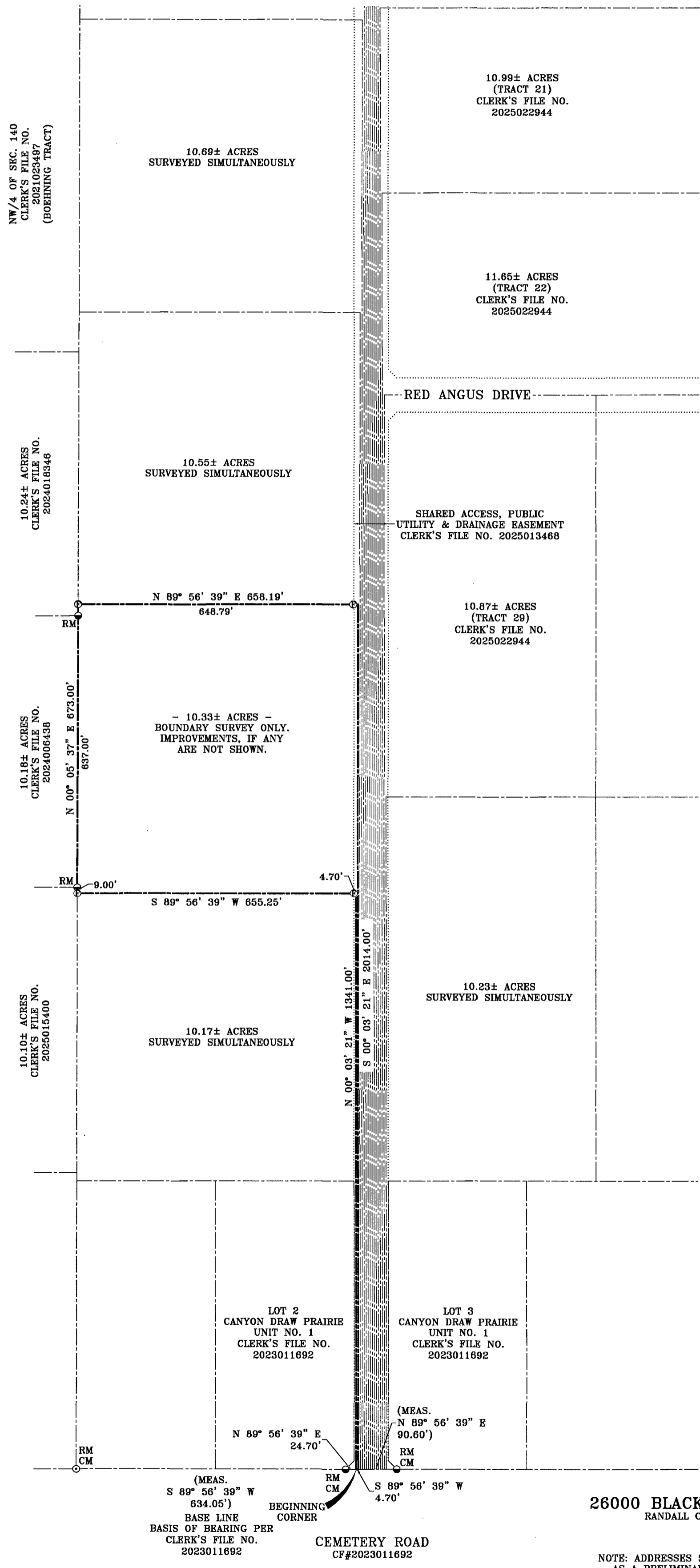
THENCE S. 89° 56' 39" W. on the North line of said 10.17+/- acre tract of land surveyed simultaneously, at 4.70 feet pass a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set, continuing for a total distance of 655.25 feet to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set in the East line of that certain 10.10+/- acre tract of land being described in that certain instrument recorded under Clerk's File No. 2025015400 (OPRR), same being the West line of said 314.08 acre tract of land, for the Northwest corner of said 10.17+/- acre tract of land surveyed simultaneously, same being the most West Southwest corner of this tract of land;

THENCE N. 00° 05' 37" E. along the common line of said 10.10+/- acre tract of land and said 314.08 acre tract of land, at 9.00 feet pass a 1/2 inch iron rod with cap (FURMAN) found, of record, for the most East Southeast corner of that certain 10.18+/- acre tract of land being described in that certain instrument recorded under Clerk's File No. 2024006438 (OPRR), same being the Northeast corner of said 10.10+/- acre tract of land, at 646.00 feet pass a 1/2 inch iron rod with cap (FURMAN) found, of record, for the most East Southeast corner of that certain 10.24+/- acre tract of land being described in that certain instrument recorded under Clerk's File No. 2024018346 (OPRR), same being the Northeast corner of said 10.18+/- acre tract of land, continuing for a total distance of 673.00 feet to a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set for the most West Southwest corner of that certain 10.55+/- acre tract of land surveyed simultaneously, same being the Northwest corner of this tract of land;

THENCE N. 89° 56' 39" E. on a common line with said 10.55+/- acre tract of land surveyed simultaneously, at 648.79 feet pass a 1/2 inch iron rod with cap stamped "FURMAN RPLS" set, continuing for a total distance of 658.19 feet to an interior corner of said 10.55+/- acre tract of land surveyed simultaneously, same being the Northeast corner of this tract of land;

THENCE S. 00° 03' 21" E. 2014.00 feet on a common line with said 10.55+/- acre tract of land surveyed simultaneously to a point in the North Right-of-Way line of said Cemetery Road for the Southeast corner of this tract of land, from whence a 1/2 inch iron rod with cap (FURMAN) found, of record, for the most South Southwest corner of Lot 3, said Canyon Draw Prairie Unit No. 1, bears N. 89° 56' 39" E. 90.60 feet;

THENCE S. 89° 56' 39" W. 4.70 feet on the North Right-of-Way line of said Cemetery Road to the PLACE OF BEGINNING and containing 10.33 acres of land, more or less.
