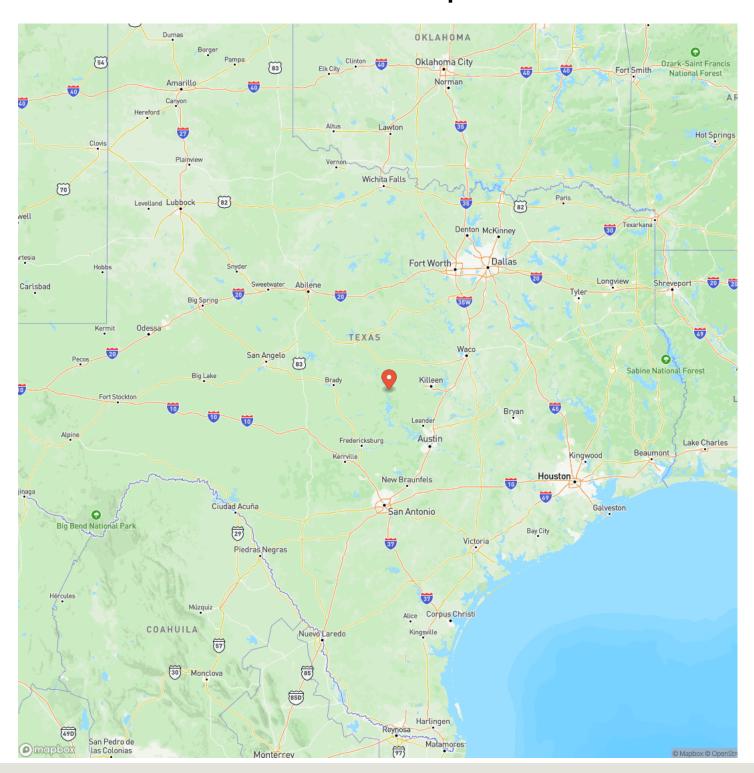

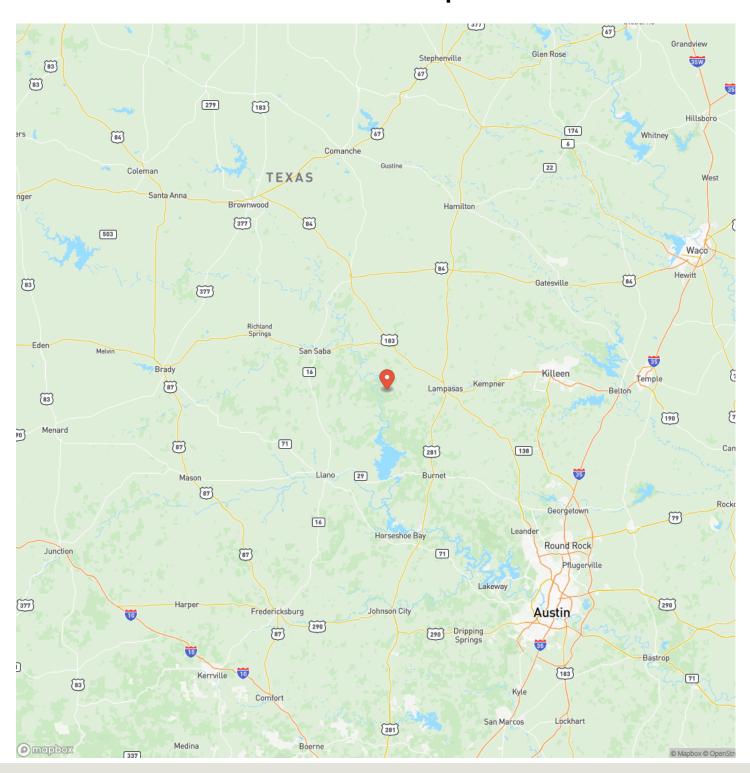
Locator Map

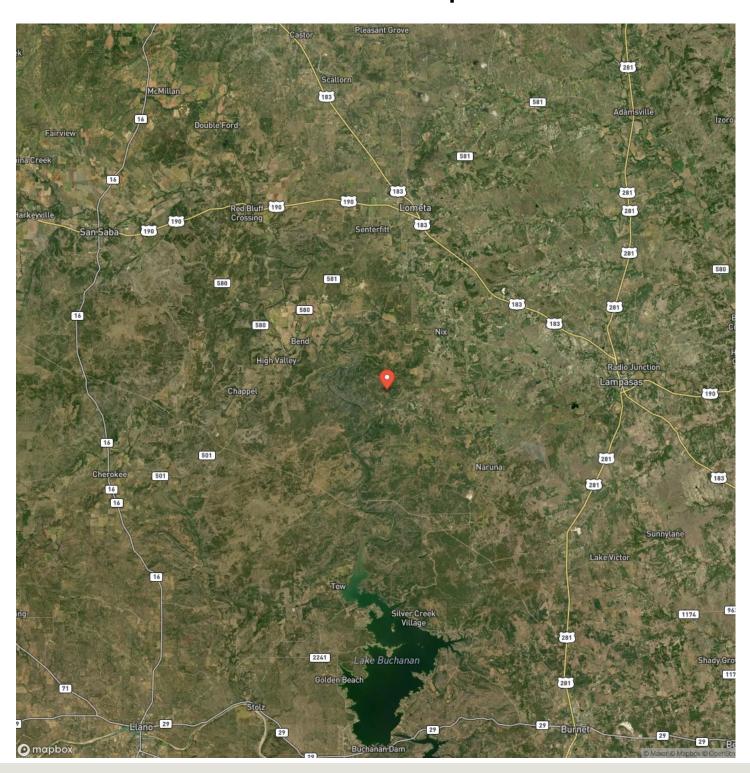
