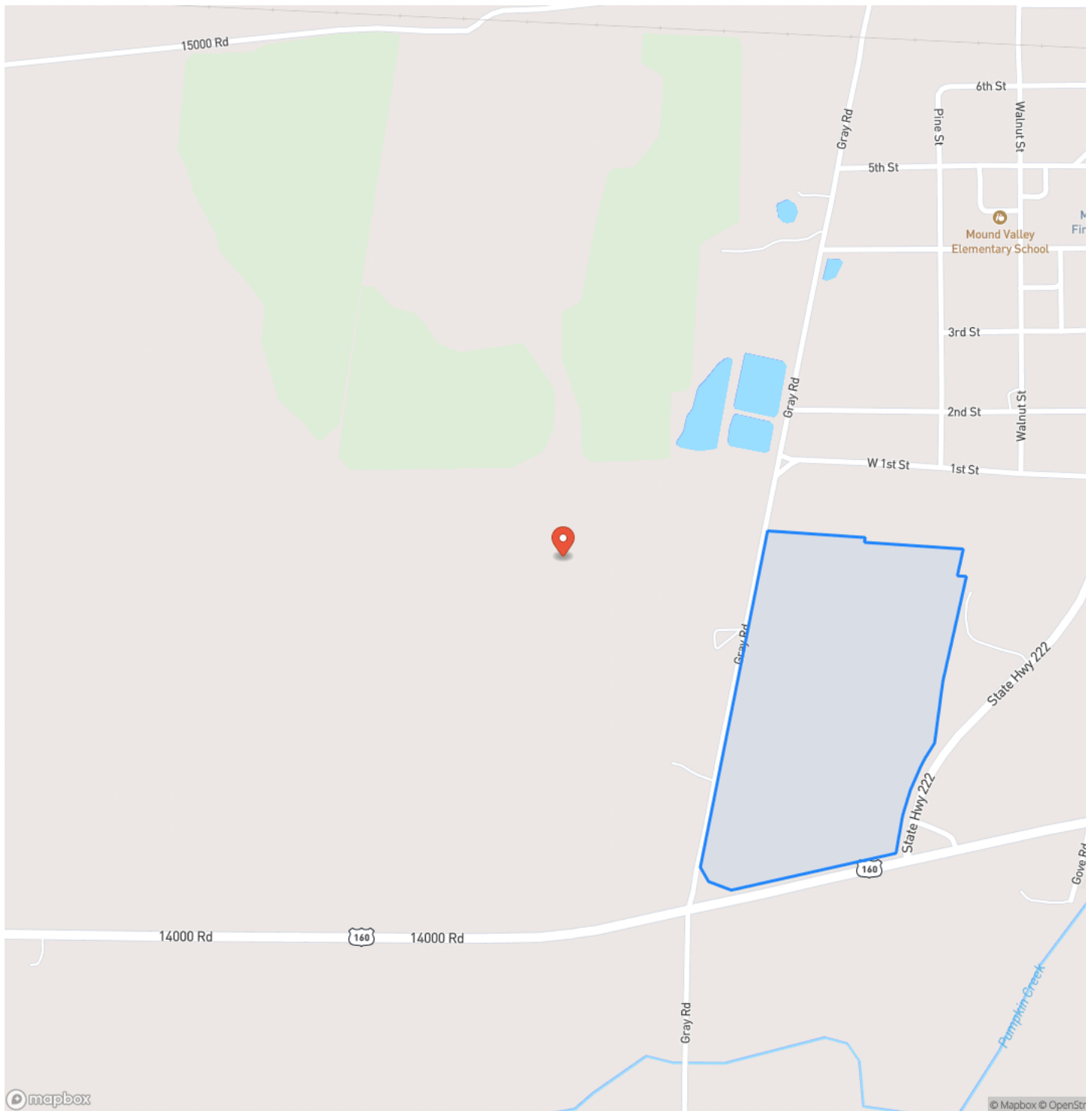

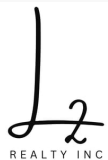
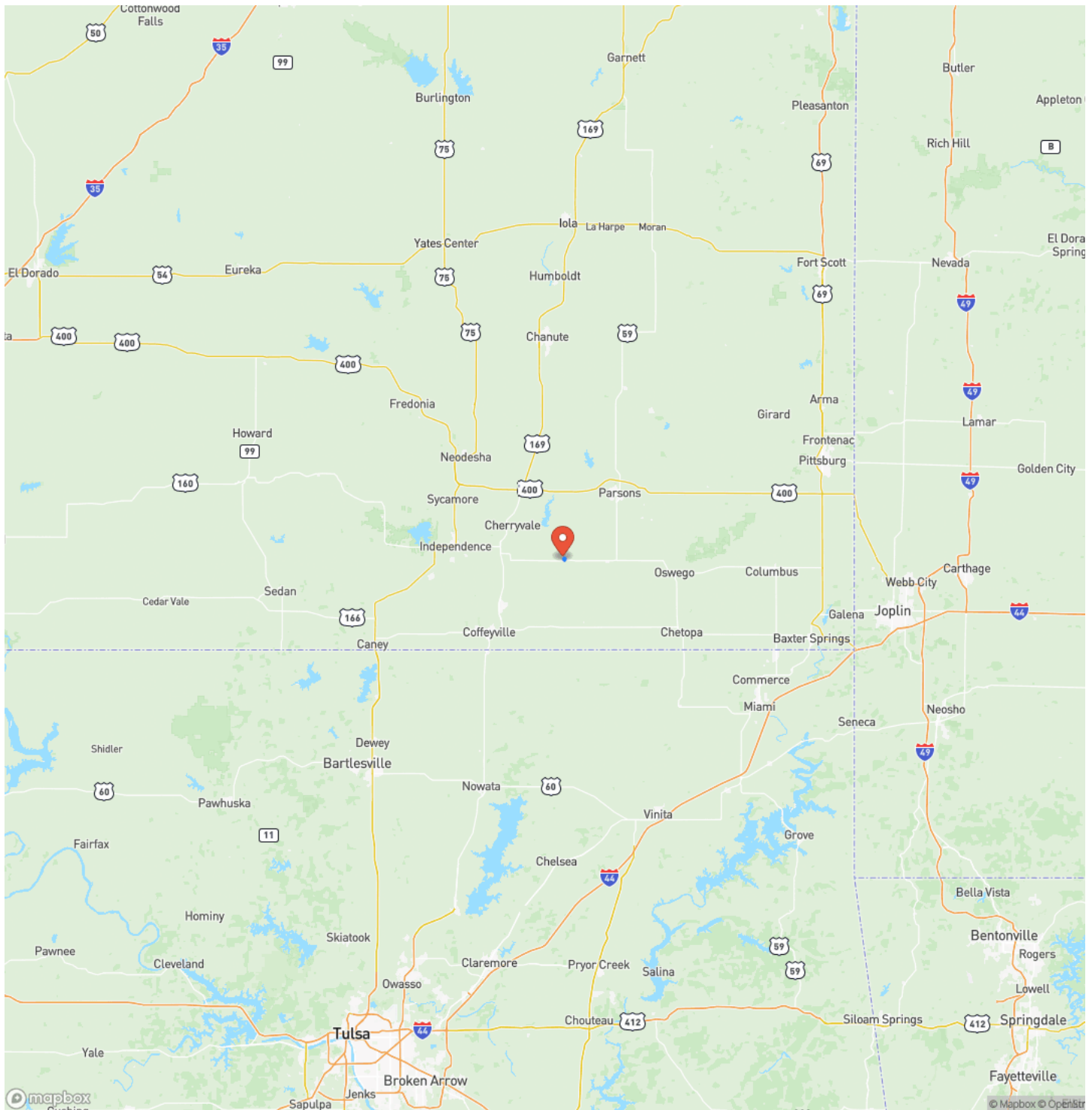


Locator Map
