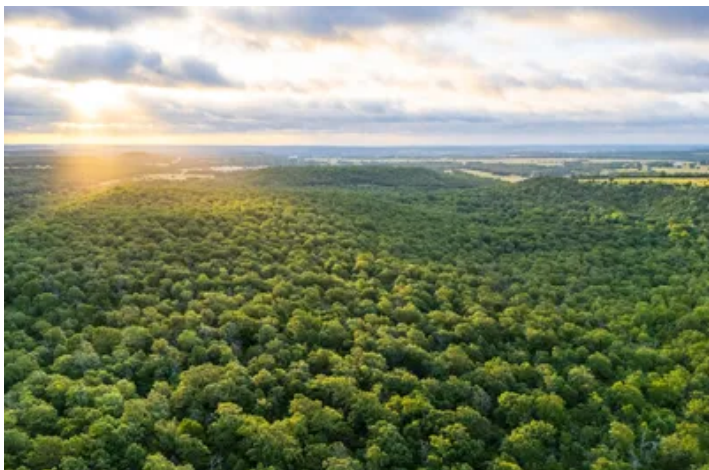

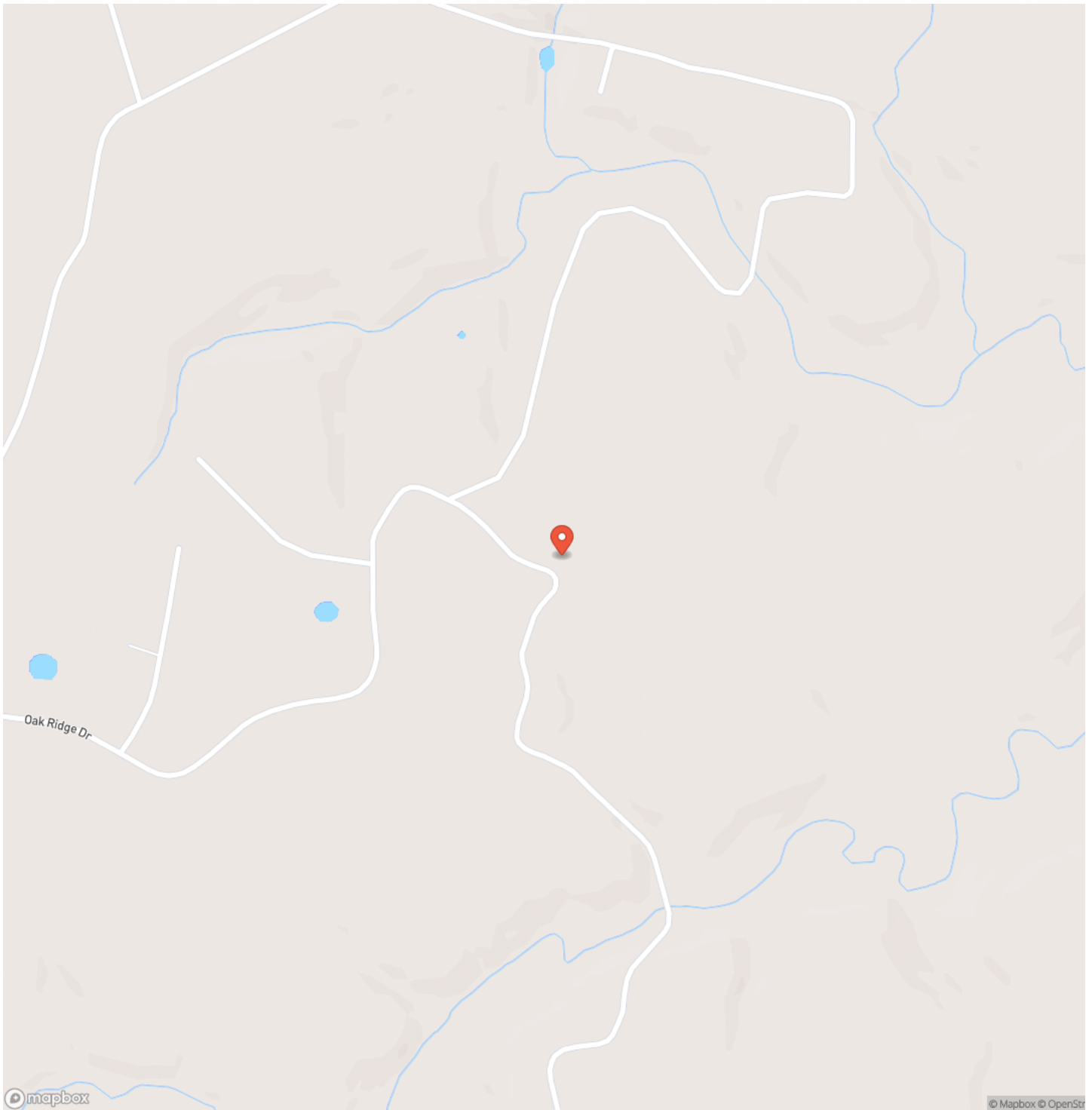

The abundance of mature oak trees provides excellent acorn production, creating a natural food source that helps draw and hold deer on the property throughout the hunting season. 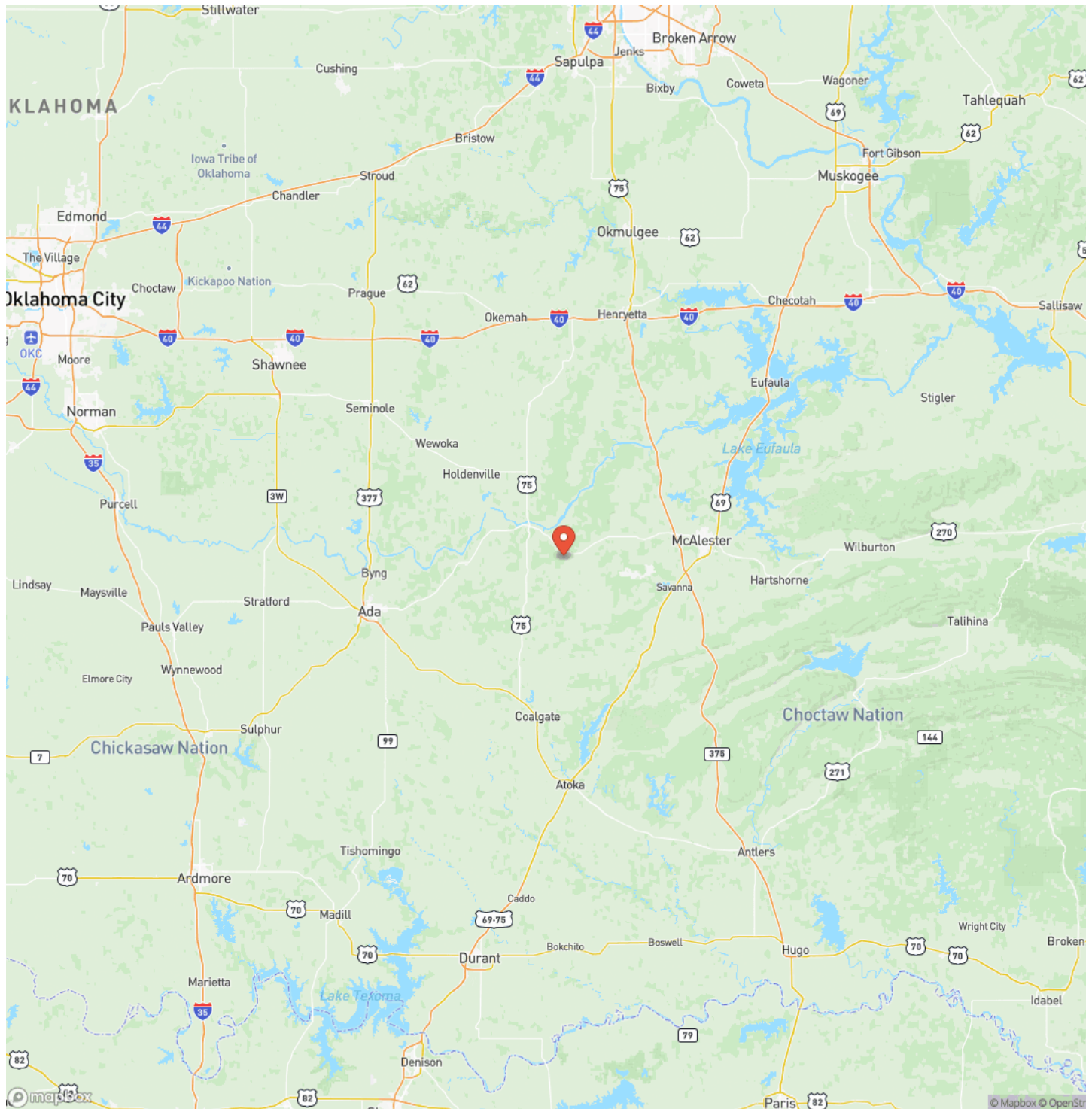

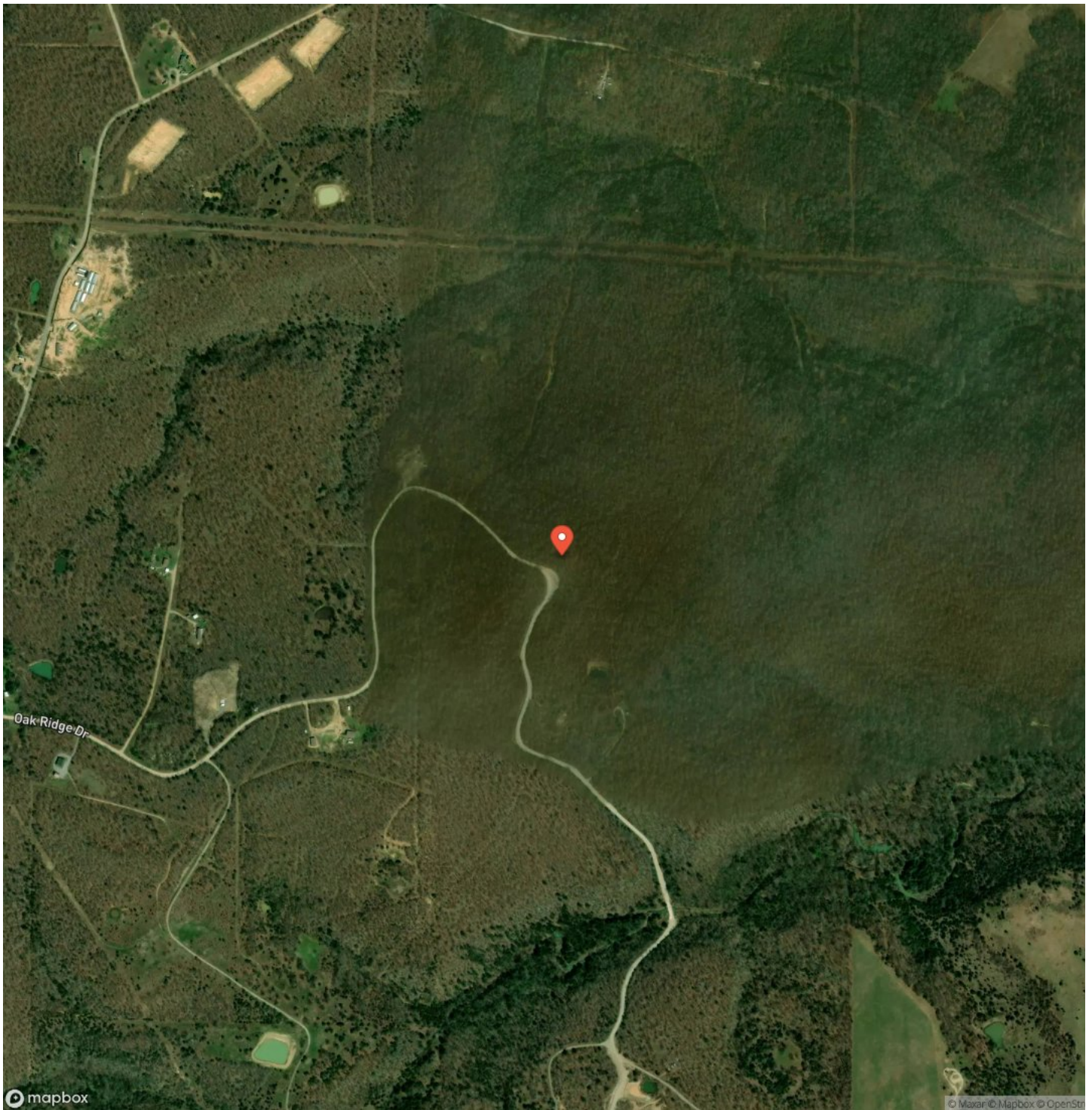
Locator Map
