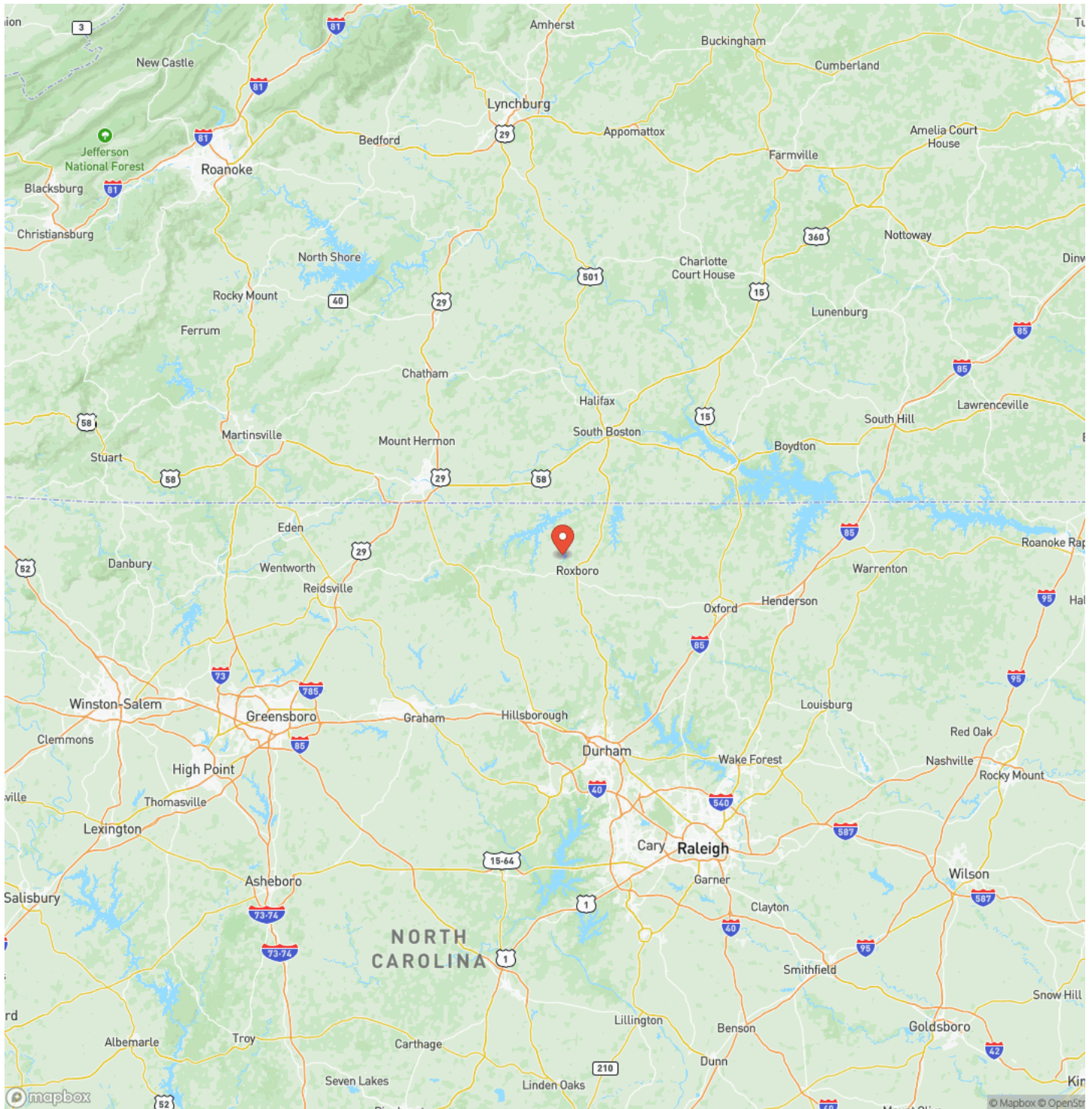


Locator Map
