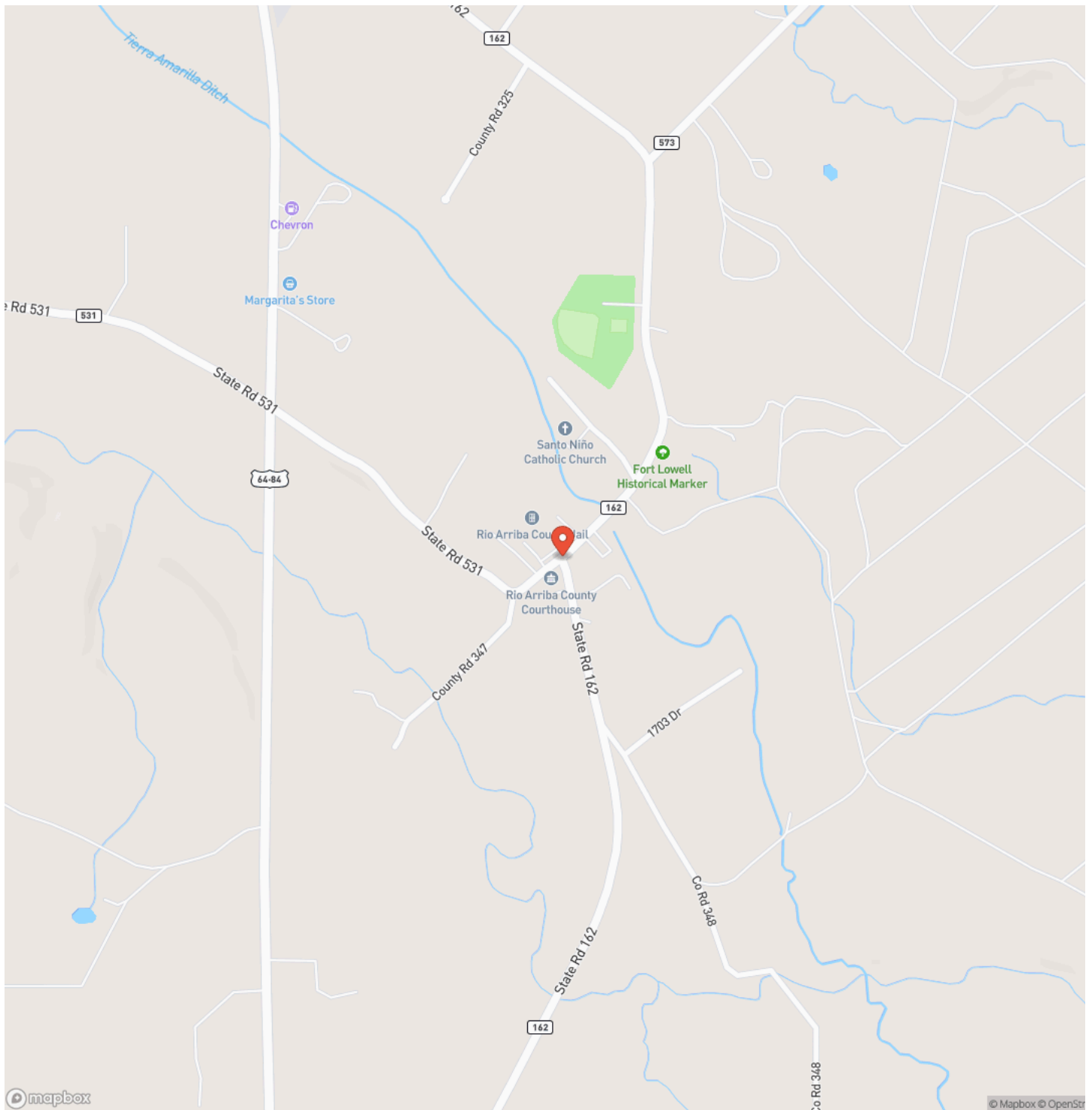

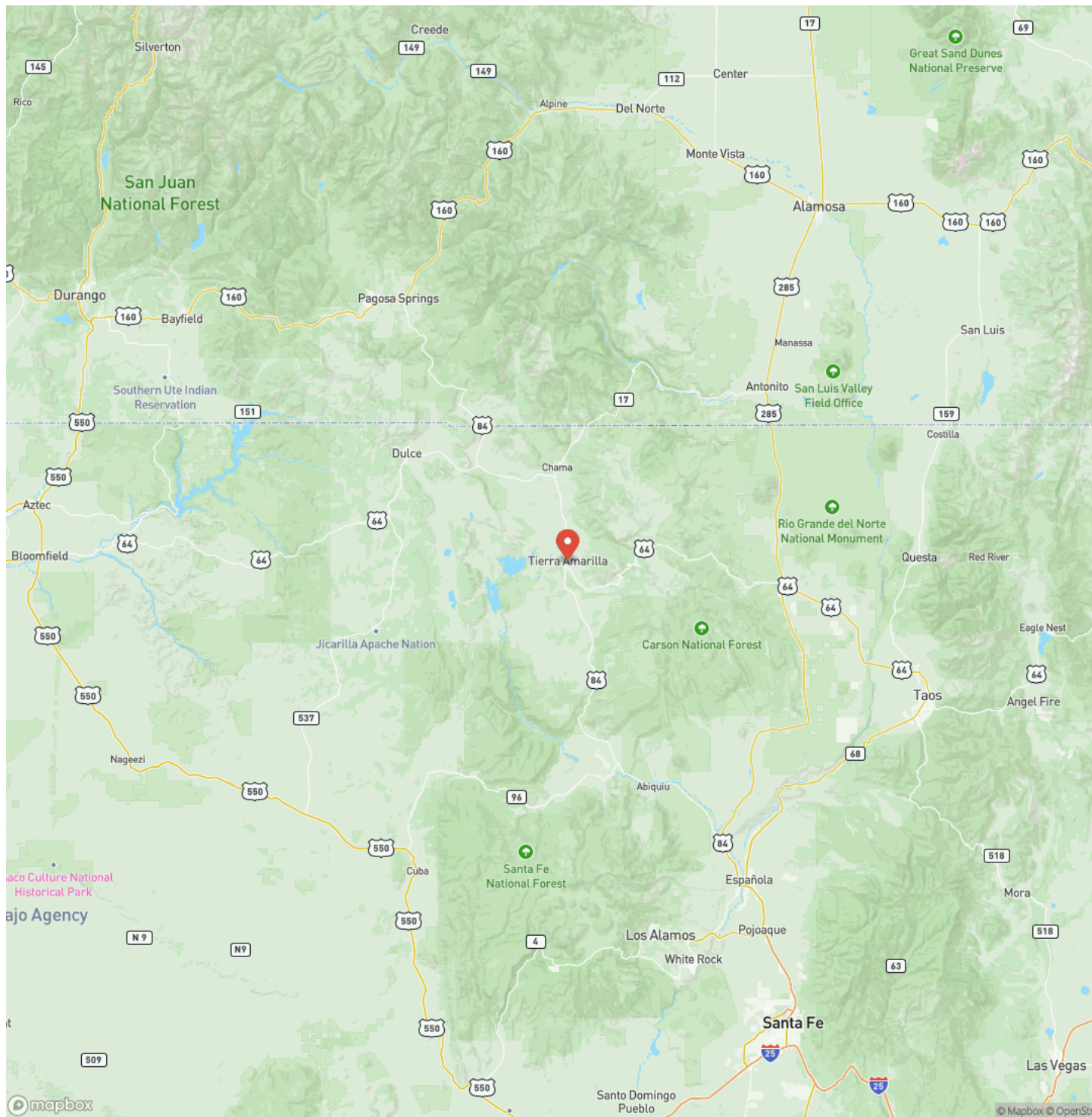




Locator Map
