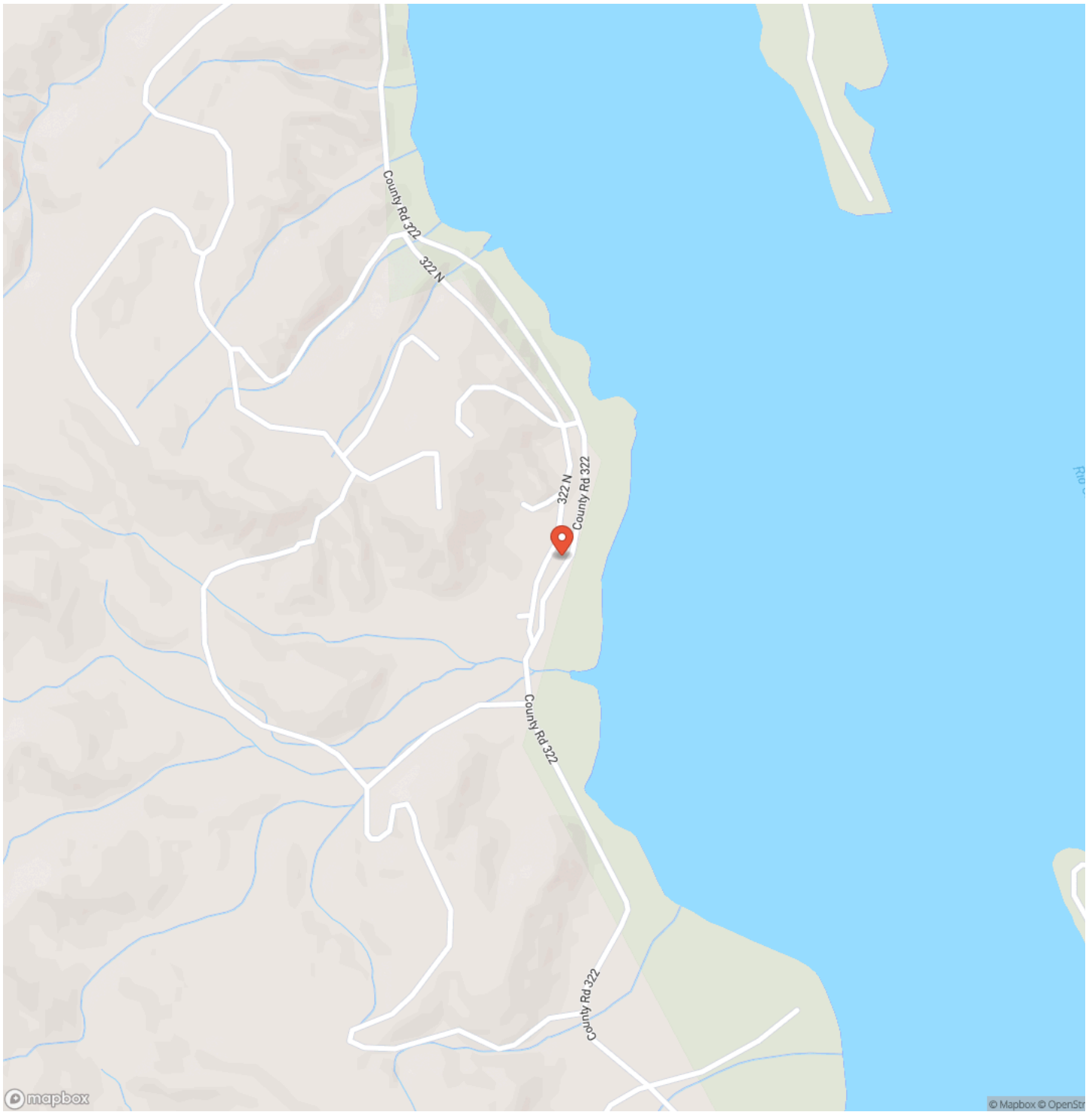

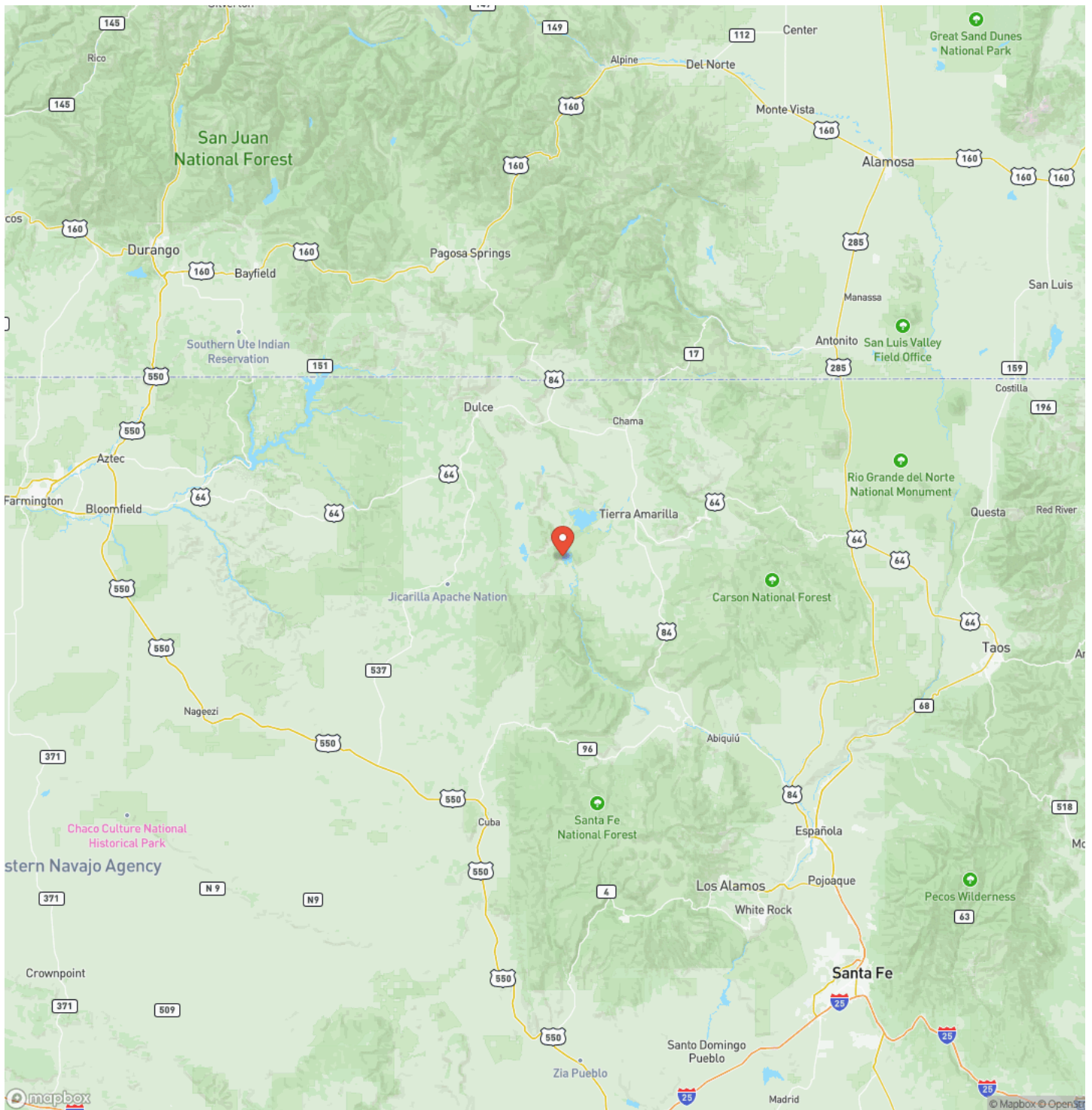




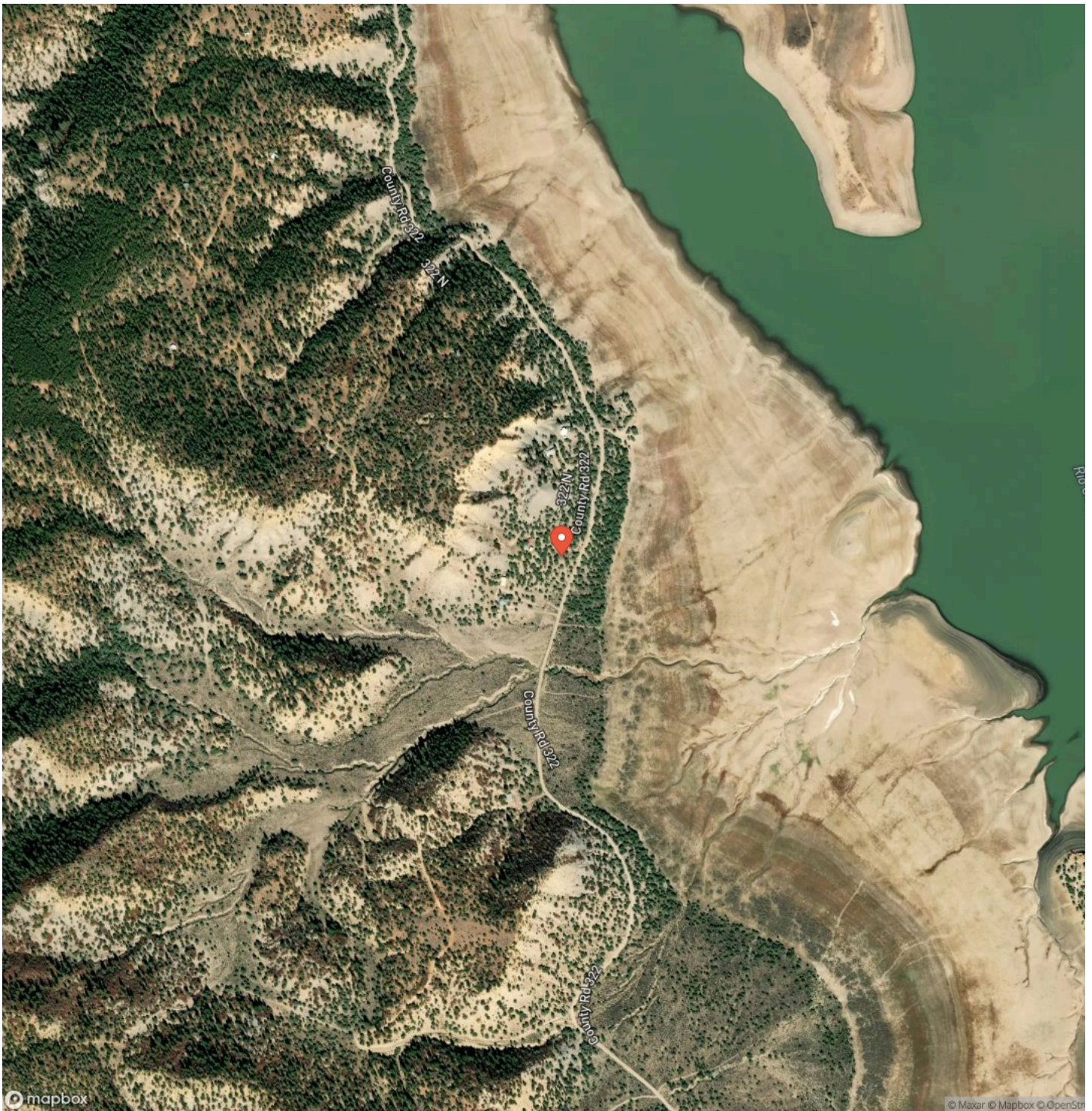
Locator Map
