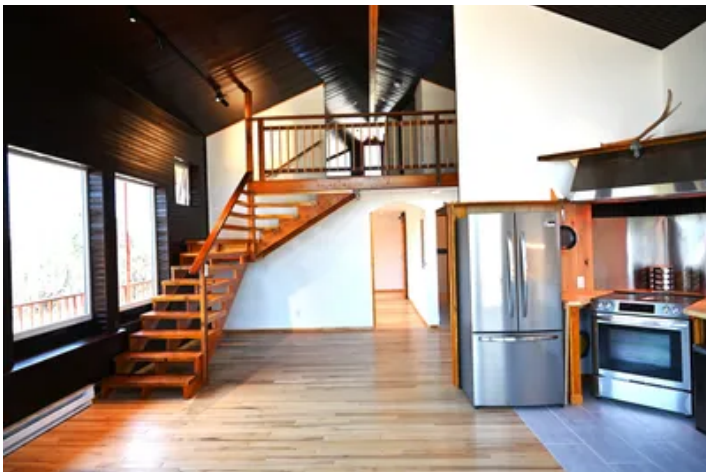

Hickory wood floors downstairs and oak upstairs. Custom made Barndoors. Butcherblock kitchen counter tops. Brand new appliances. Custom tile work in the baths. Nice big windows for that passive solar heat to the south. 16x16 shop /storage shed. Year round access. Laguna Vista has a volunteer road and gate maint fee of \$375.00 per year. Privated and gated. 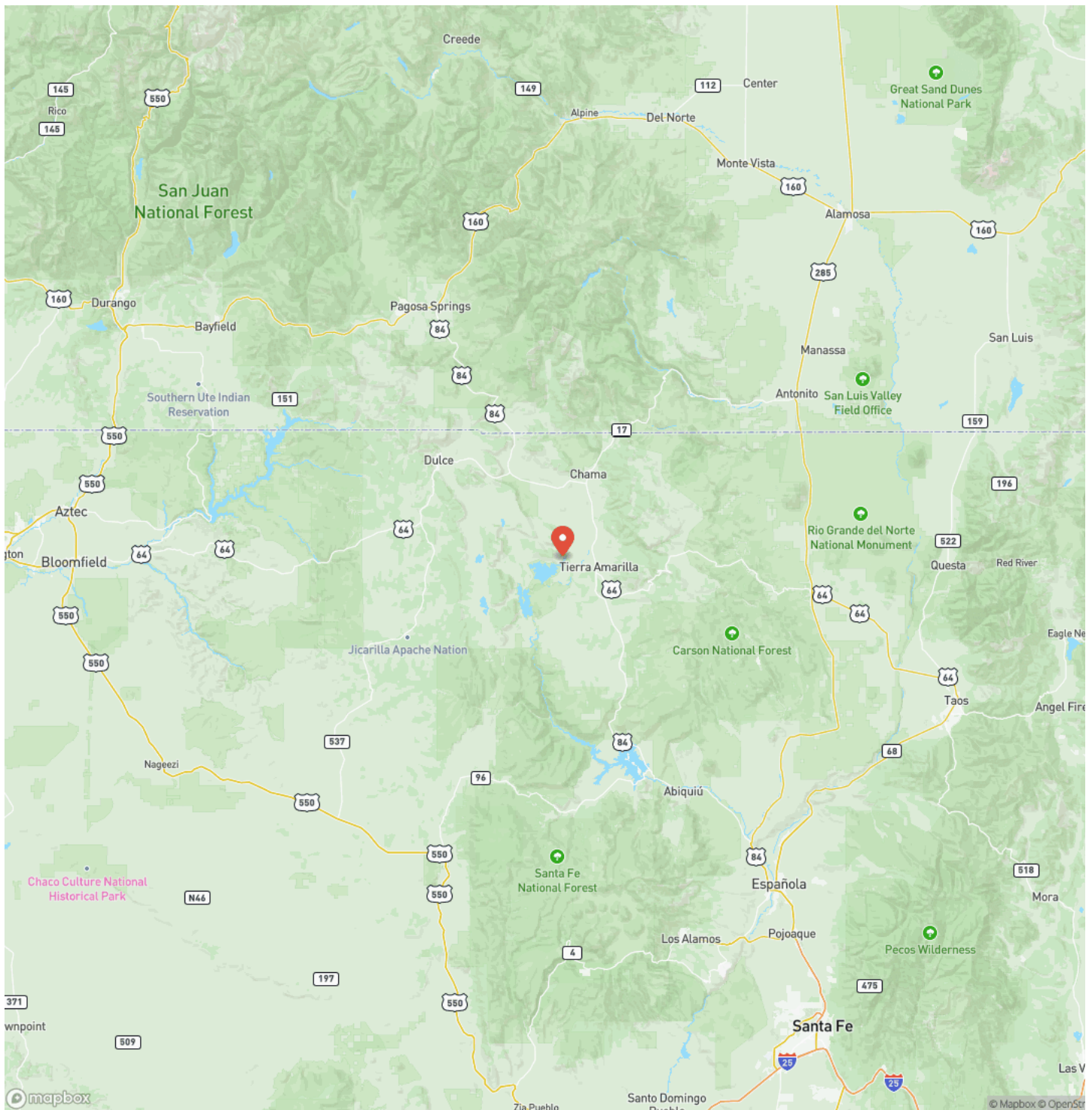

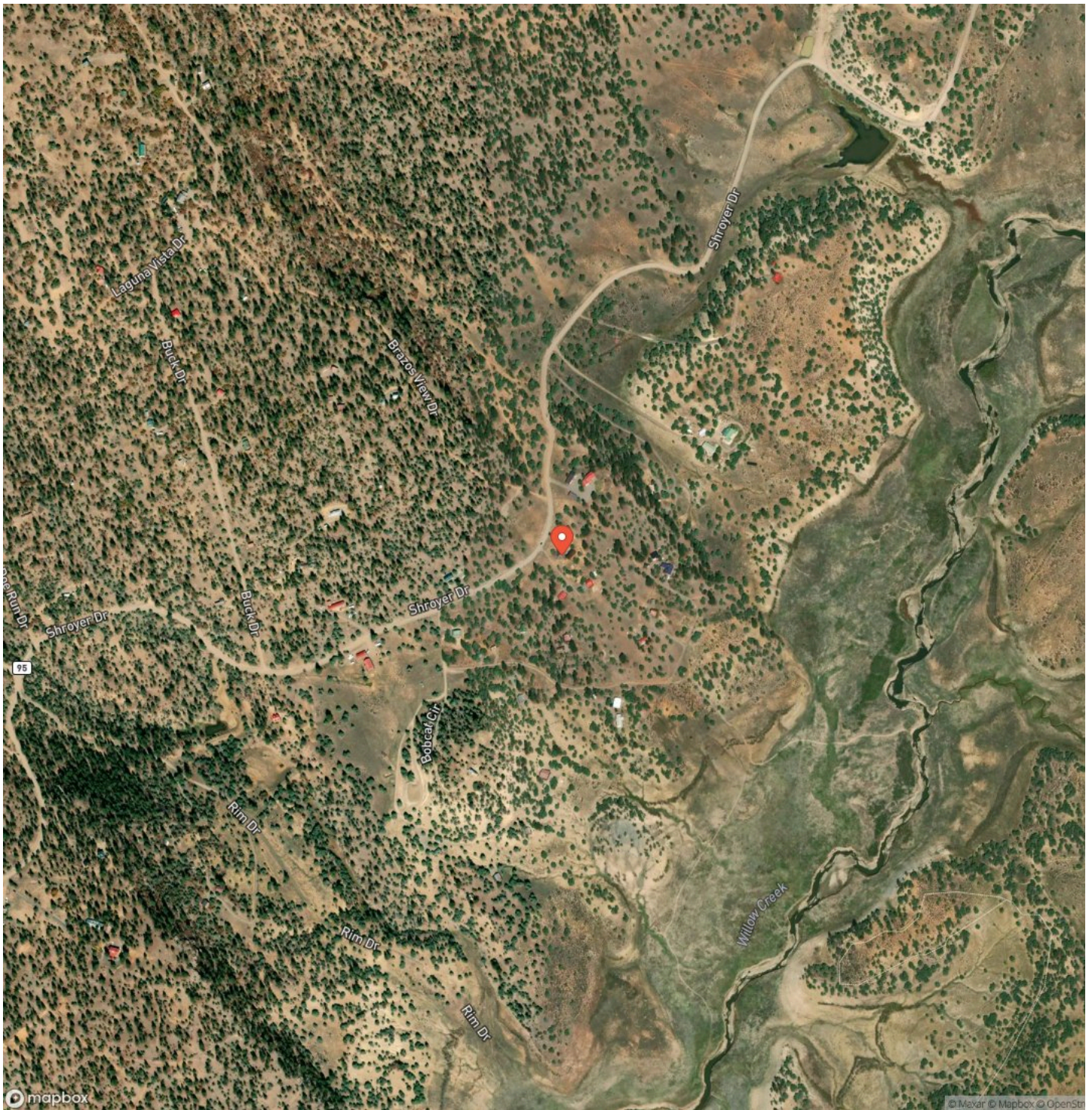
Locator Map
