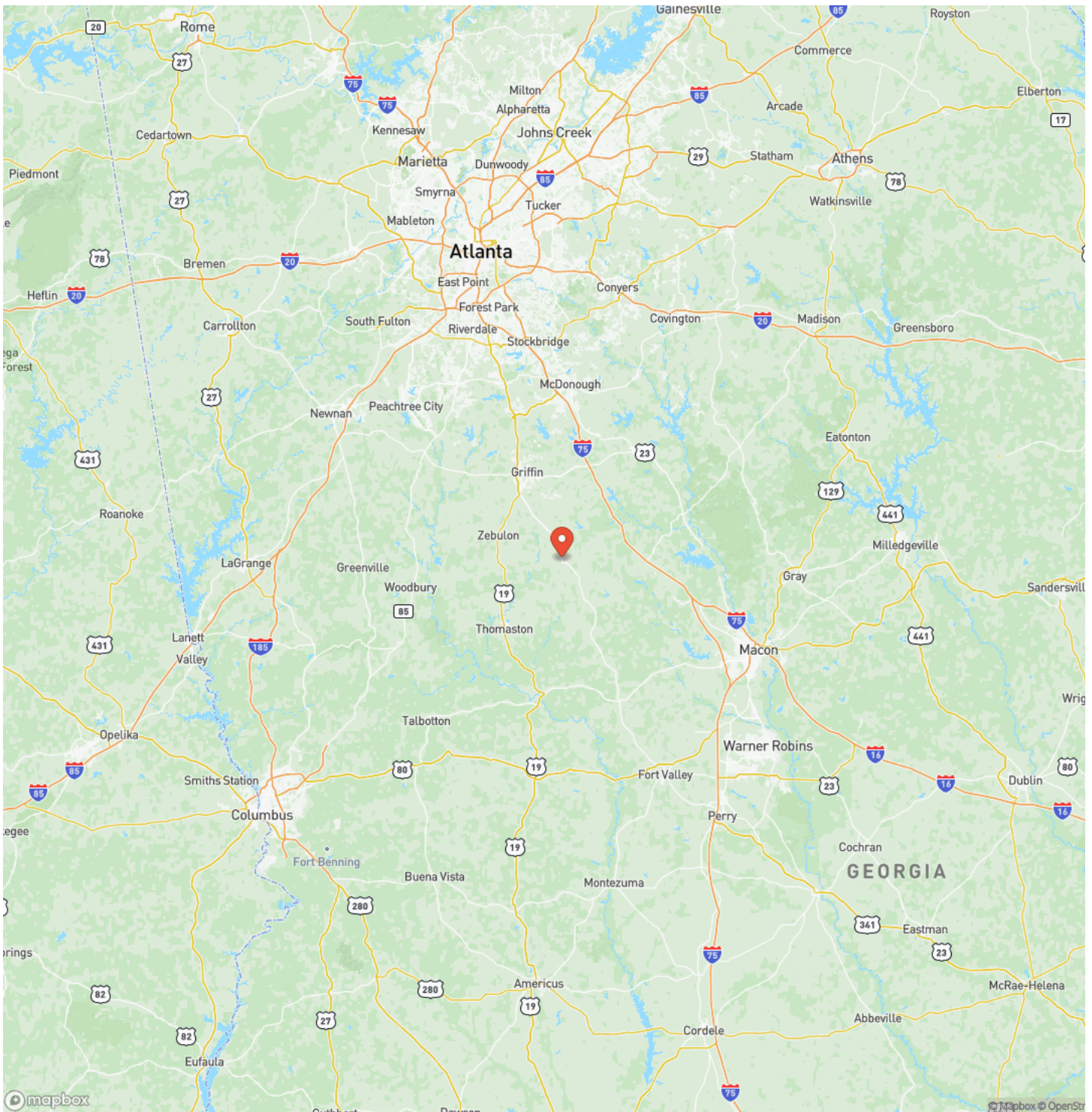


Locator Map

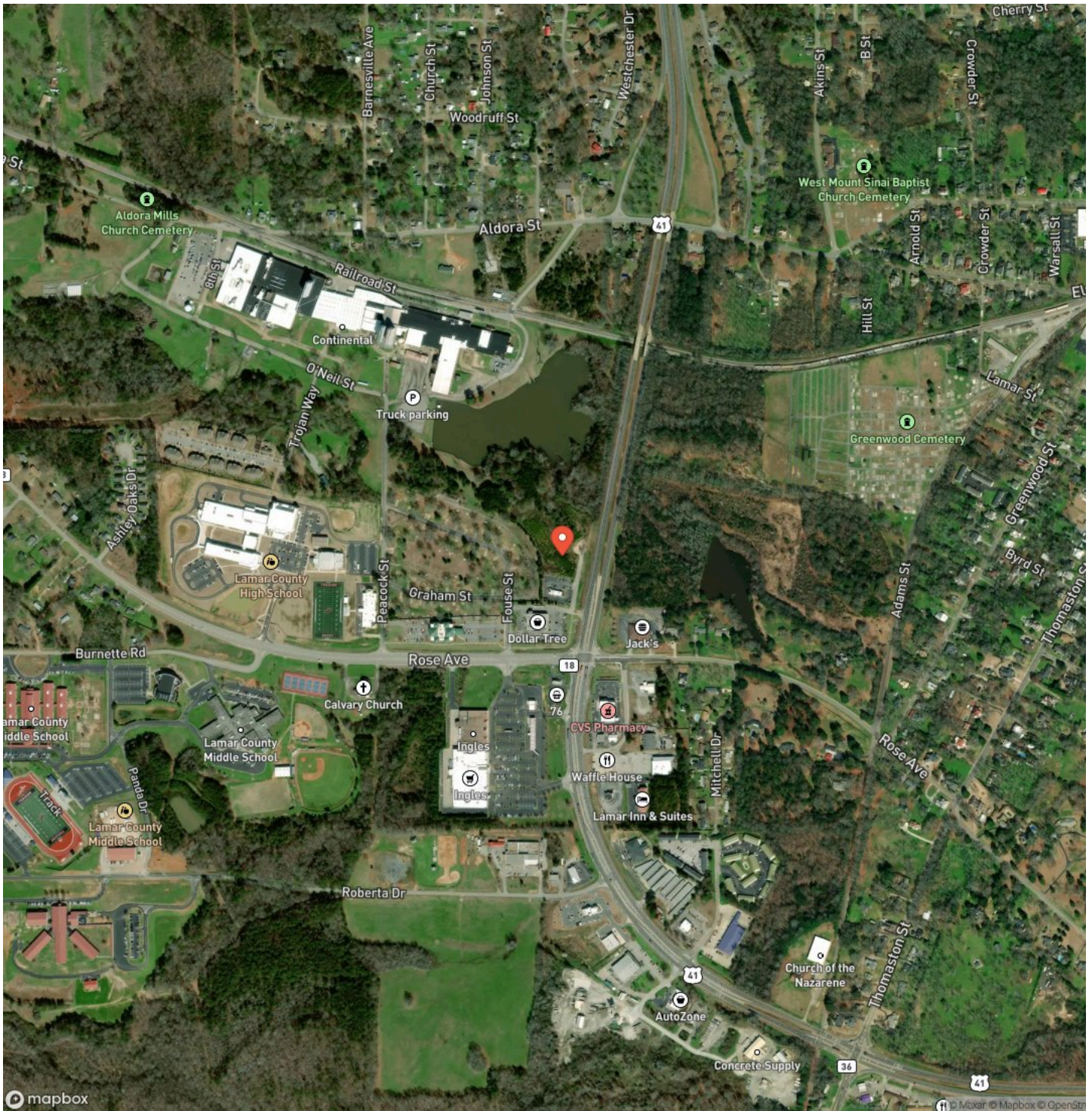
