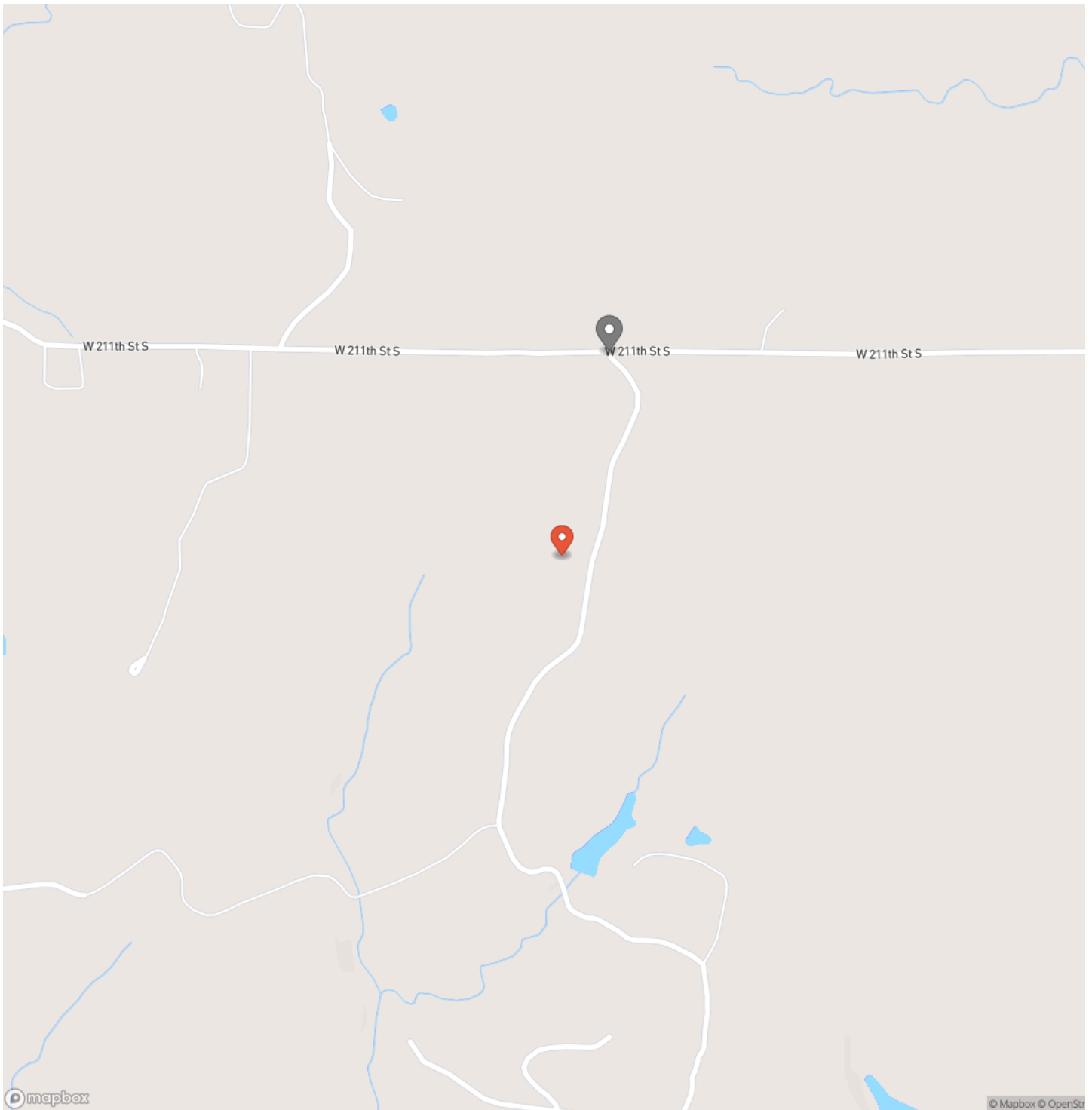
PROPERTY DESCRIPTION

The property is located approximately 12 ± minutes from Bristow, 40 ± minutes from Tulsa, and 45 ± minutes from Cushing, offering a convenient drive while still maintaining a rural setting. With its access, open ground, water features, and hunting potential, this property offers a great opportunity for a well-rounded recreational tract in Creek County! 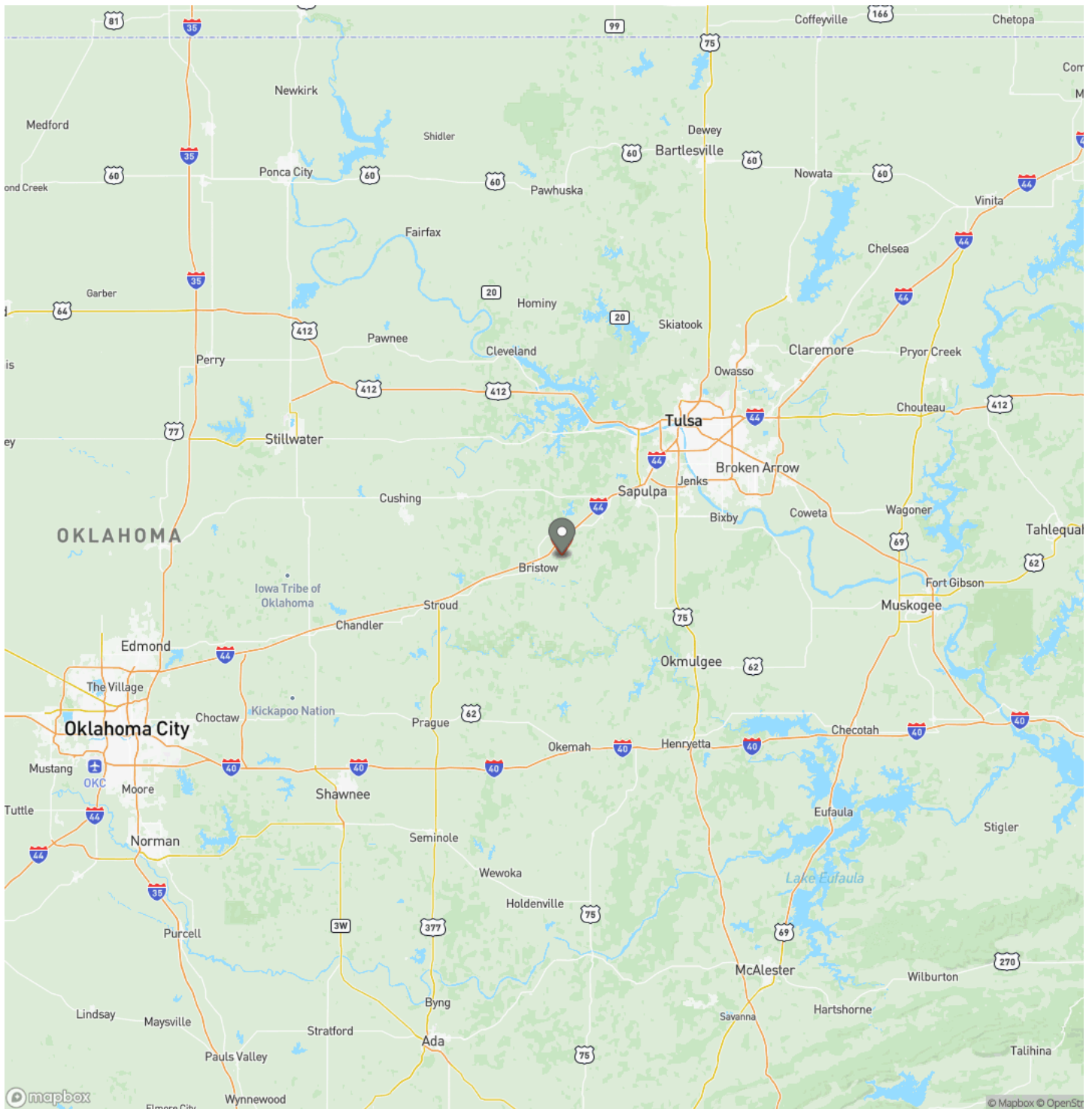
