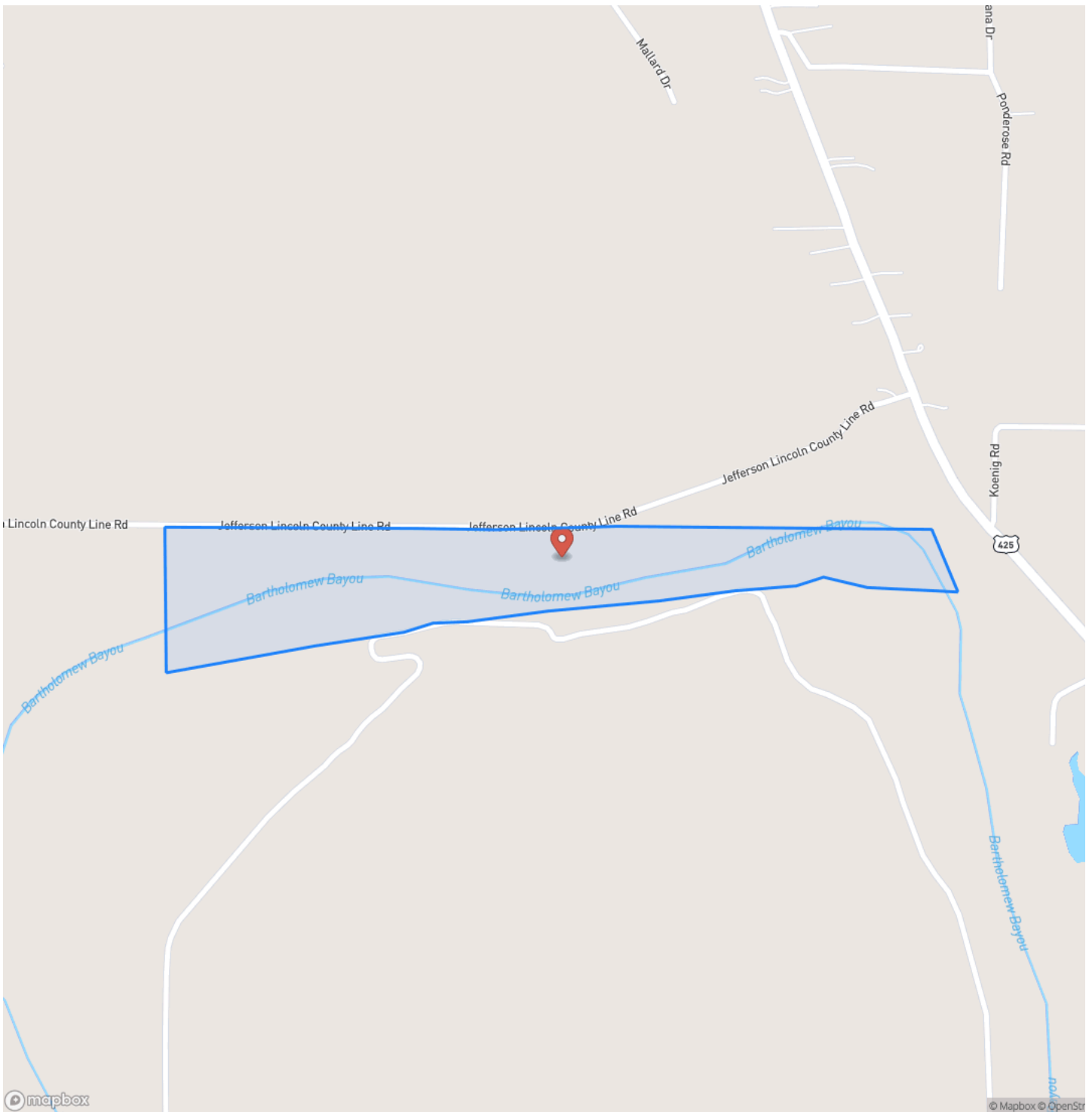
PROPERTY DESCRIPTION

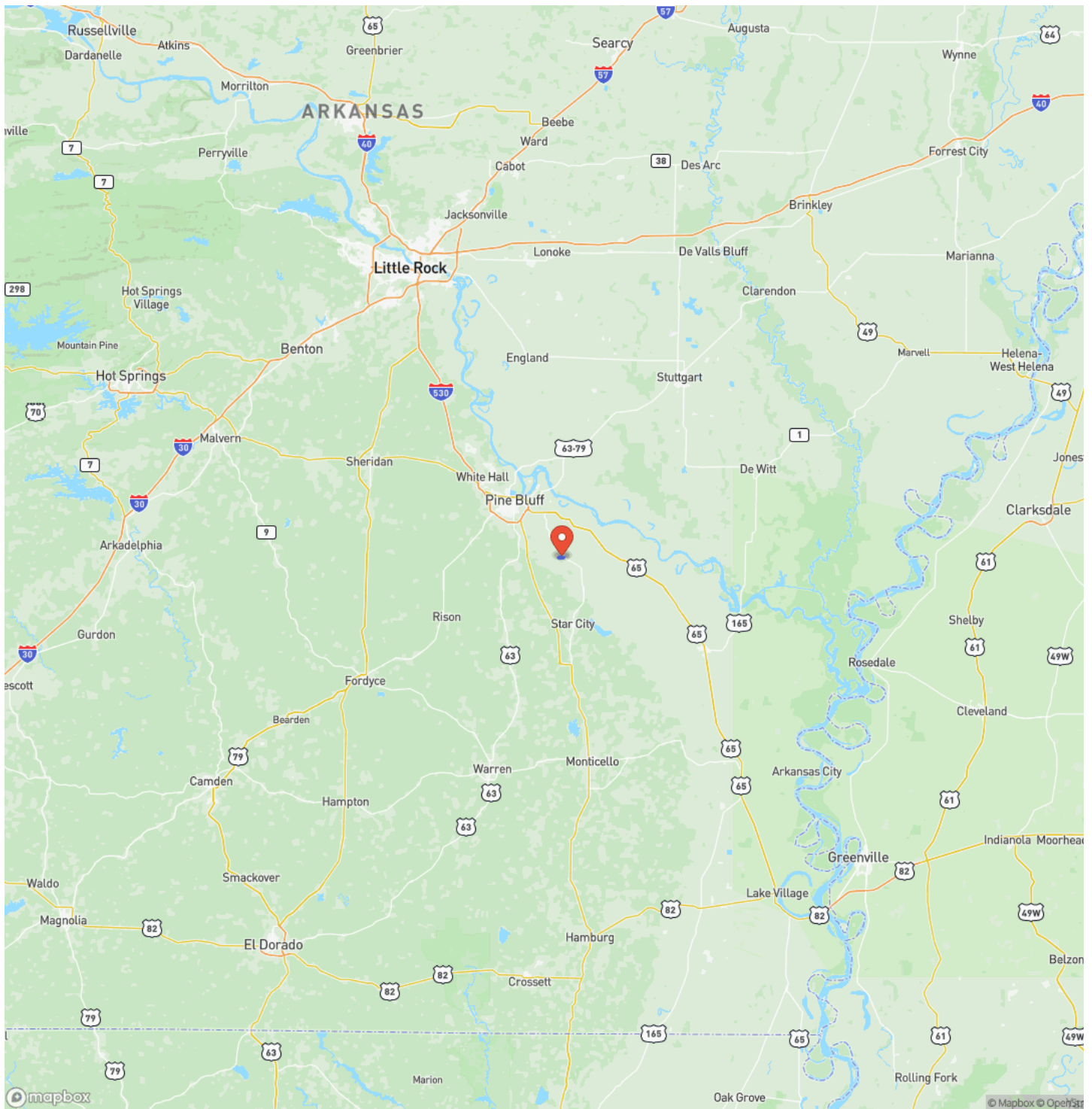




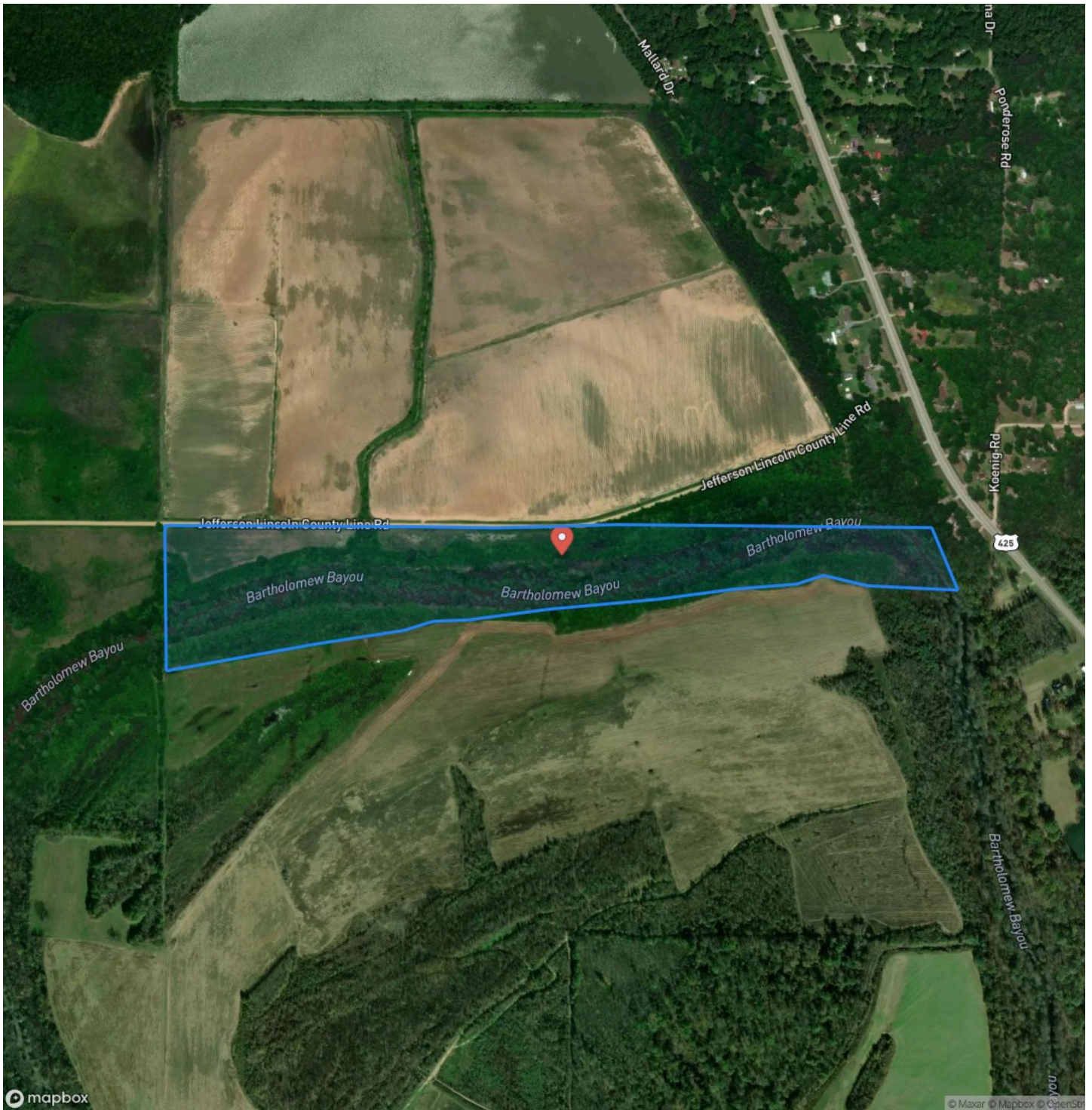
Locator Map
