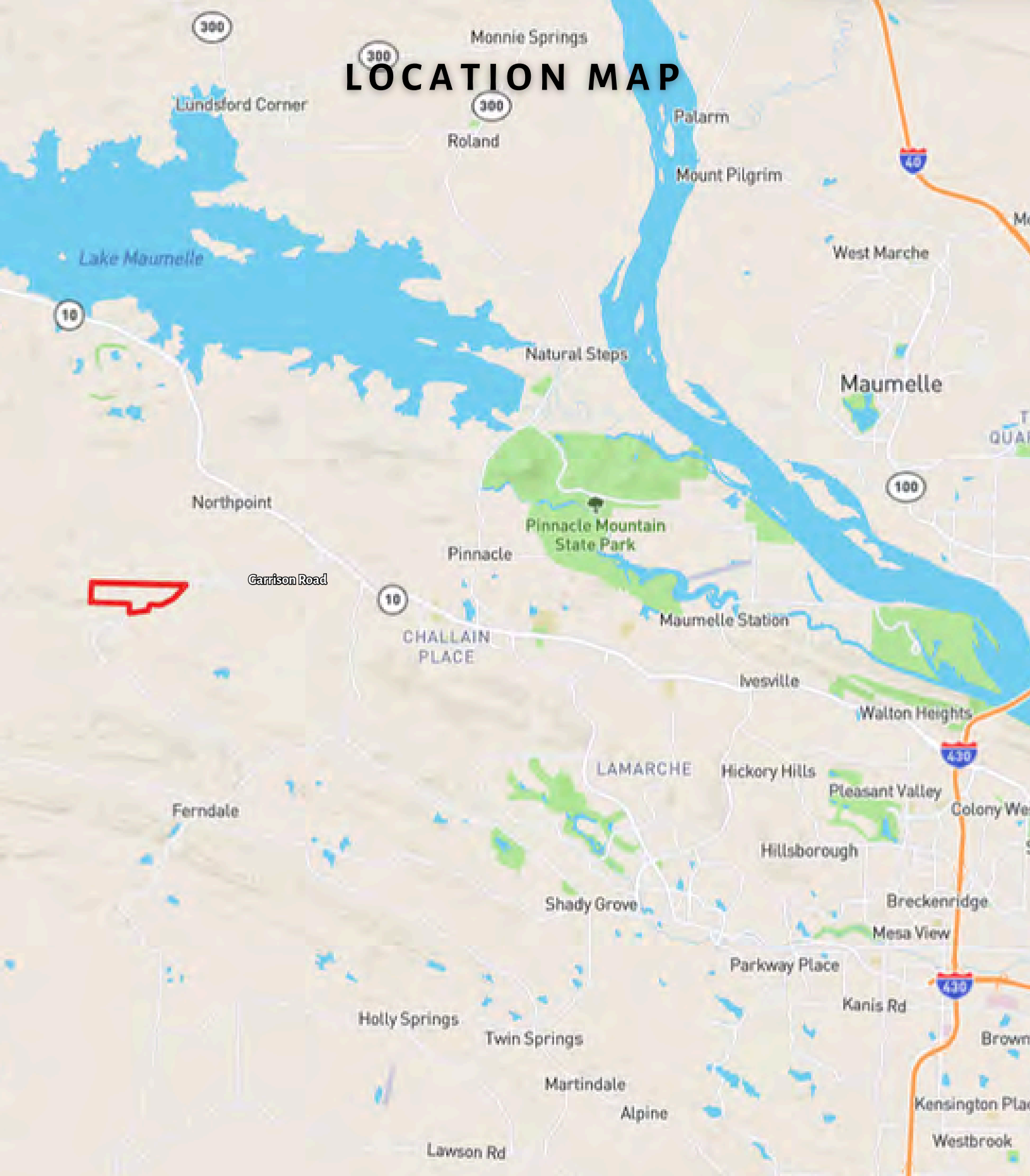

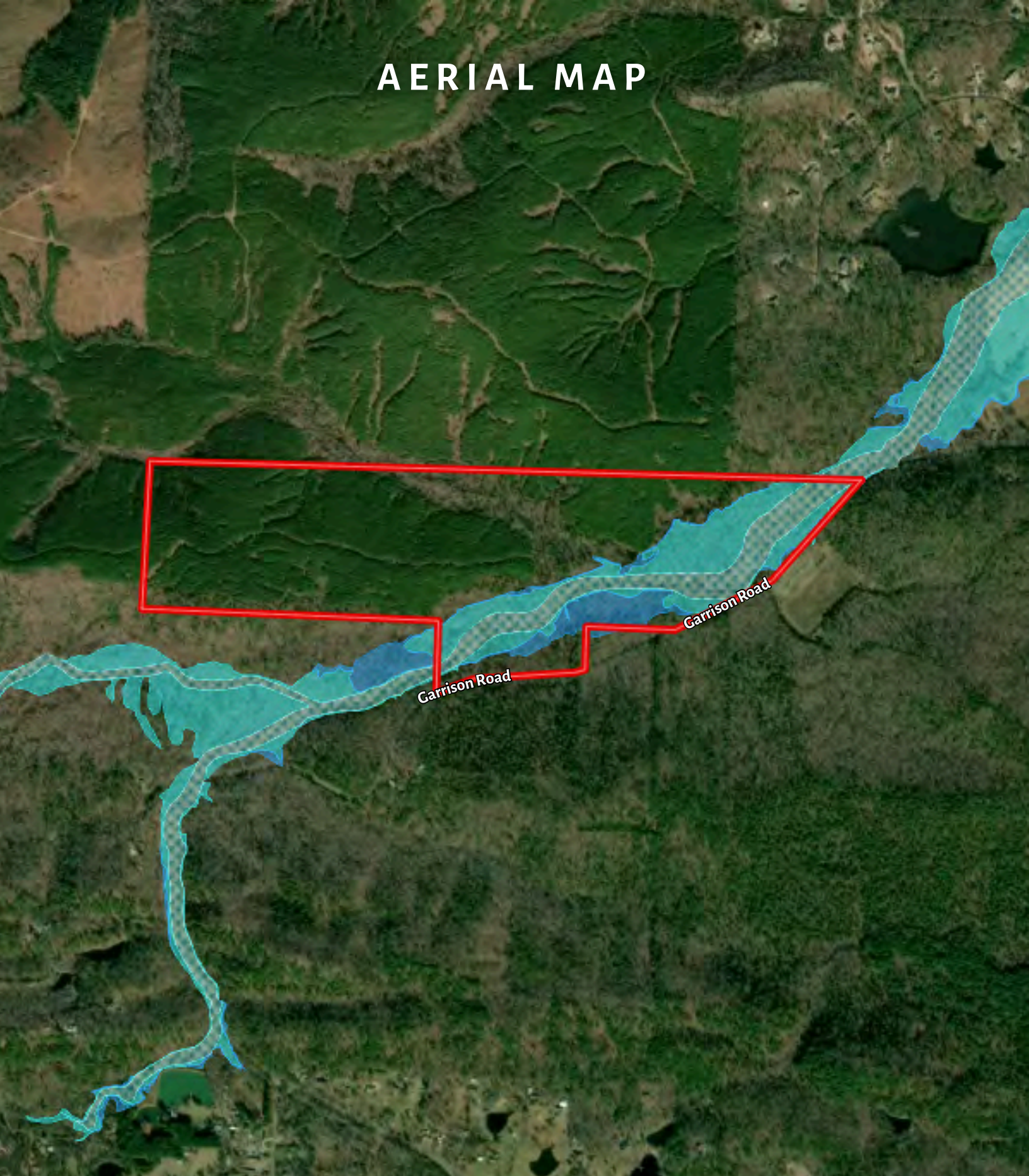

AERIAL MAP

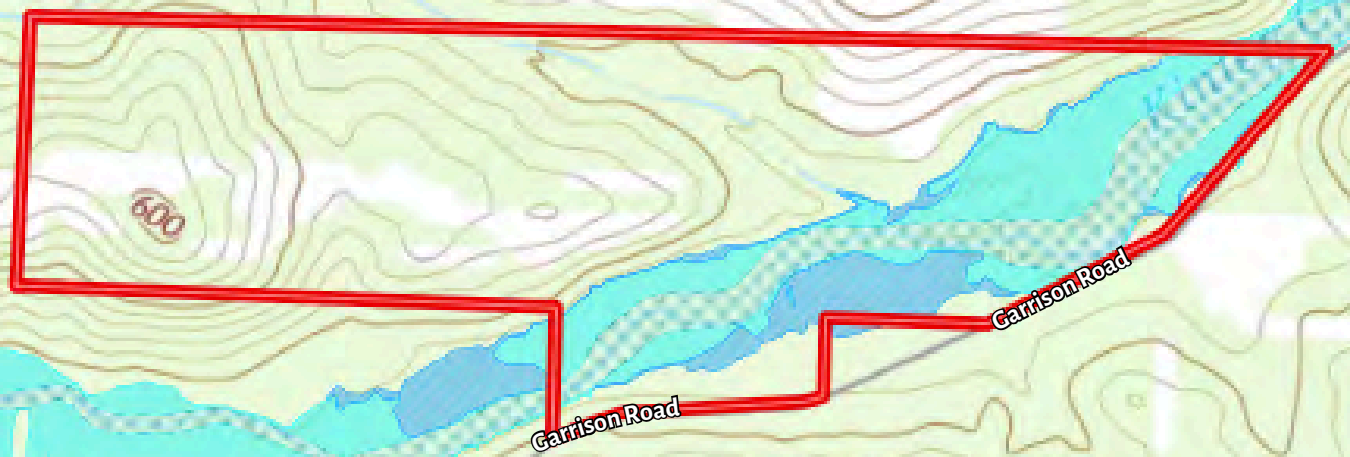
