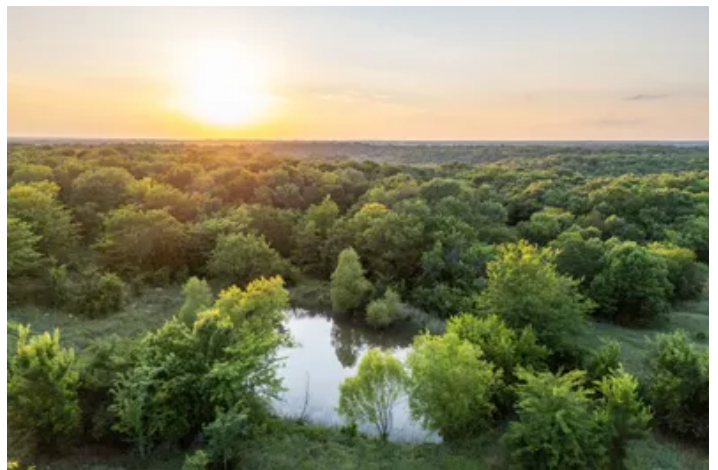

The Business:

Three distinctive accommodations sit on the front portion of the ranch, each designed to give guests a genuine escape: two geodesic domes, each with a bed, private bath, kitchen, outdoor shower, and grilling area; and a mirror cabin, the crown jewel of the operation, featuring a bed, kitchenette, indoor bath, and modern finishes that consistently earn top marks from guests. The business transfers completely turnkey: website, direct booking platform, dynamic pricing software, established cleaning crew, and a social media following of more than 12,000. Guests arrive through an electric gated entrance into a clean, well-curated setup that reflects a hospitality operation run with intention.

The Property:

Behind the resort, the property opens into something different. Timbered terrain with rolling elevation changes, three established food plots, two ponds, and ATV/hiking trails wind through the back acreage. Quality deer, hogs, dove, and other game move through regularly. Supporting infrastructure is already in place: a metal barn, storm shelter, water well with lines servicing multiple areas of the property, county water along the road, and multiple electrical service points throughout.

The Location:

Positioned approximately 15 minutes from both Lake Texoma and Lake Murray, 23 minutes from the upcoming Pointe Vista resort/development, 1 hour 45 minutes from Dallas, and 2 hours from Oklahoma City, this is one of the most accessible recreational corridors in the region, and demand for getaway properties here continues to build.

The Opportunity:

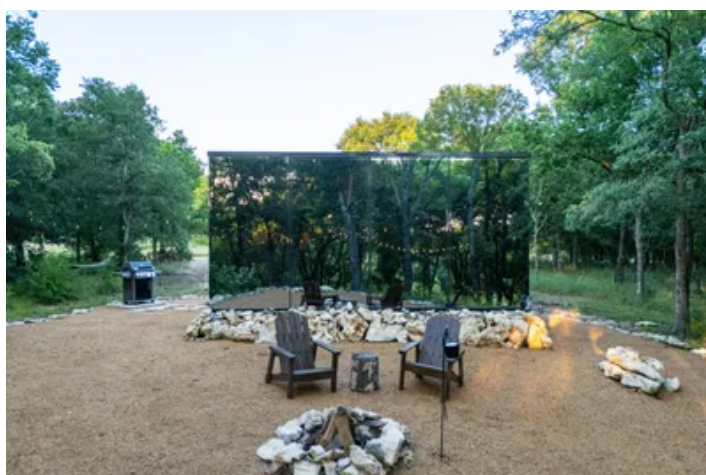

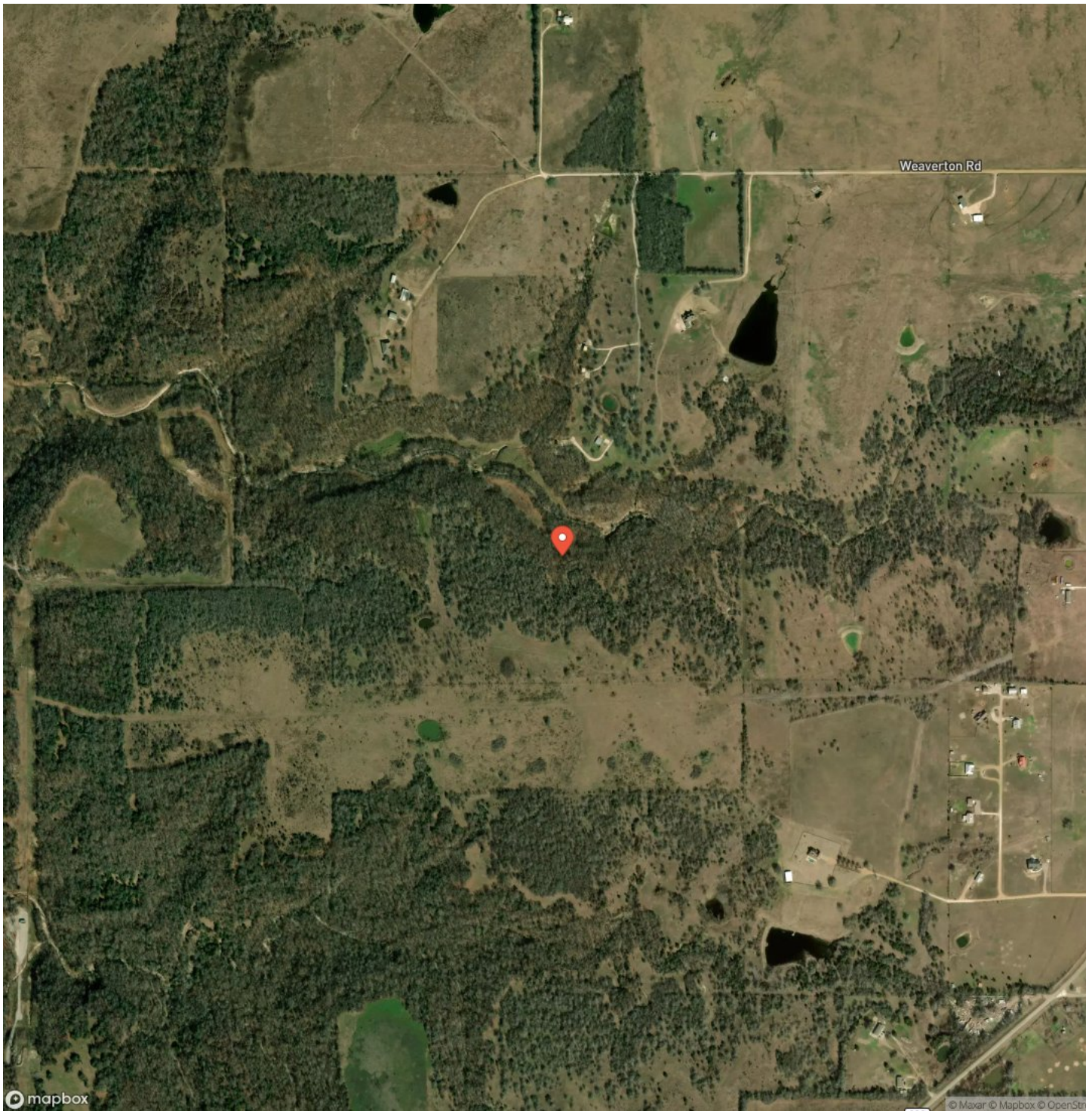
Locator Map
