Tishomingo County 25.07



The land features a diverse timber stand, with roughly half consisting of hardwood and pine pulpwood, while the other half is made up of beautiful old-growth hardwood sawtimber, including a few scattered veneer White Oak logs. Outdoor enthusiasts will appreciate the abundant wildlife, with deer and turkey frequently spotted throughout the property, making it a great small hunting farm as well. With approximately 1,300 feet of road frontage, this tract provides excellent access and endless potential for recreational use, investment, or building your dream getaway close to the lake.

Locator Map


