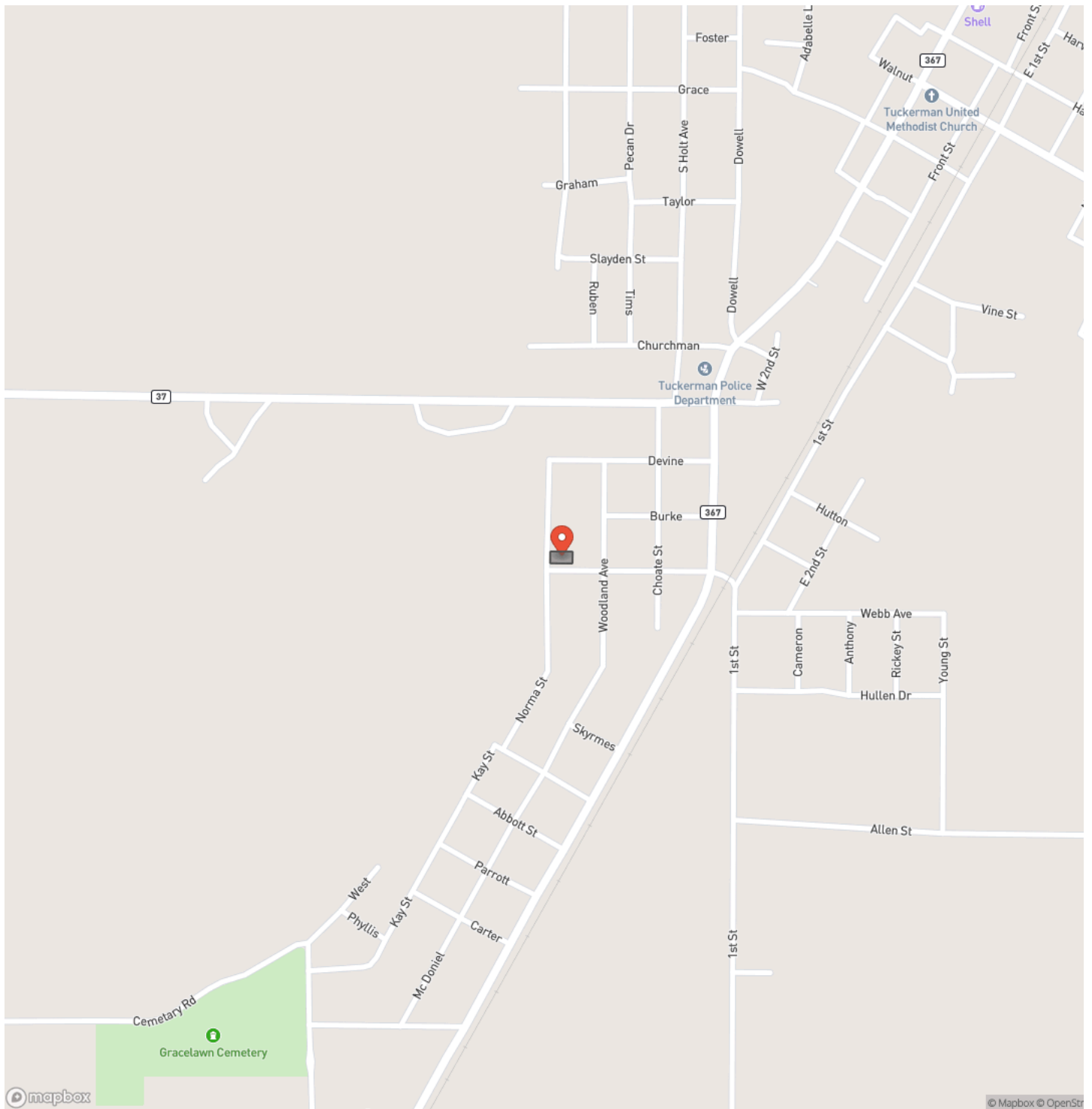
The house also features a large pantry, a screened-in porch, and a fully fenced backyard with a tree swing. Recent upgrades include laminate flooring, central air, and a new roof.



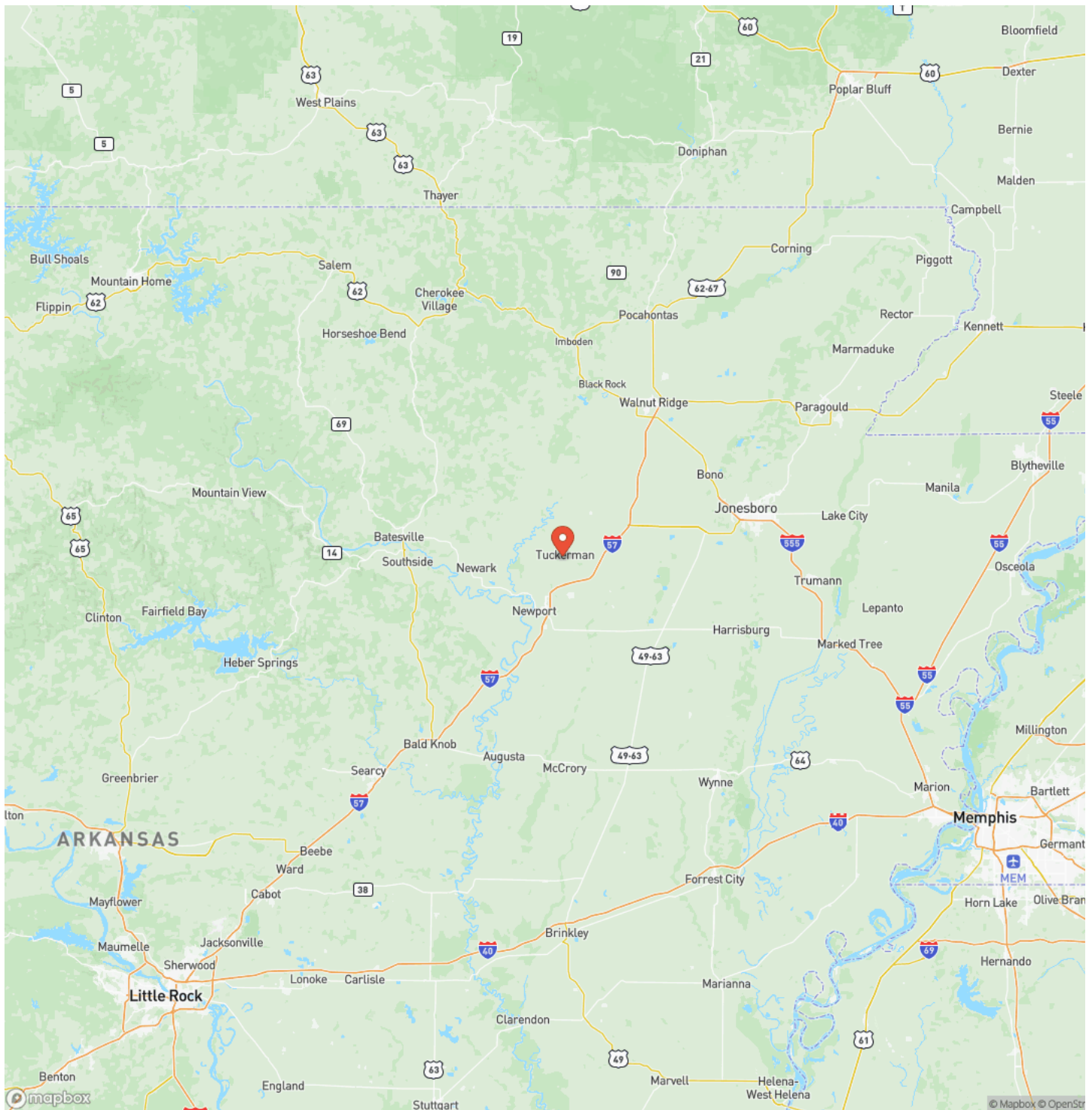

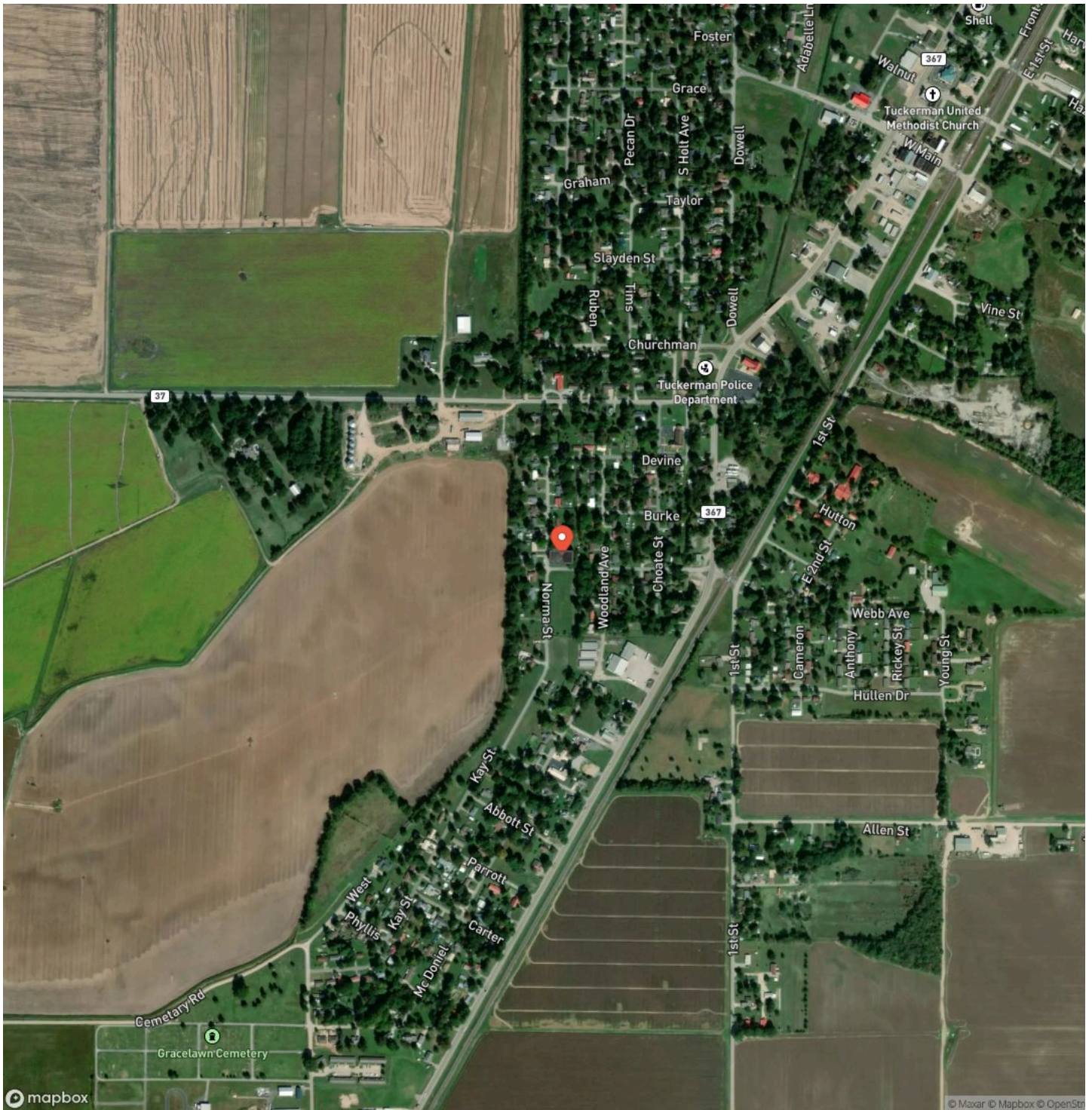
Locator Map
