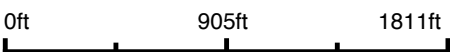

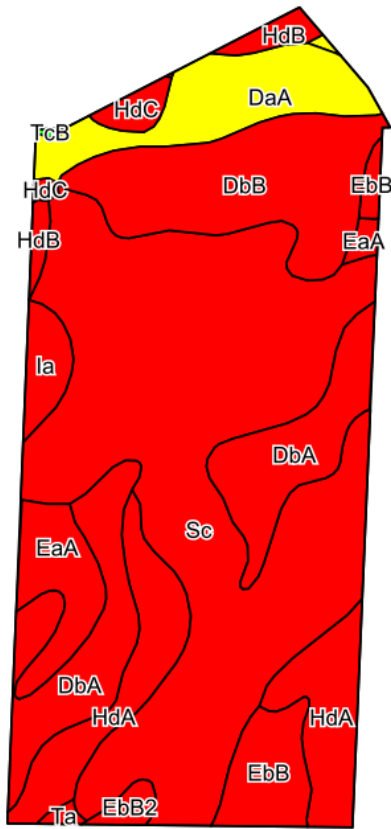

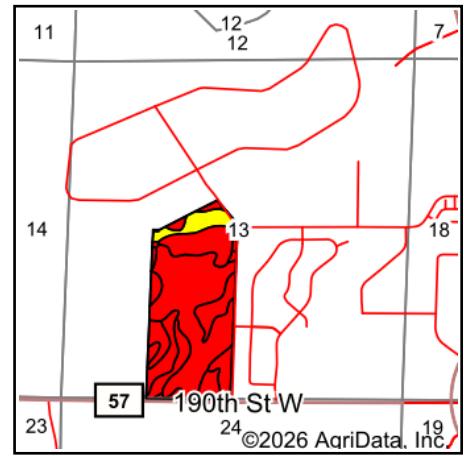


Entire Parcel Soils Map

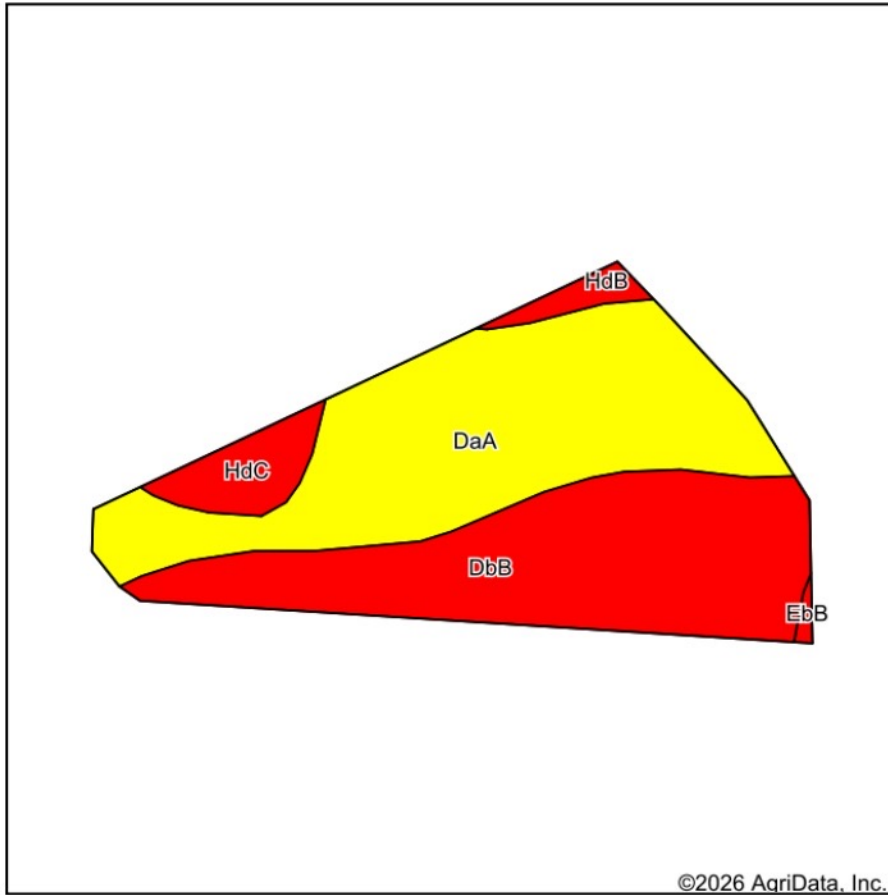

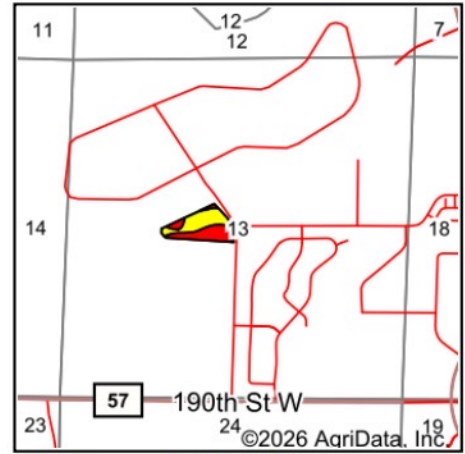

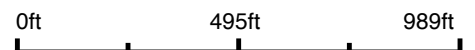

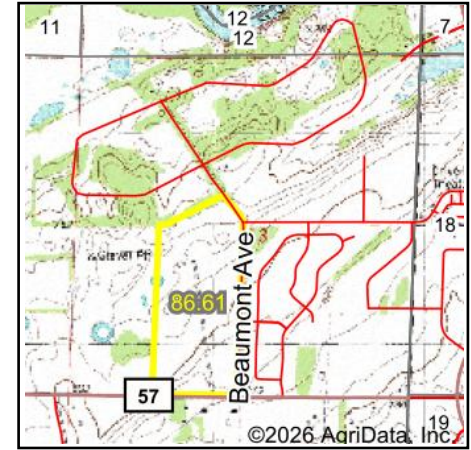
