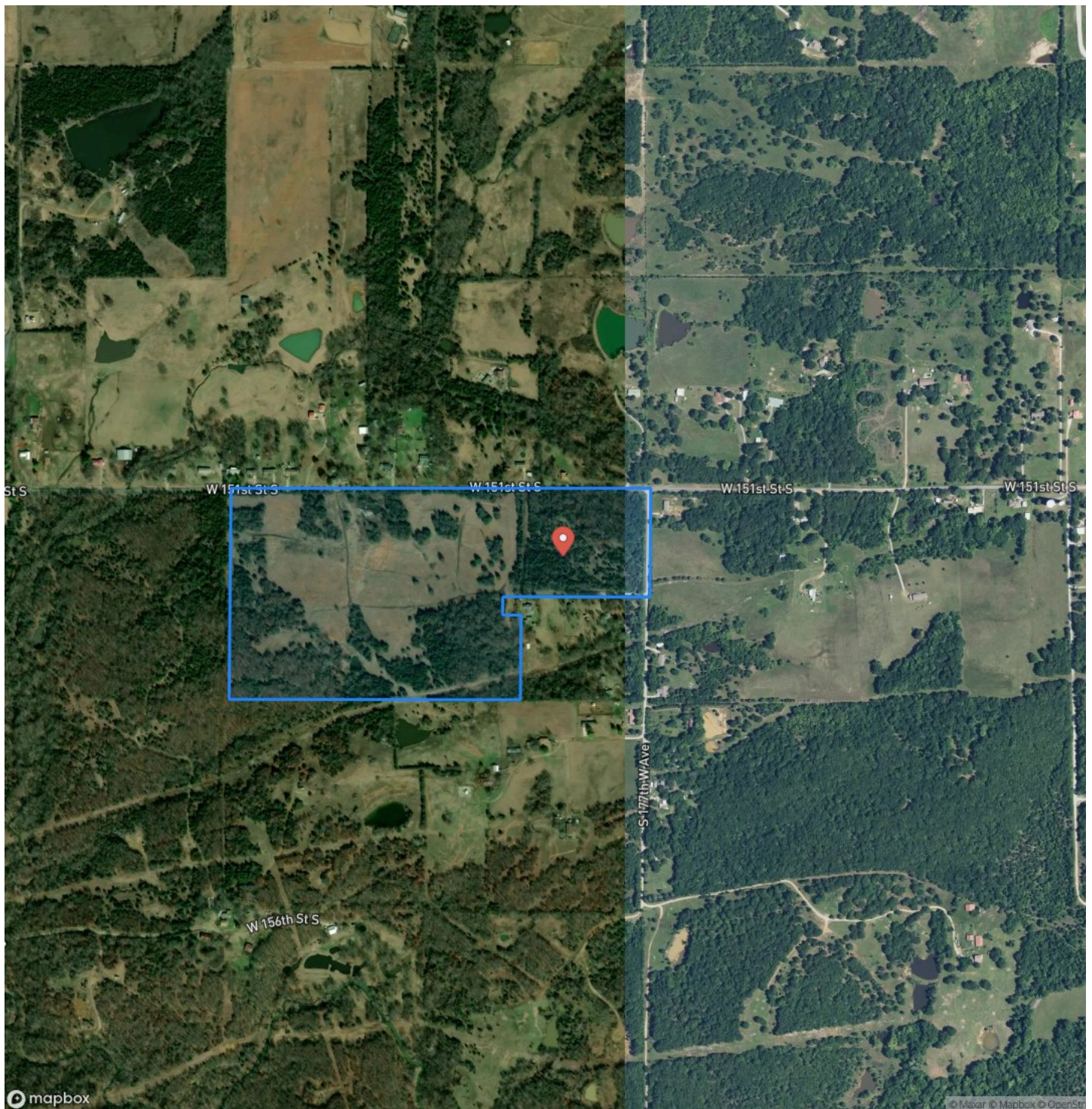
Locator Map
