Locator Map



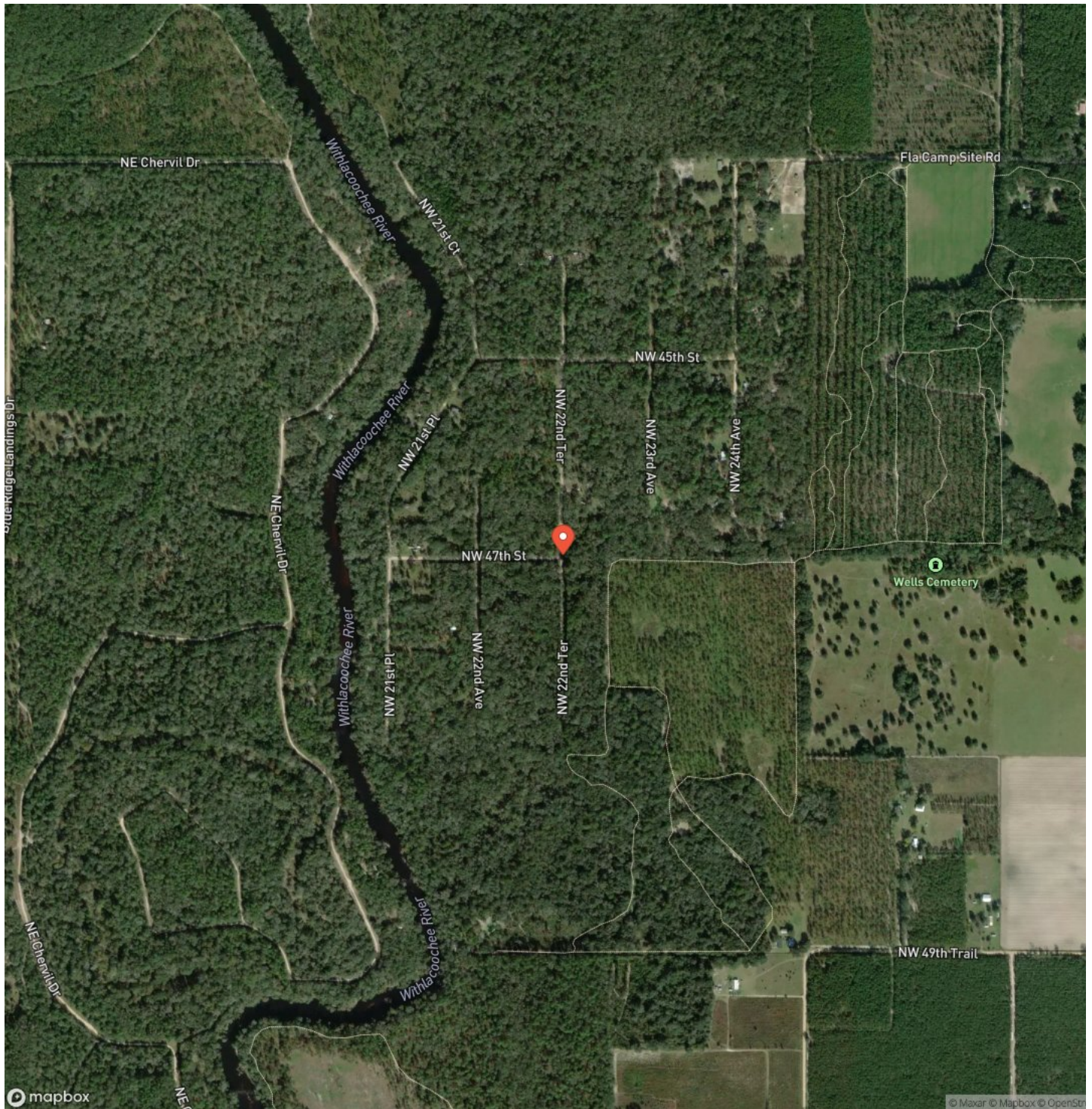
