20 Acres east of Willisville, Arkansas. Timber covered, creeks, and a pond. Wildlife is abundant. Assessible by ATV.

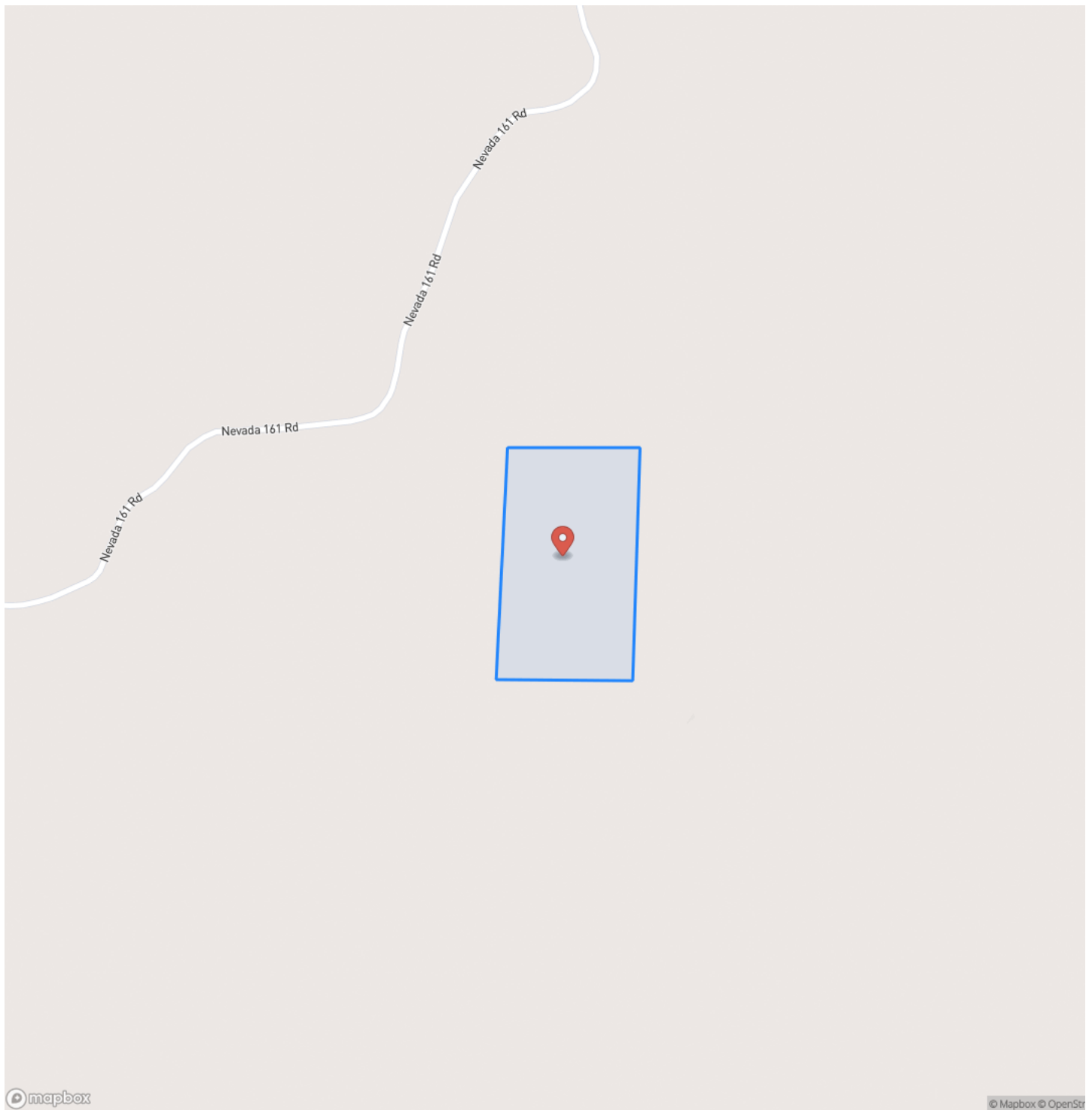

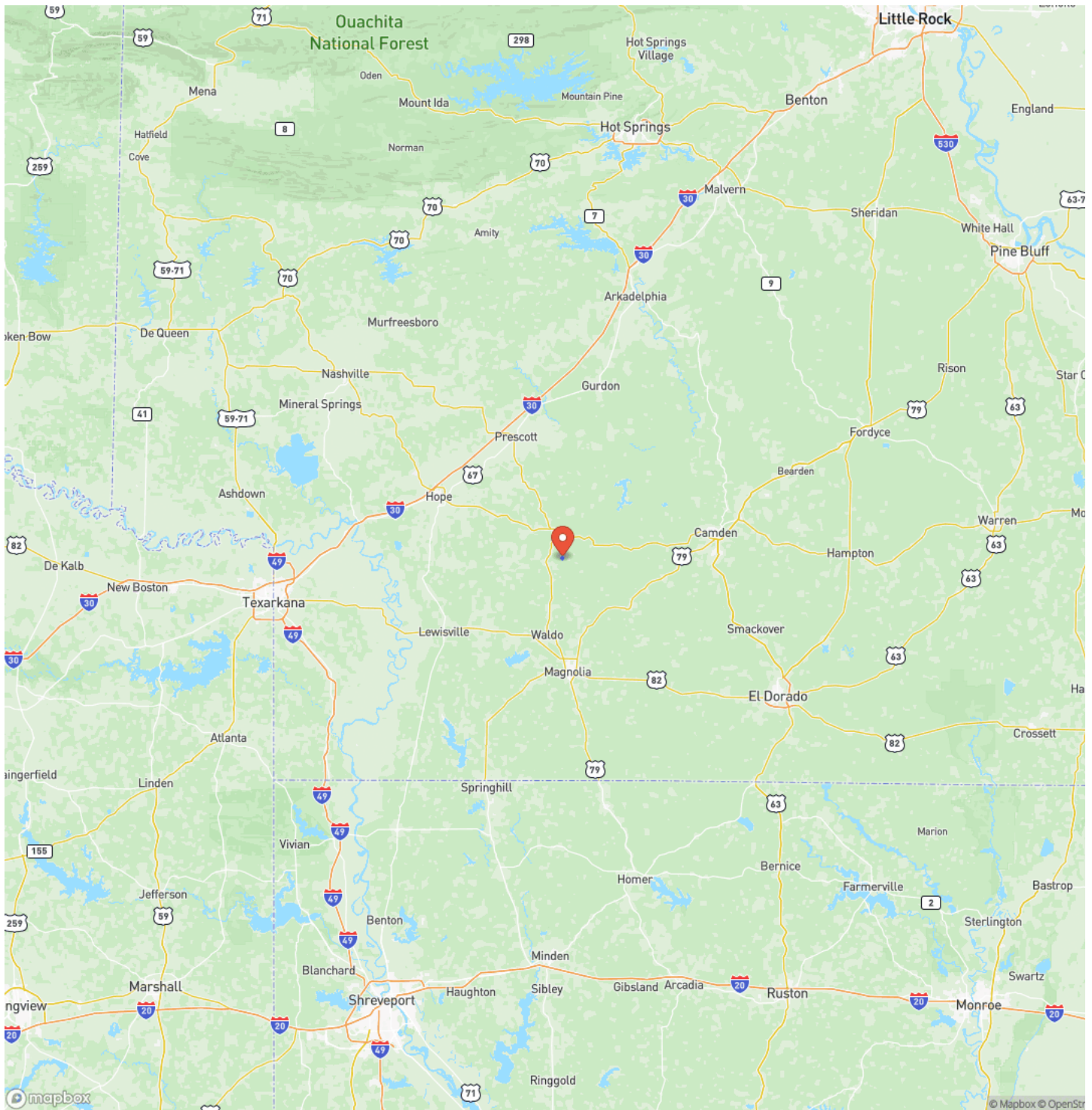
