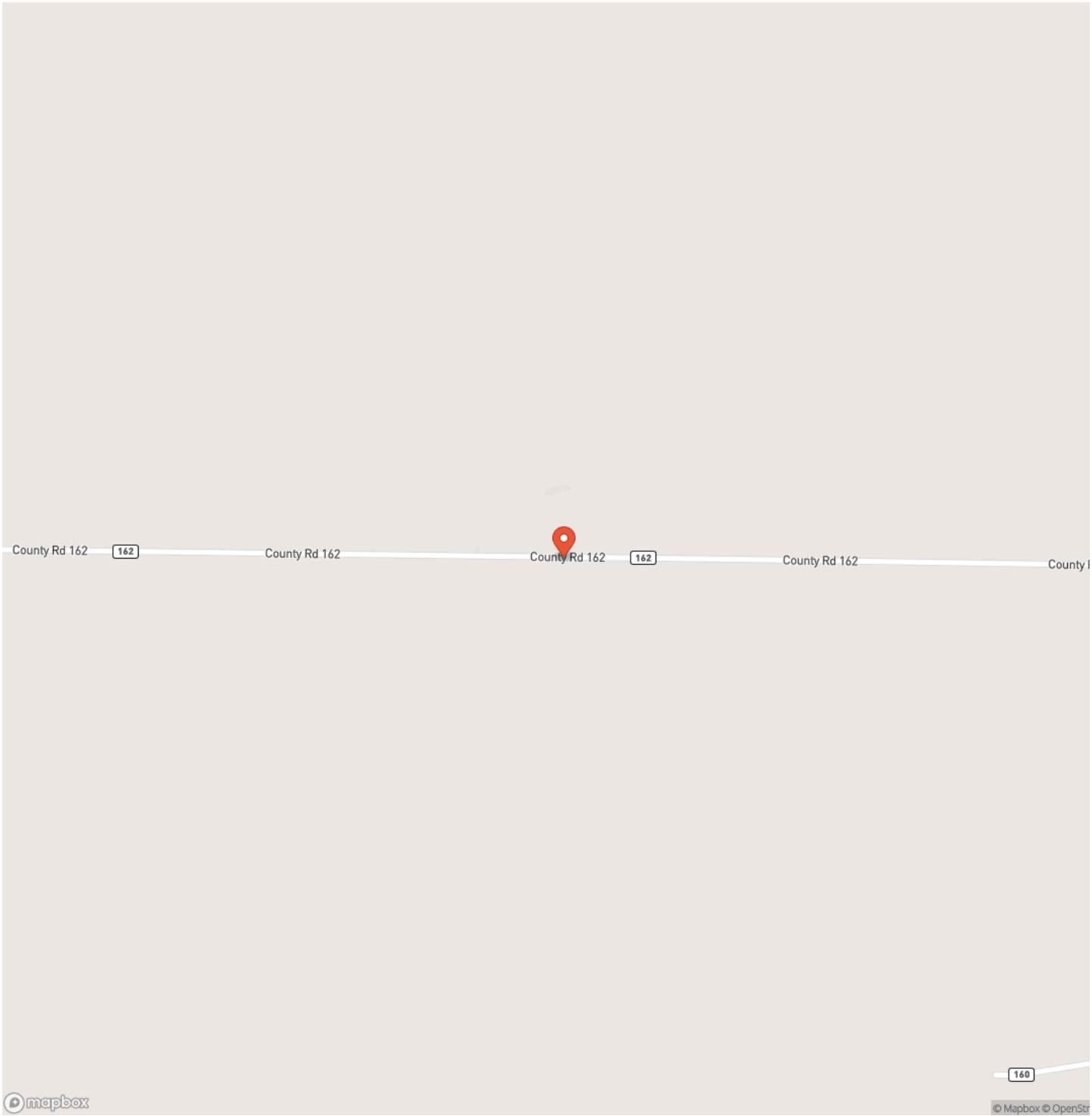

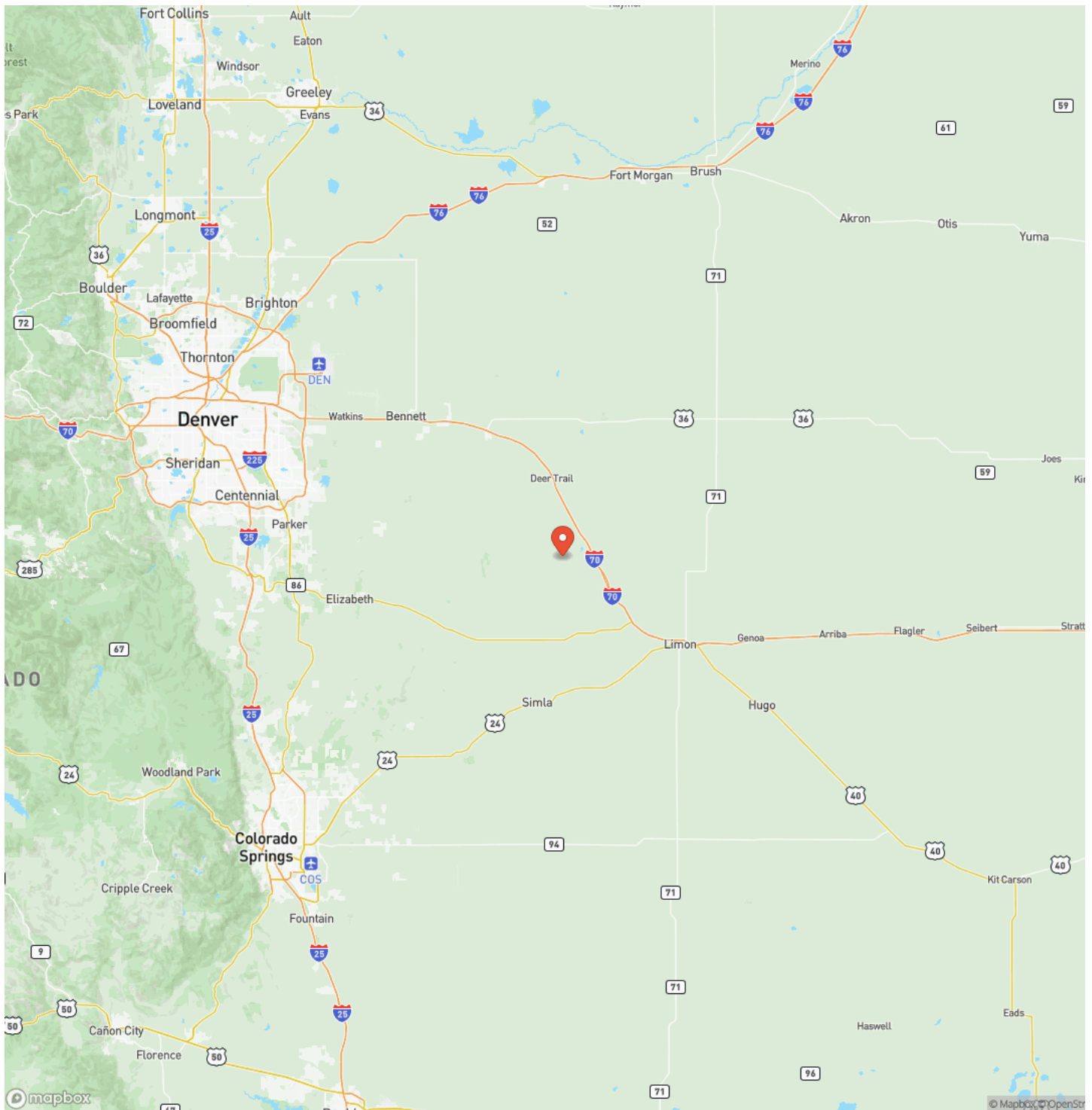


# Locator Map
