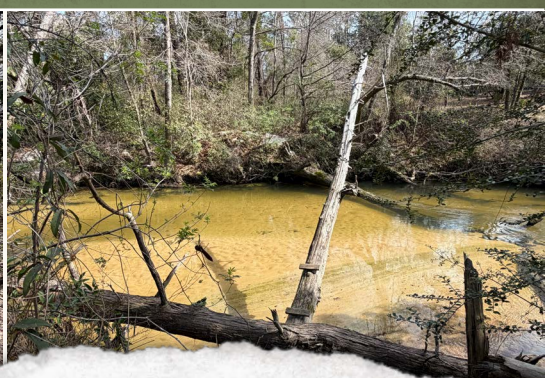
WELCOME TO 22.79± ACRES OF PARADISE LOCATED ON THE UPPER PART OF THE FISH RIVER JUST MINUTES FROM DOWNTOWN FAIRHOPE, ALABAMA, IN BALDWIN COUNTY. The Baldwin 22.79 has over 2,400± feet of frontage on the Fish River with beautiful sand bars, swimming holes, and fishing potential up and down the banks. The timber is naturally regenerating into a mixed hardwood and pine forest with many longleaf pines growing in the upland areas.

There is an abundance of small game and deer on this property for hunting. The Baldwin 22.79 will be protected by a conservation easement held by the South Alabama Land Trust (SALT) to protect the sensitive wetland habitats and prevent future development. An approximate three-acre portion of the property will allow for construction of a home and outbuilding approved by the SALT. Other activities like hunting and some timber management will also be permitted. The Baldwin 22.79 is accessed by a 50-foot deeded easement from Comalander Road.

Directions from Robertsdale, AL:
Travel on County Road 52 for 1.5 miles. Turn left onto Broad Street, continue for 0.5 miles, and then turn right onto AL-104 West. Proceed for 3.5 miles. Turn left onto Langford Road and travel for 1.5 miles. Turn right onto County Road 48 and continue for 1 mile. Turn left onto Gunnison Road, travel for 0.5 miles, take a slight left onto Baldwin Lane, continue for 0.5 more miles, and then turn right onto County Road 33. Proceed for 0.5 miles. Turn left onto Comalander Road and travel 0.4 miles to arrive at the property.
