

The Calhoun County, MS, property is offered in two different tracts: 1) 63.7± acres adjoining the west side of HWY 9 and also CR 165 and 2) 110± acres on the east side of HWY 9 along with CR 151. Combined, you have more than half of a mile of road frontage! The 63.7± acre tract also has McGill Creek frontage along the northern property line.

The two tracts consist of approximately 128± acres of 3-year-old planted pines and 45± acres of SMZ, with a mixture of mature hardwoods and pines. Not shown in the pictures, the logging roads have been cleaned up and restored. This area is well known for its turkey numbers, and the property is ready to be set up for deer and turkeys to your liking, with multiple locations for potential food plots and other wildlife enhancements. There are also possible pond/lake locations on both tracts depending on the soil types.
