MORE ABOUT TREASURE VALLEY MEAT PACKING FACILITY

The USDA produced a white paper outlining steps to boost and improve the beef industry in the US. Since 2017, the U.S. has lost over 17% of cattle ranches, more than 150,000 operations. The national herd is at a 75-year low, while consumer demand for beef has grown ~9% over the past decade. Because herd rebuilding takes time, USDA is investing during the downturn so that the next upswing is less volatile for ranchers and more affordable for consumers. The USDA Beef Industry Plan includes promotion, support, and expansion of small and medium processors. The three primary components of the program for beef processing are:

1. Promote Innovation and Reduce Costs for Small Processors
2. Reduce Overtime and Holiday Inspection Fees for Small Processors
3. Enhance Local Processing and Increase Marketing Options for Ranchers and Consumers

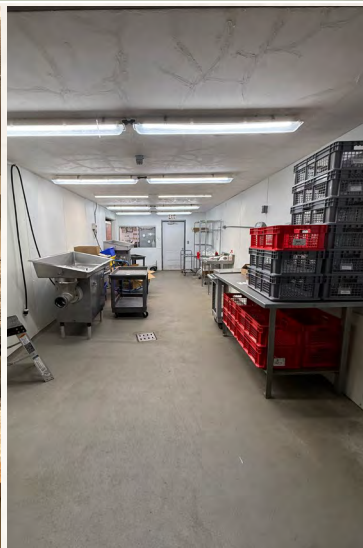

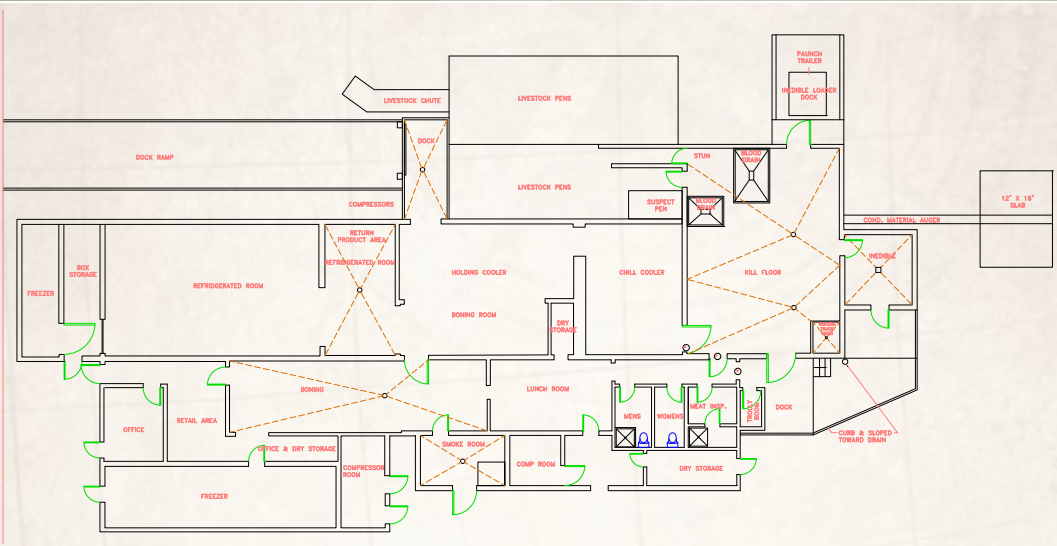

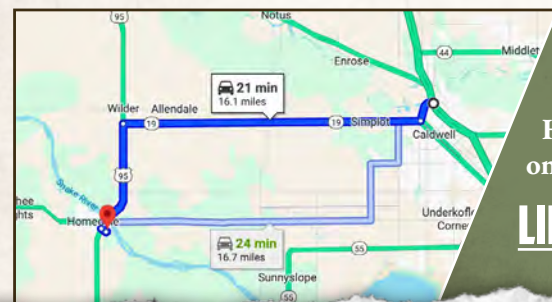
