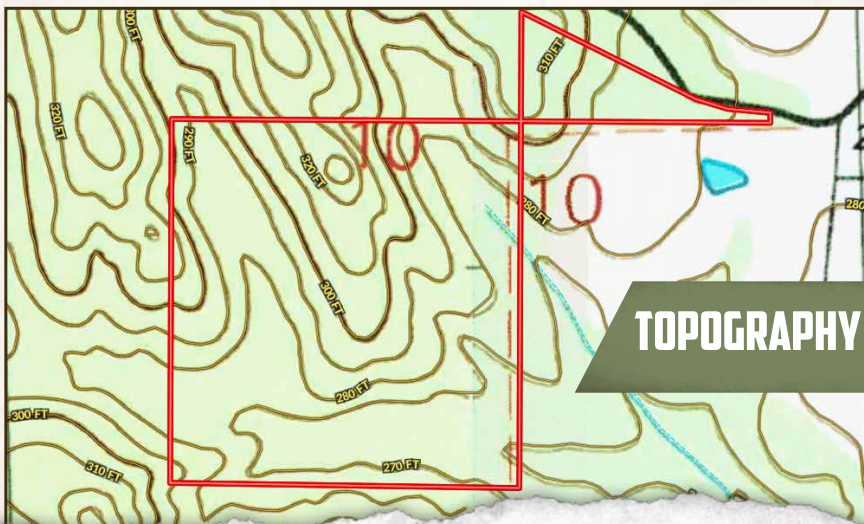

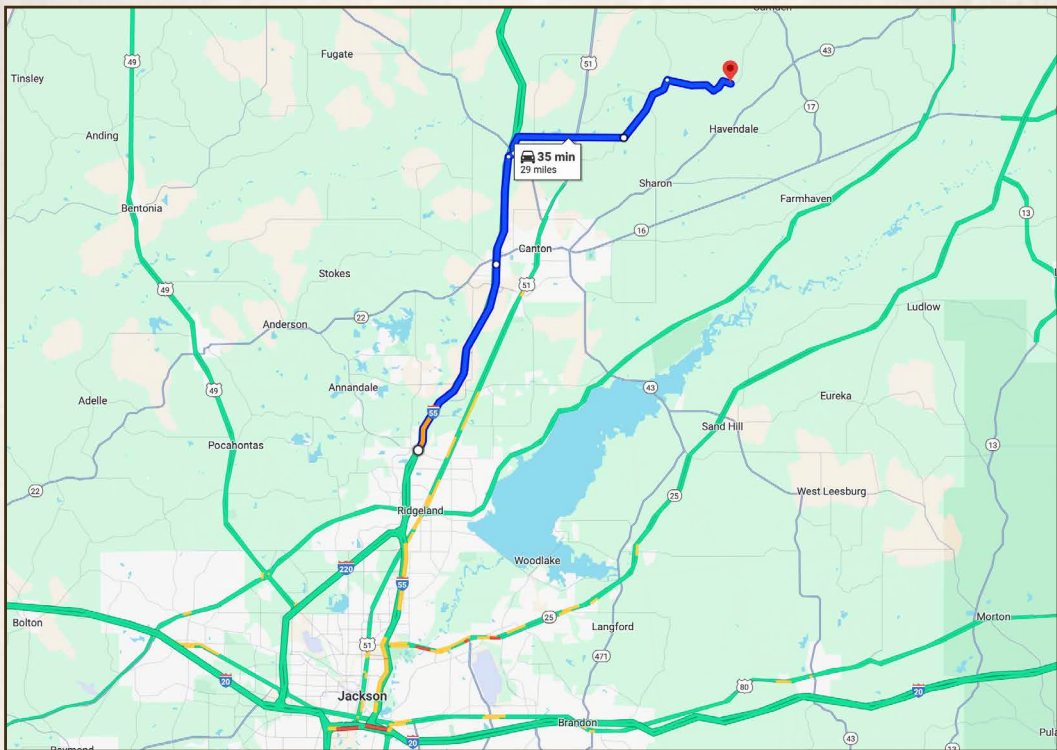

Turn left on Davis Crossing Road and proceed 6 miles. Turn left on Stump Bridge Road and travel 3.6 miles. Turn right on Mount Pilgrim Road and continue 3.5 miles to the property on the right.
