The mix of cutover ground and standing timber creates ideal conditions for deer and turkey hunting, with plenty of room for food plots, trail systems, and stand locations. The streamside timber enhances habitat, offers shaded areas, and adds scenic value for recreational use.

This tract is also well-suited for ATV riding, camping, hiking, or developing a secluded future home or cabin site. Power is already established on the property and is provided by Tallahatchie Valley Electric Power Association. As a cutover property, it offers strong potential for timber investment and land appreciation, allowing a new owner to actively manage regrowth while benefiting from the existing wooded stream buffer. Its size and layout provide privacy and flexibility for a wide range of uses.

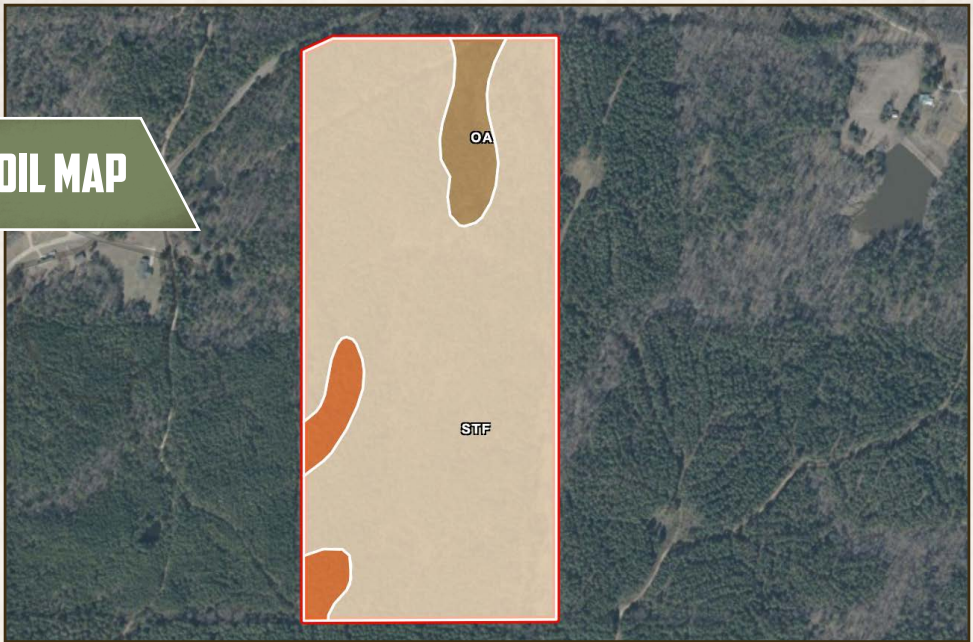

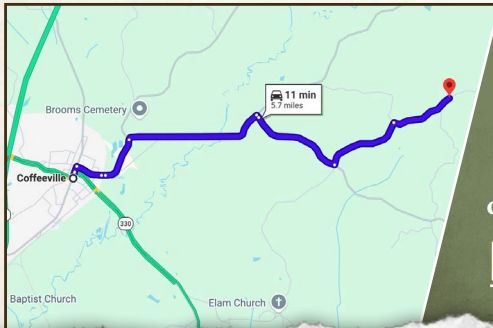
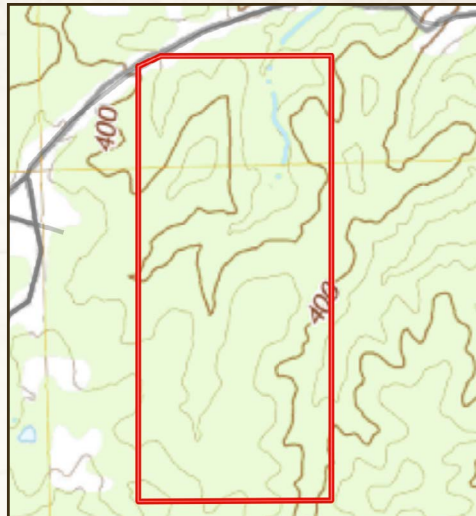

Directions From Coffeerville, MS: Travel north on Okahoma Street. Turn right on Kennedy Street which becomes Pontotoc Road. Continue on Old Water Valley Road for 0.6 miles. Make a slight right on County Road 222 and proceed 1.7 miles. Turn right toward County Rd 222 and continue 1.2 miles. Turn left onto Elam N Road and travel 1.0 mile. Turn right on Old Houston Road and in 0.8 miles, the destination will be on the right.
