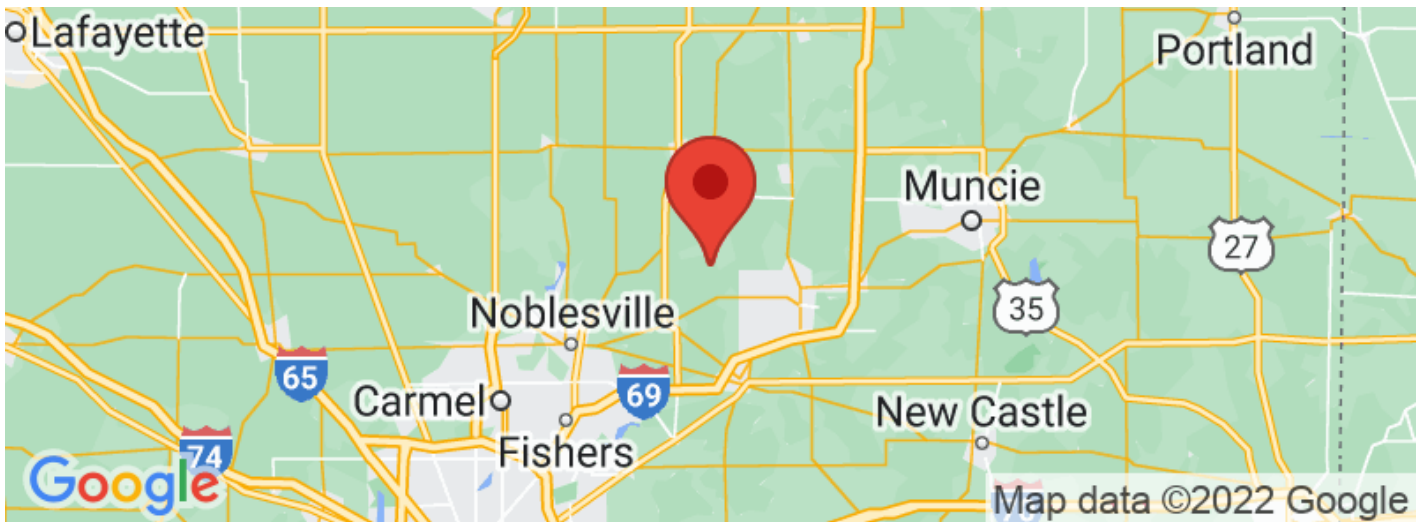
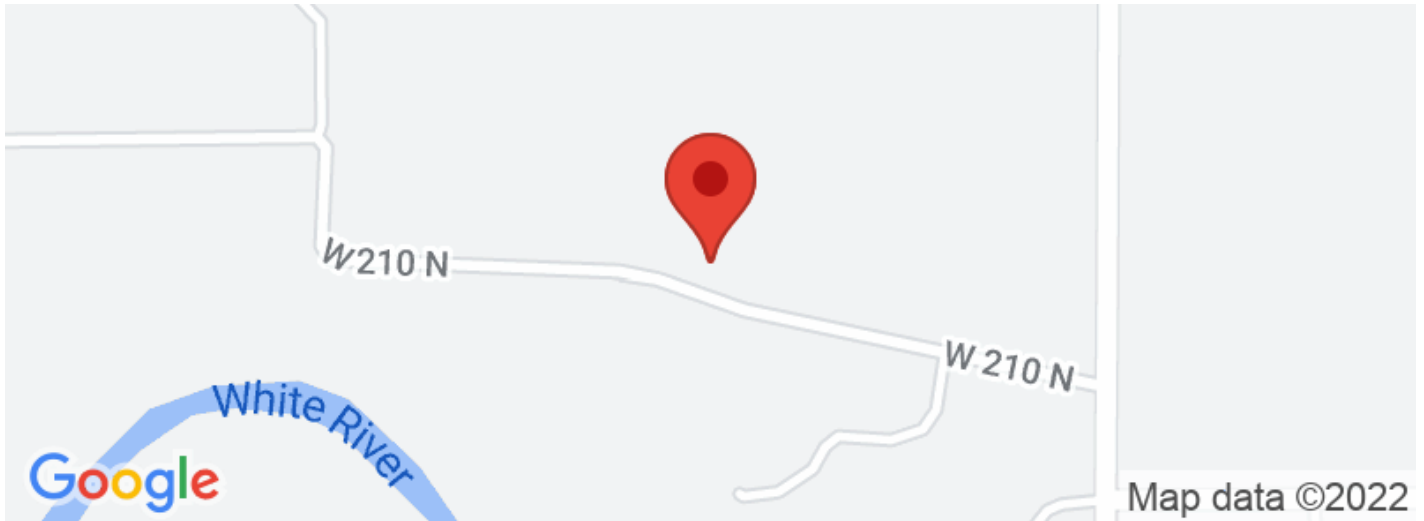

## Locator Maps

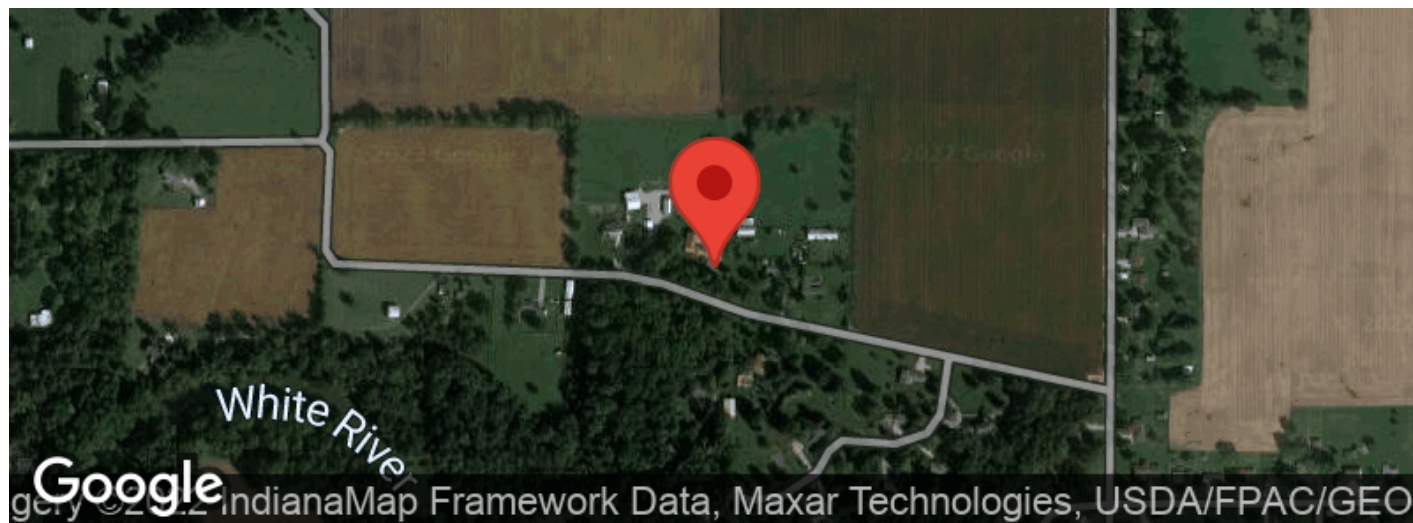
