Power is available nearby, adding convenience for future improvements. While much of the property is located within the floodplain, it could make an excellent location for a camper, weekend retreat, or potential cabin site subject to local regulations and permitting requirements.

Conveniently situated just 15 miles south of Terre Haute and approximately 13 miles from Sullivan, the property combines accessibility with a secluded outdoor atmosphere.

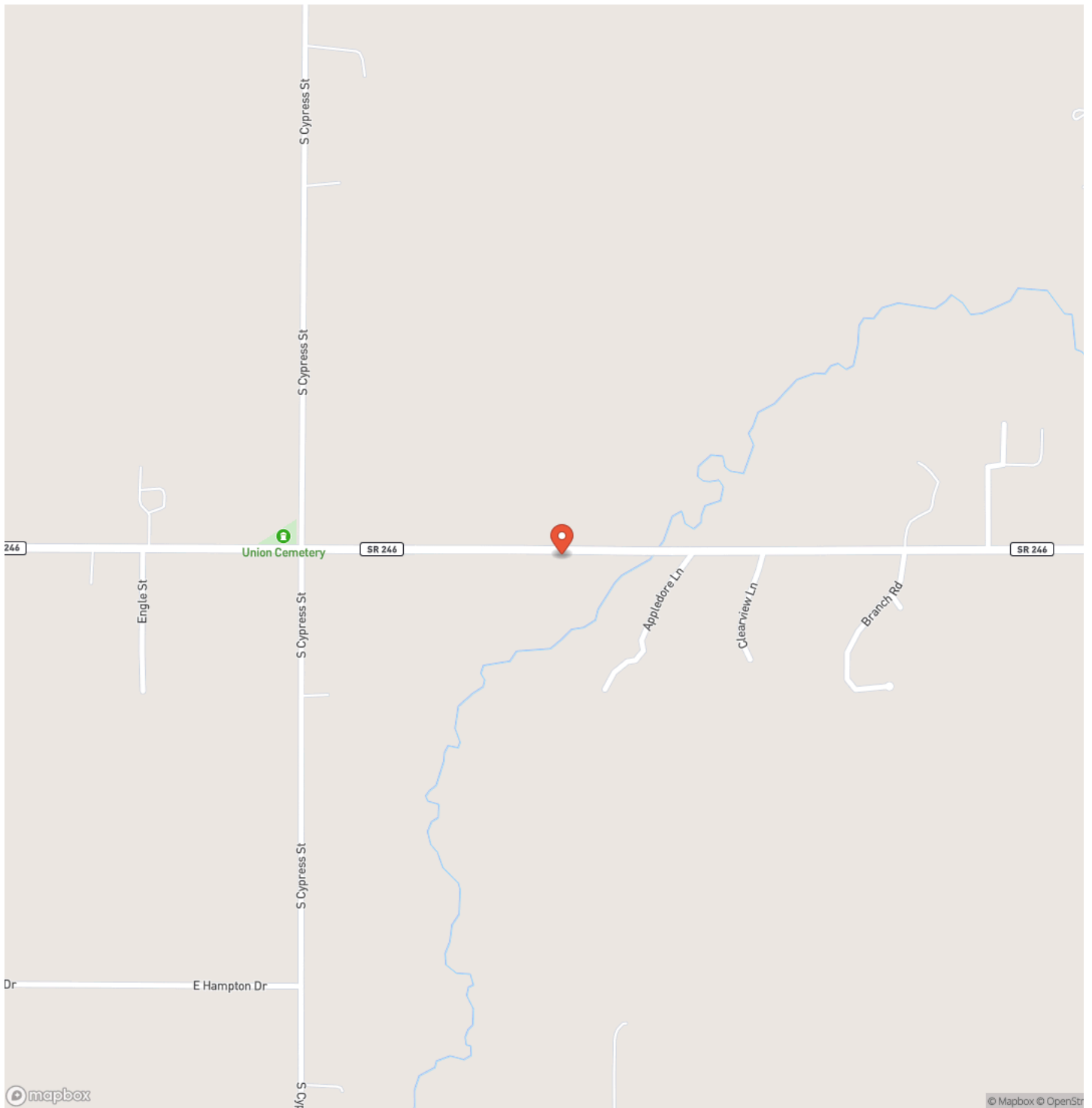

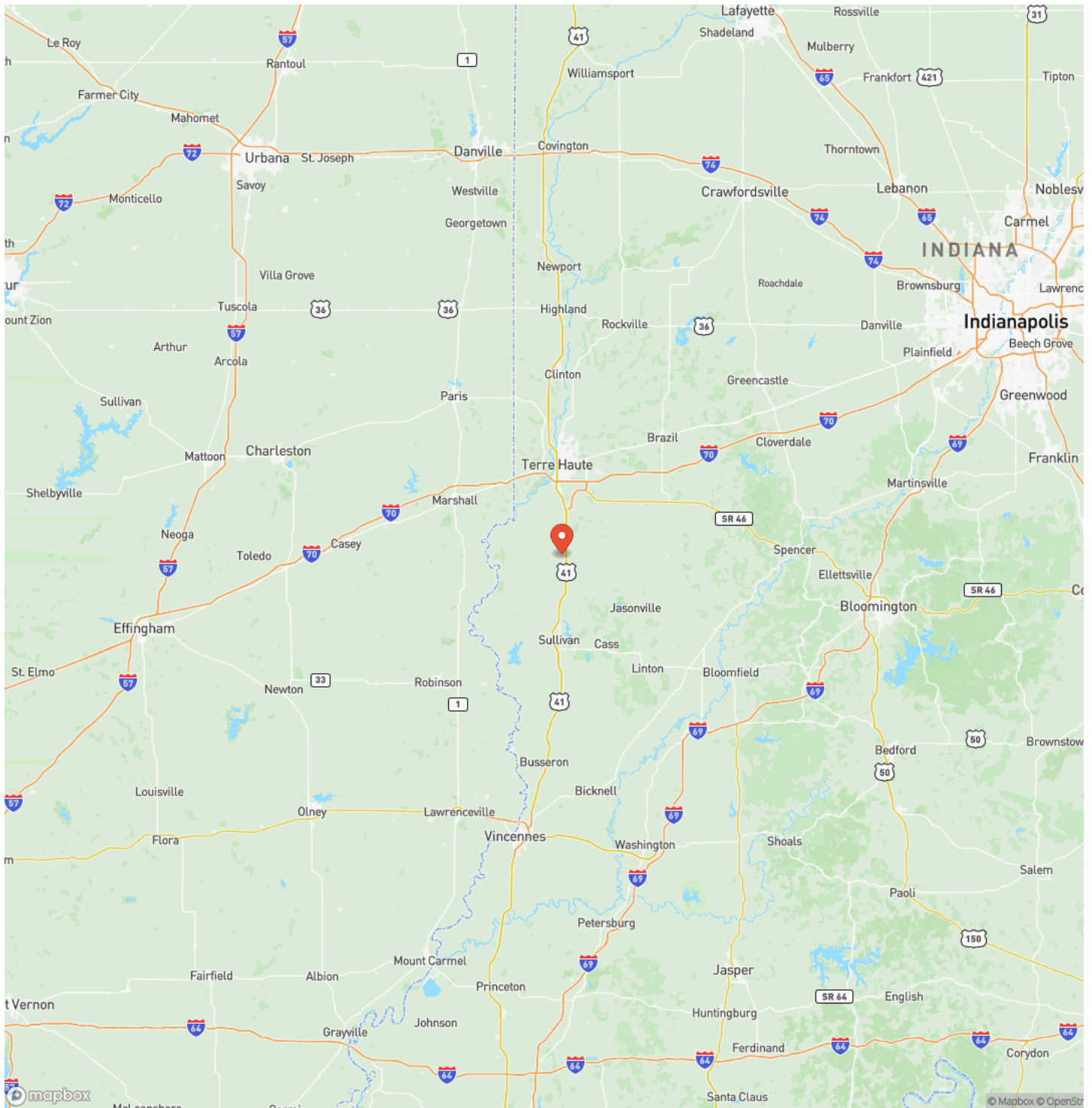
