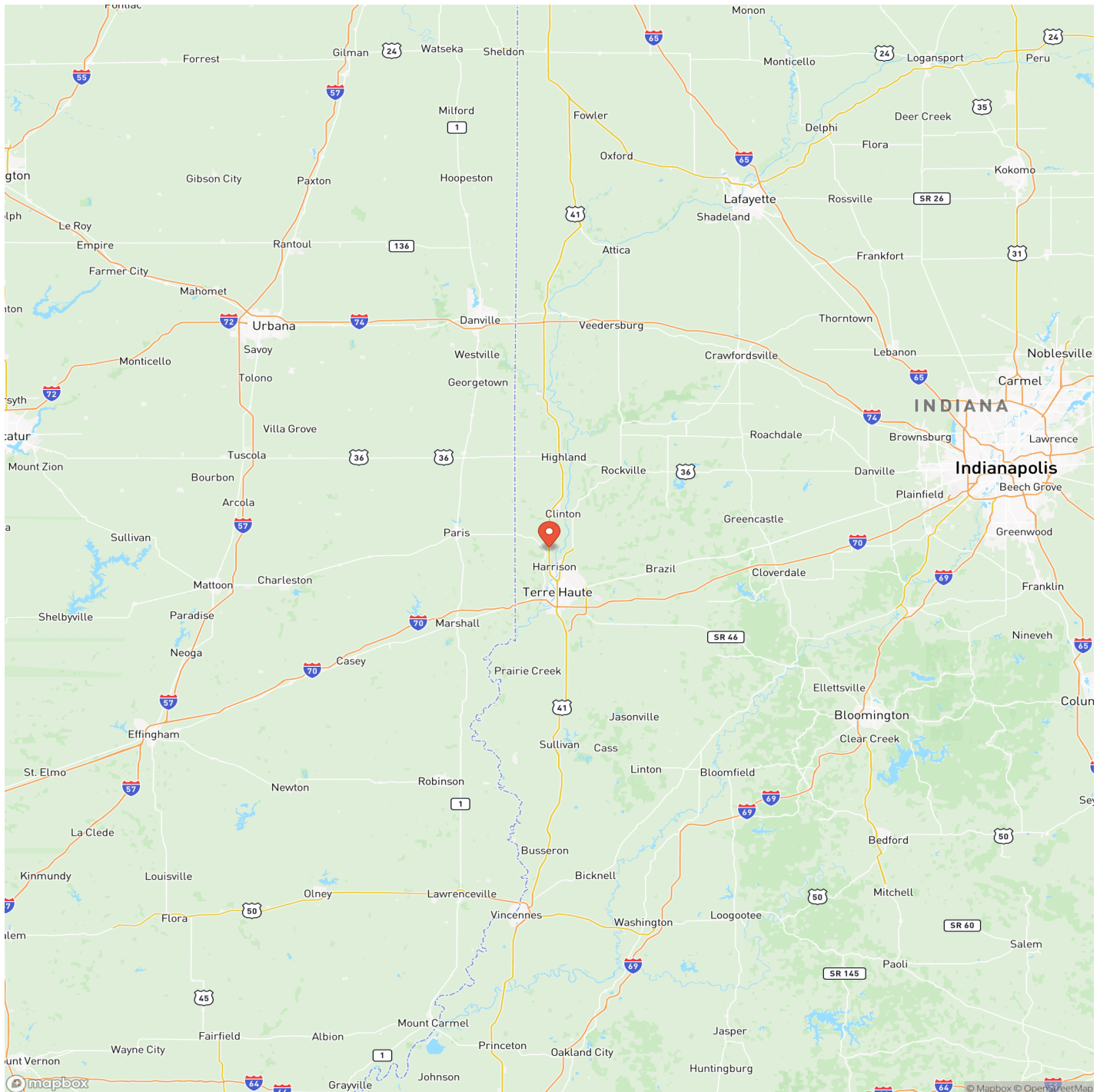


Locator Map

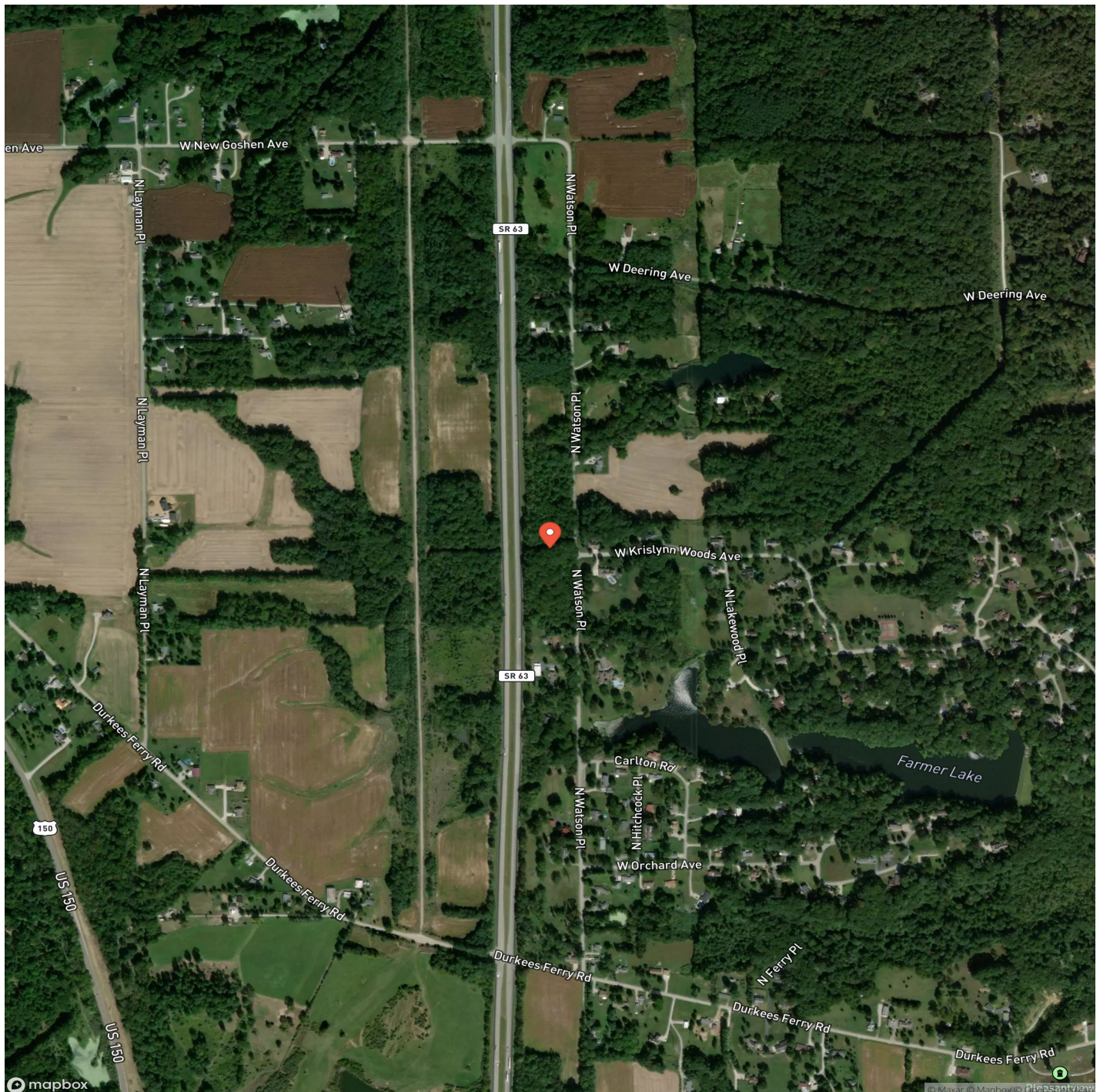
