Check out this rural Brazil property. It truly does have it all and then some! The 2464 sq ft home was built in 1997. It has 3 bedrooms, 2.5 baths, and an attached 2 car garage. The unfinished full basement adds an additional 1232 square feet, perfect for storage or future finished space. A large back deck overlooks the 15 acre lake, providing beautiful views. A wooden staircase leads from the house to the la and floating dock. The lake is home to several species of fish and is a stopping point for waterfowl heading south in the fall. Nesting pairs geese use this area to raise their young in the spring. The home is being listed with a total of 20 acres; three being the portion of the lake and the remaining 17 acres being mostly wooded. These wooded acres have a lot of nice timber with a good variety of tree species. The wooded terrain is just as diverse with rolling flats, steep ravines, former coalmine spill piles, and wooded draws. Additional acres can be purchase as part of the sale. The lake provides year-round water for the many resident wildlife. A good number of whitetail deer call this place home. Wild turkey can be seen crossing the yard or one of the many roads that criss-cross the property. Just to the west and south the property is almost 2000 acres of state-owned ground. These acres are mostly open and prairie-like with both quail and pheasant present. This area was a 2015 Indiana conservation project with the NWTF and supports a lot of small game animals like rabbit and squir with some great wildlife plantings for doves every year. 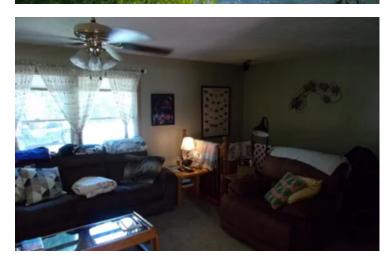








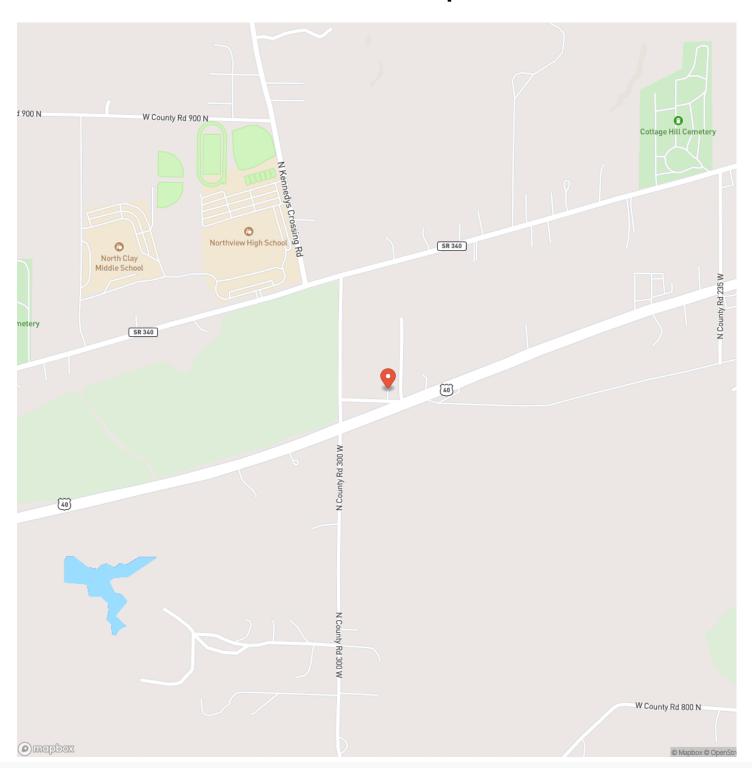






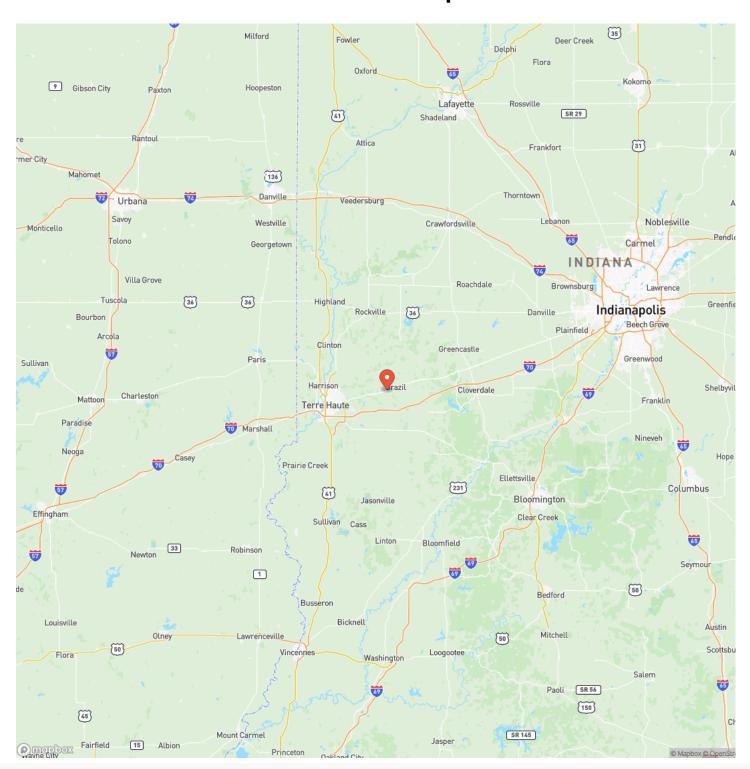


Locator Map



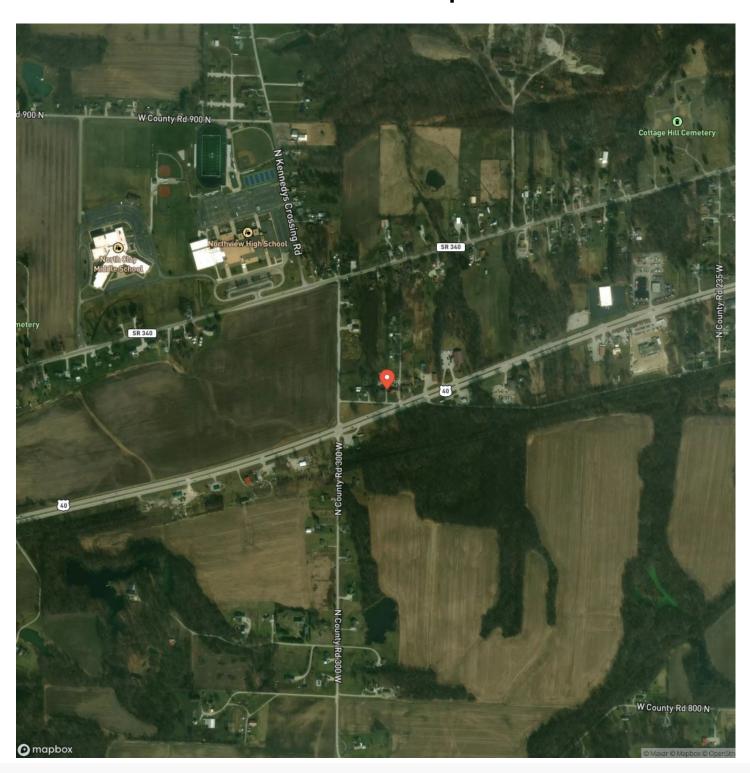


Locator Map
