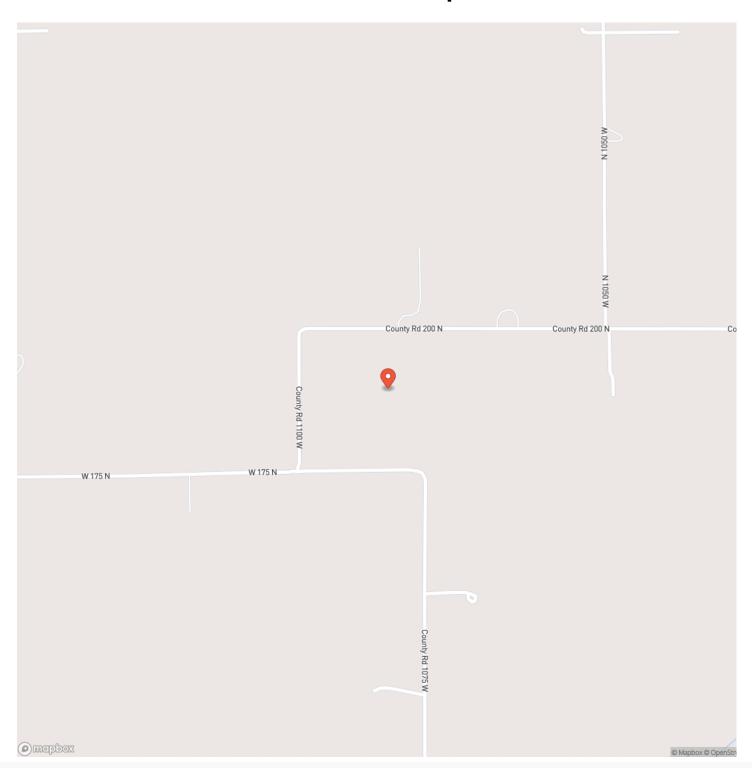

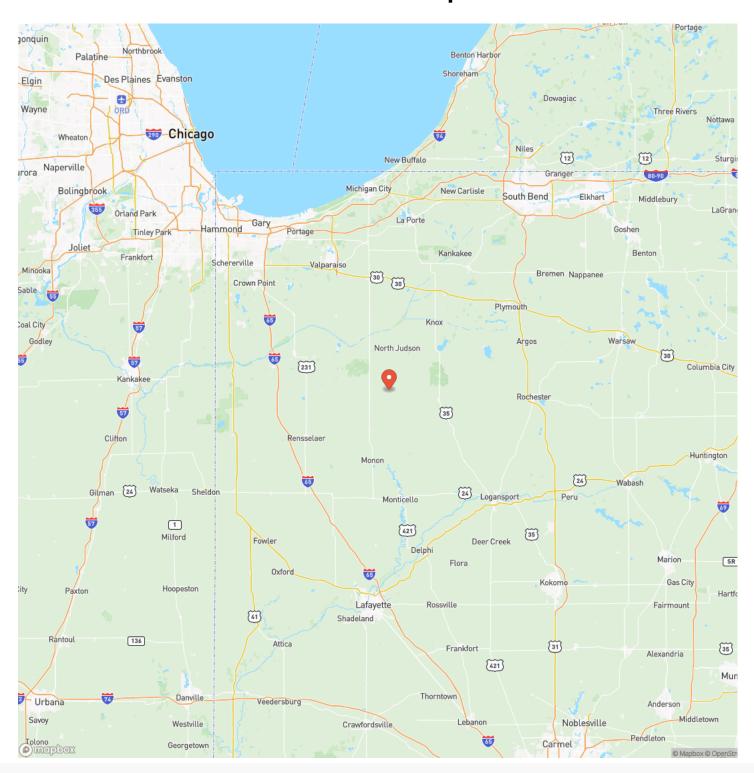


## **Locator Map**



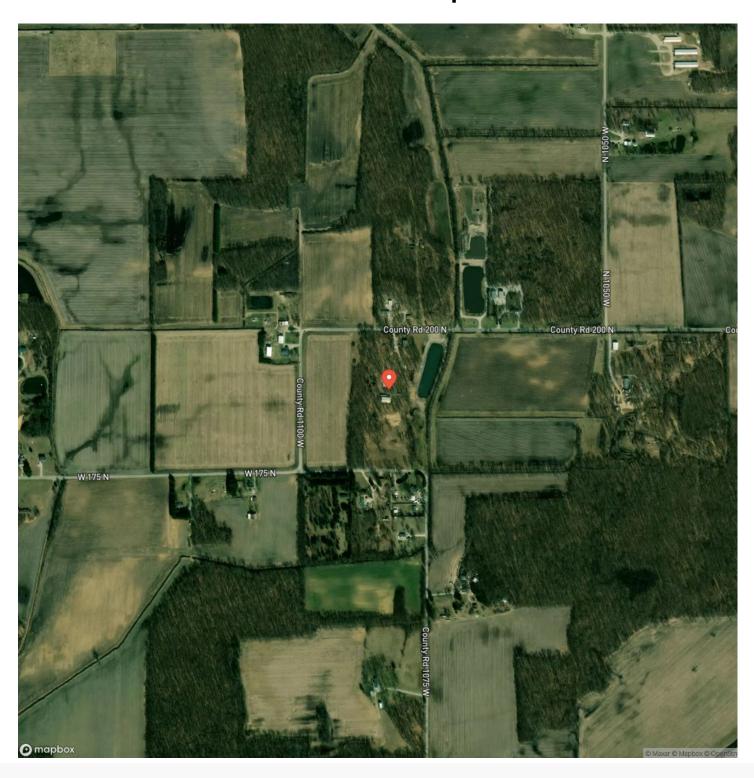


## **Locator Map**
