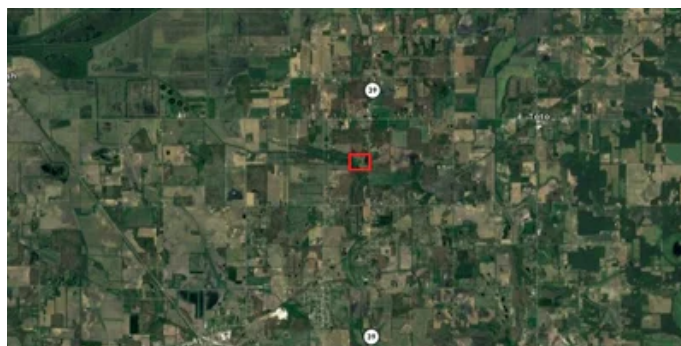

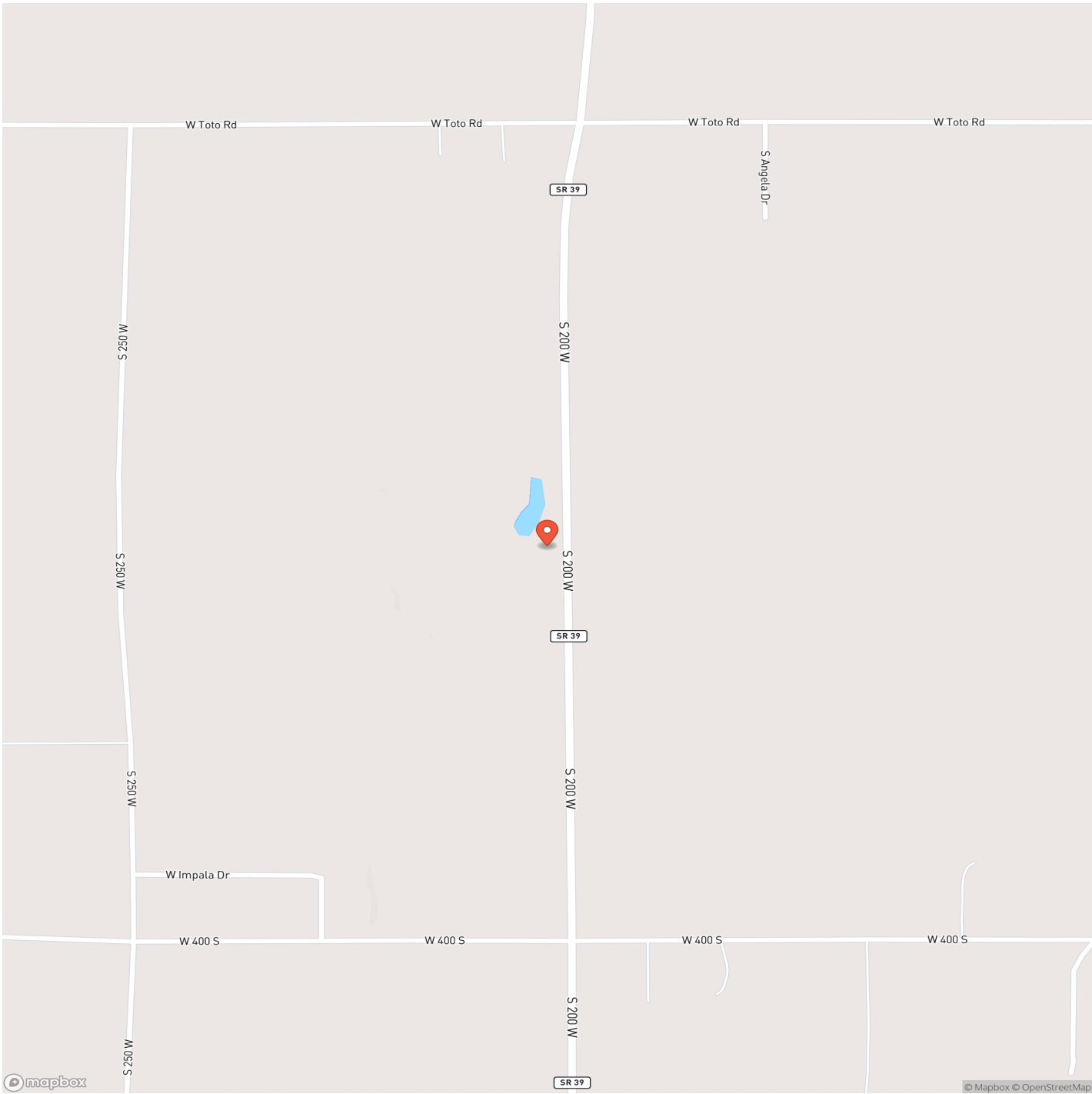

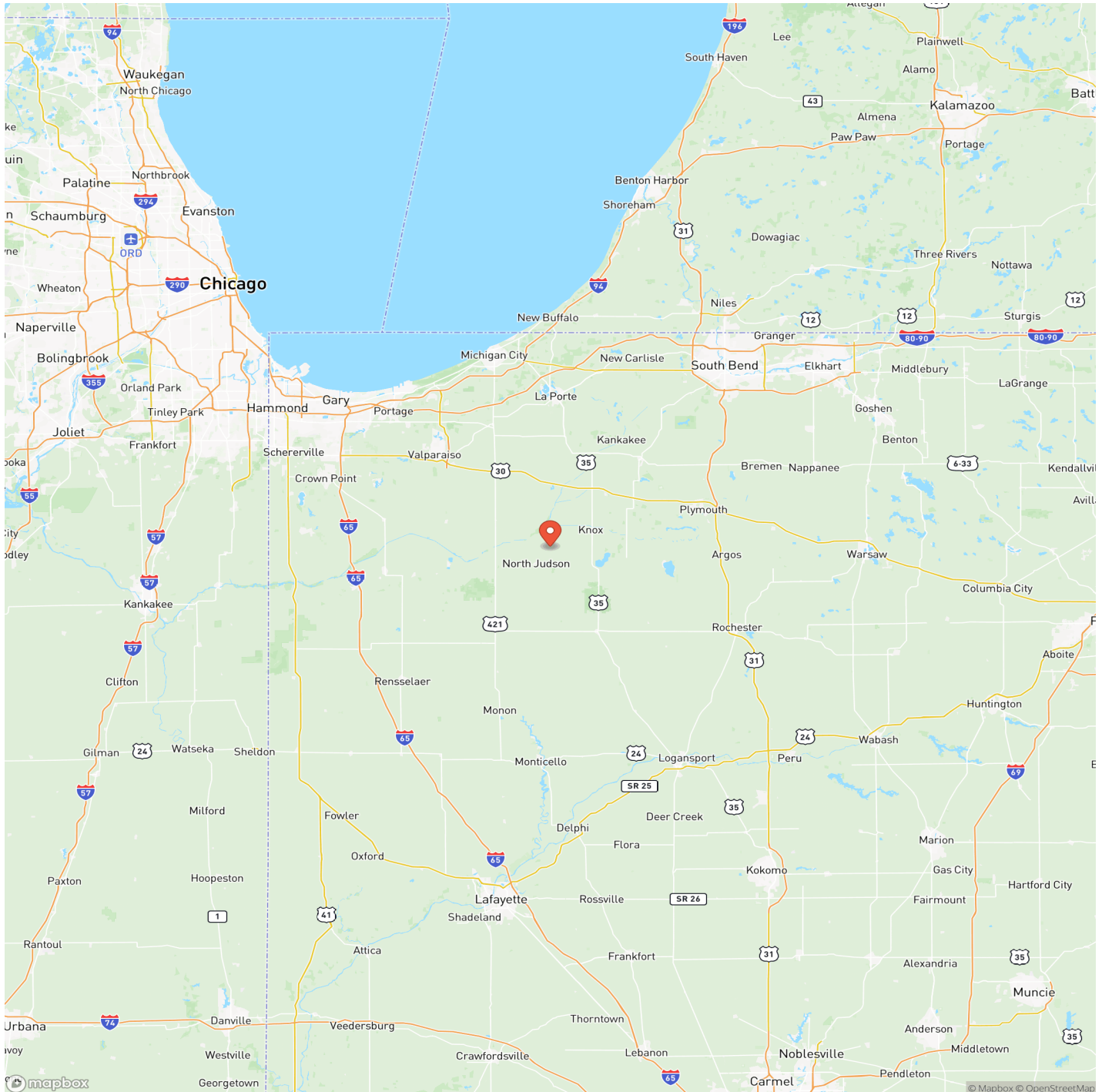

Locator Map

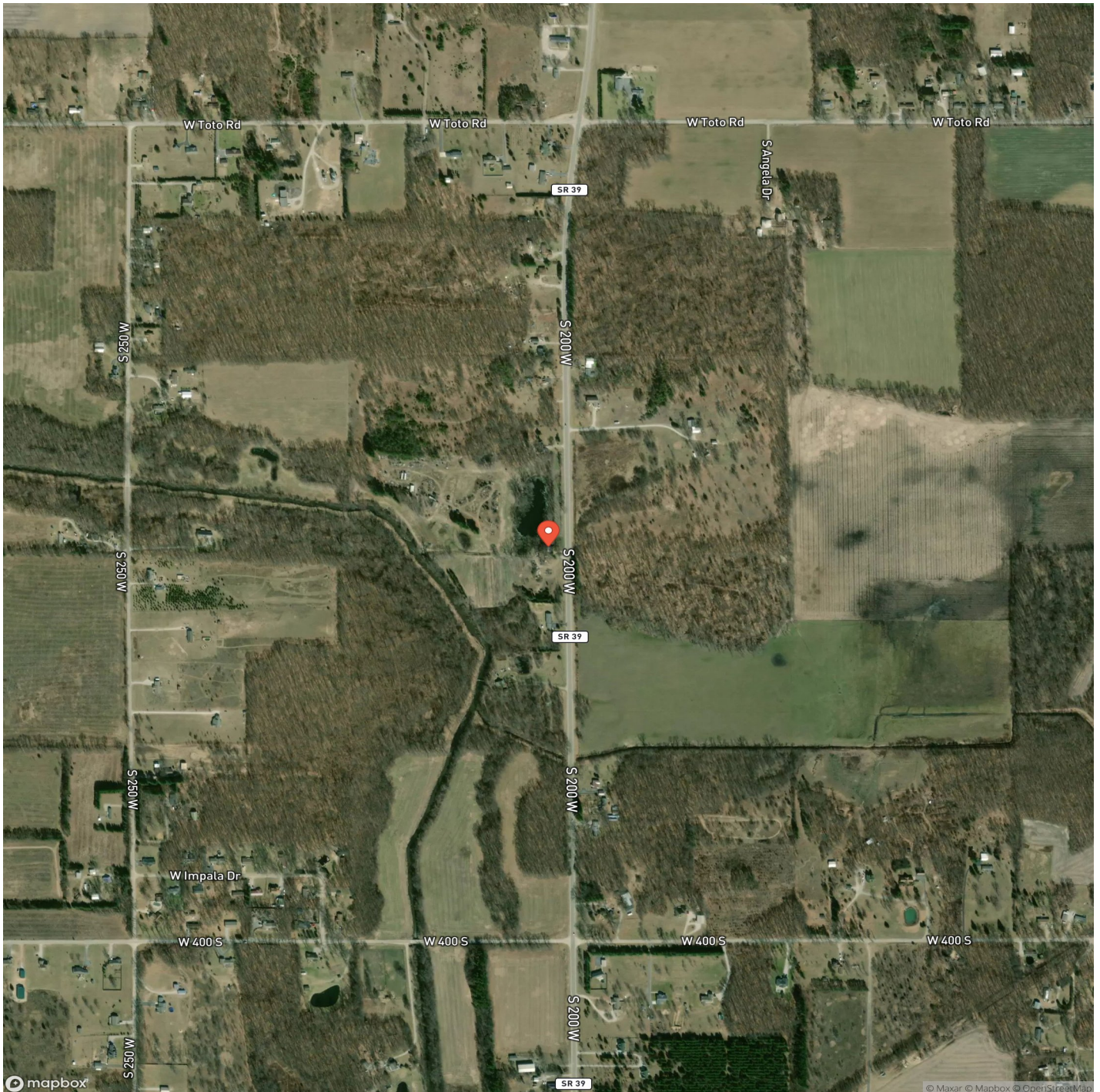
