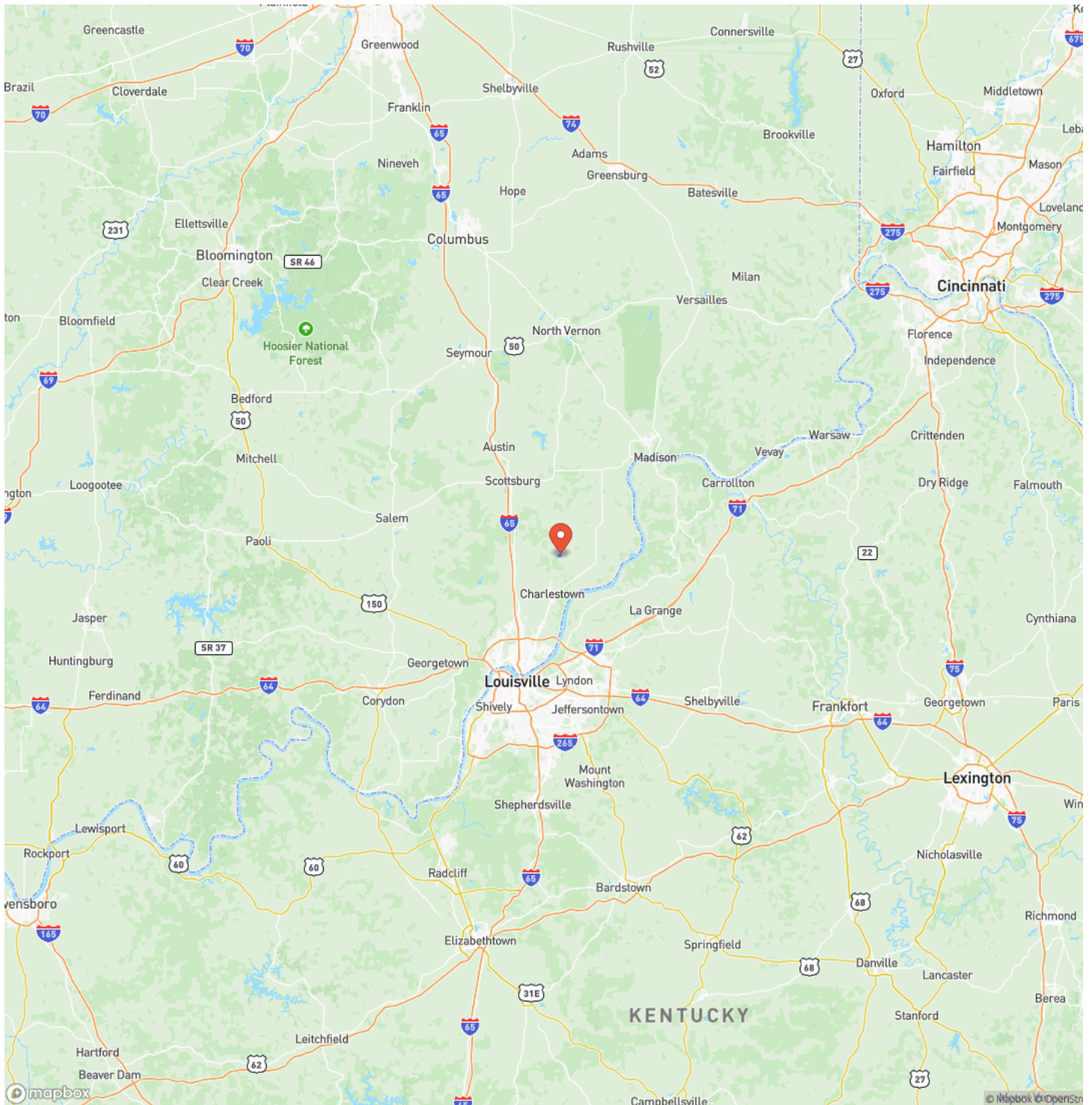
## Locator Map
