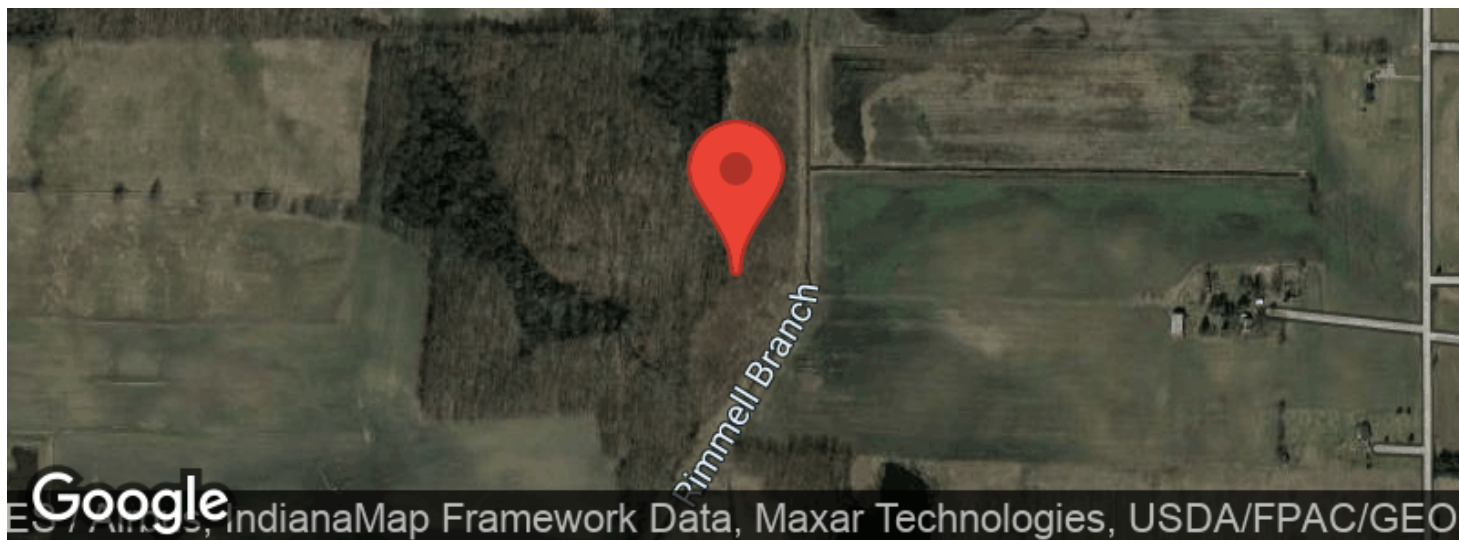
## Locator Maps
