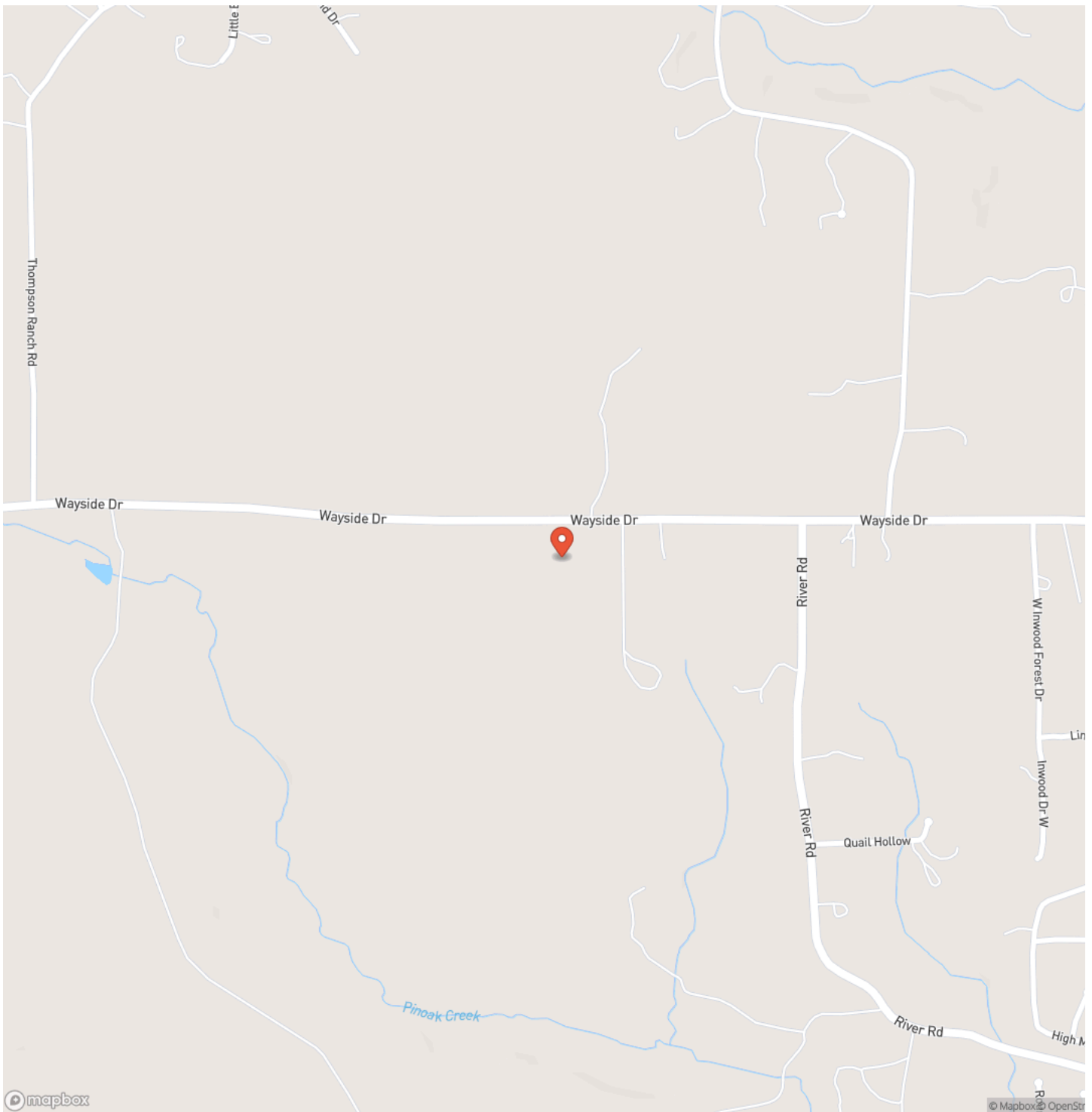

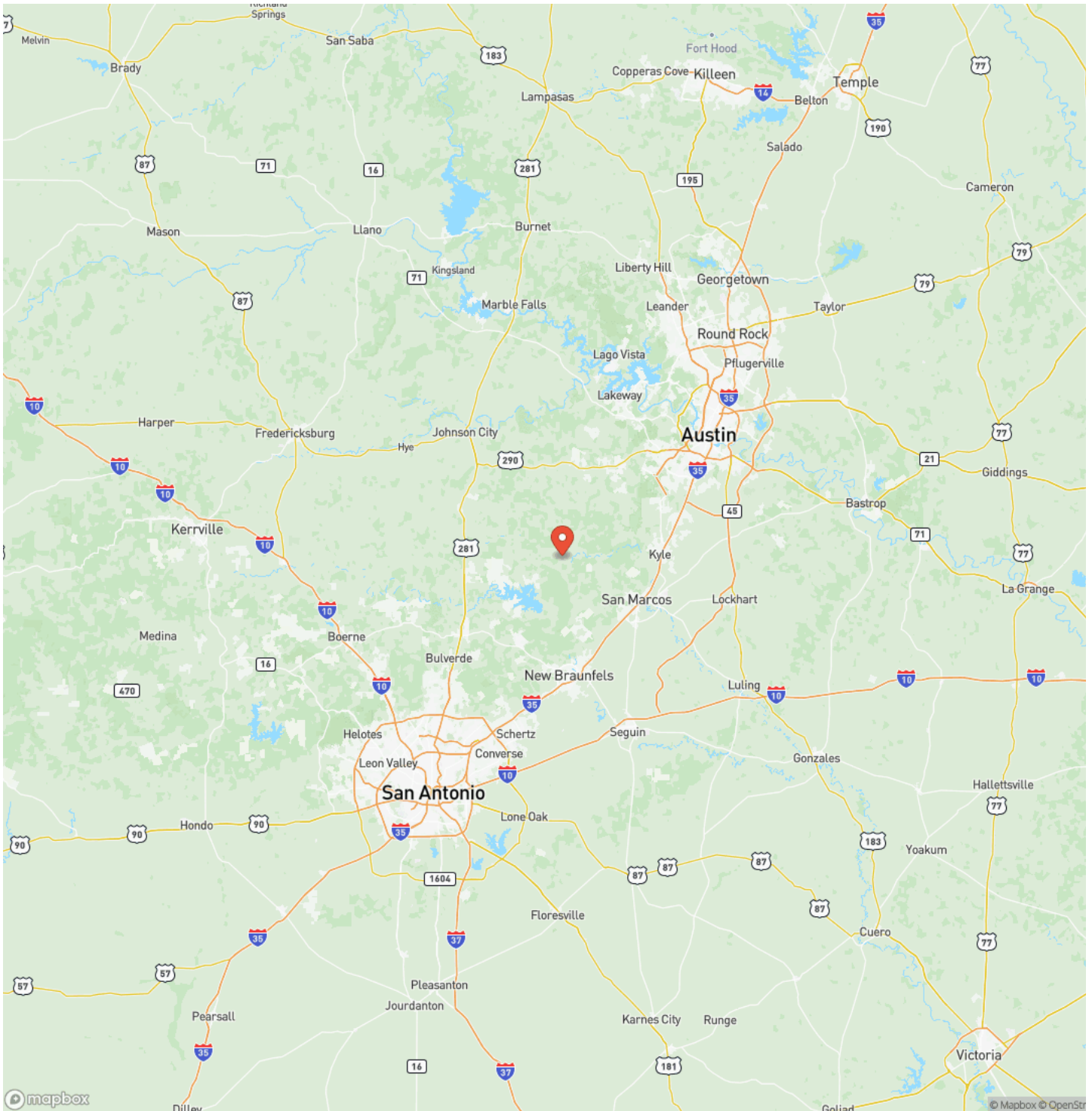

Locator Map

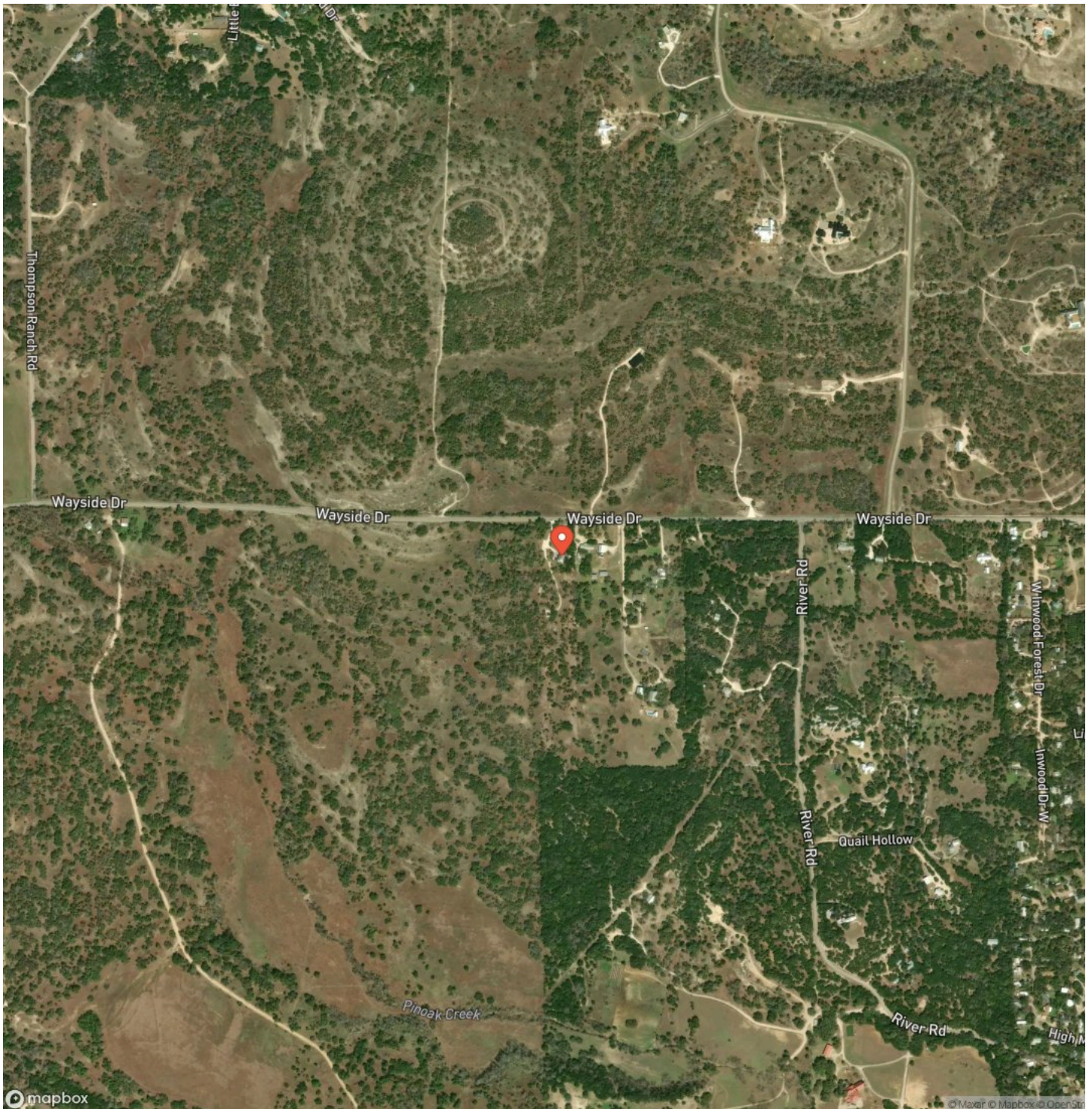
