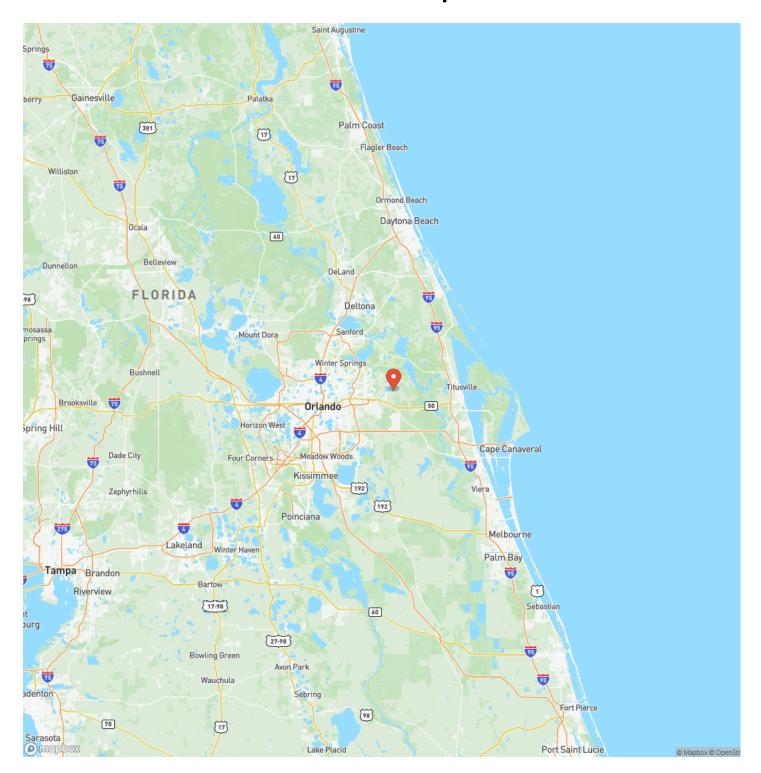


Locator Map

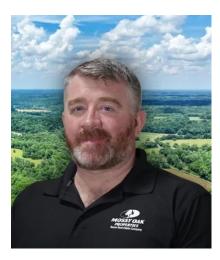
