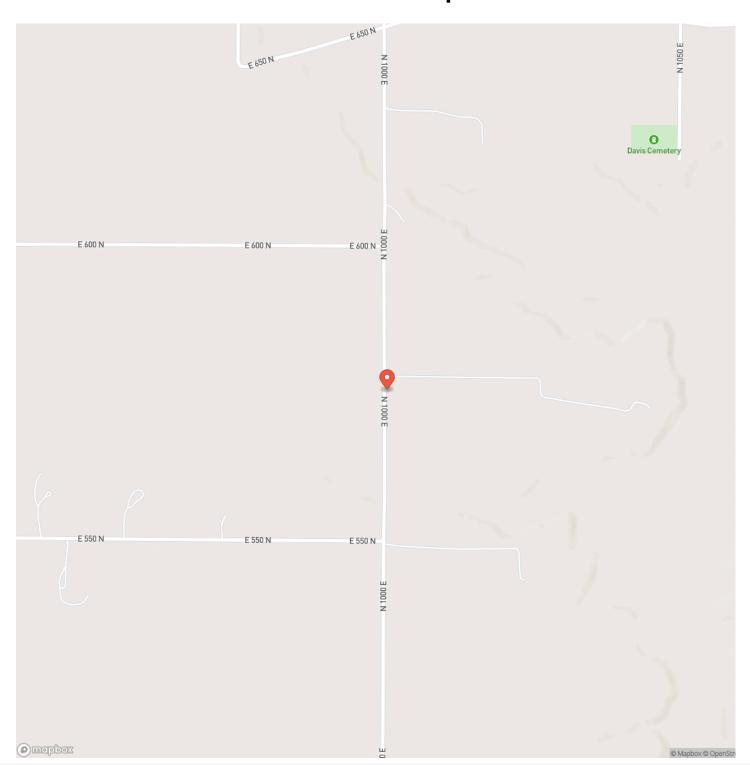

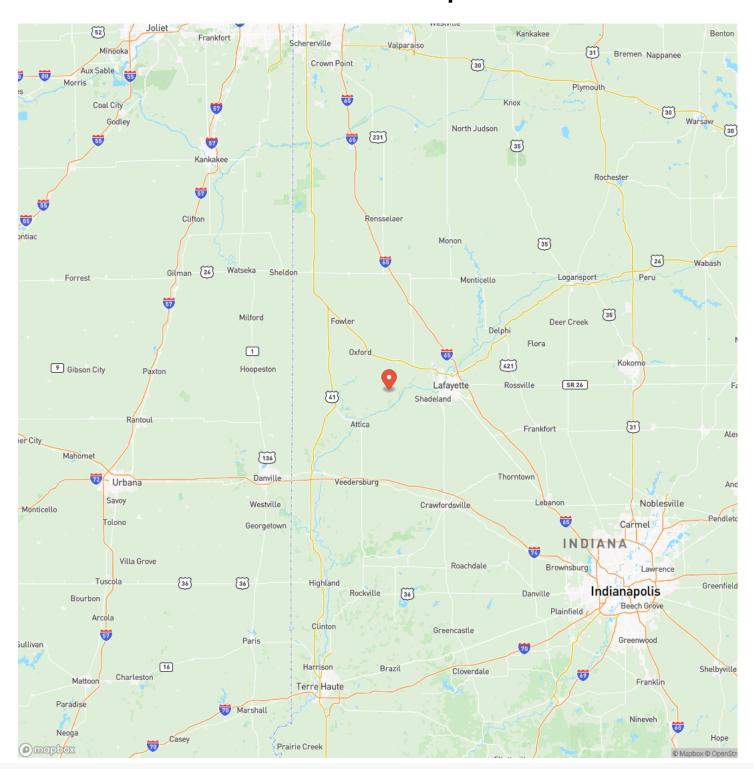


Locator Map



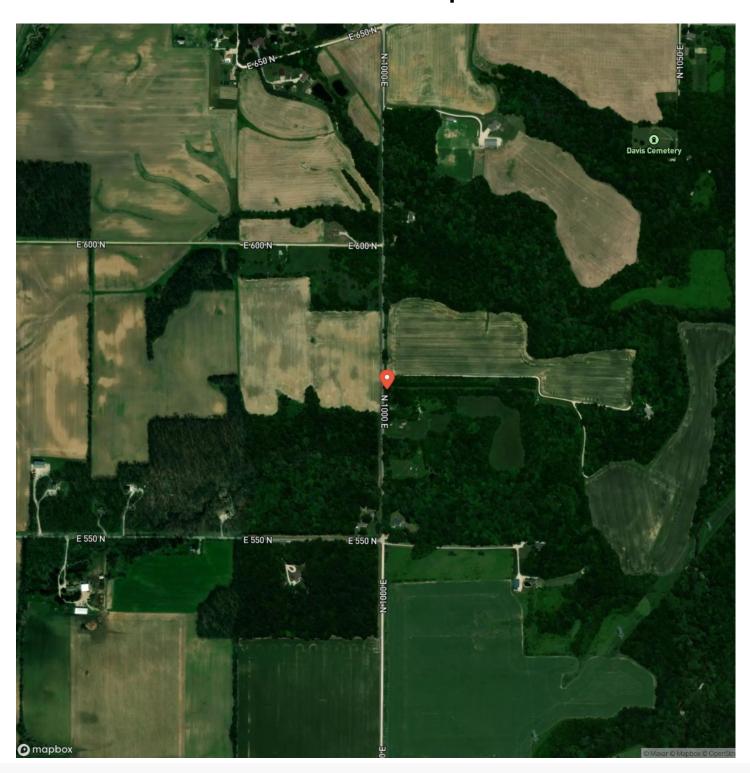
