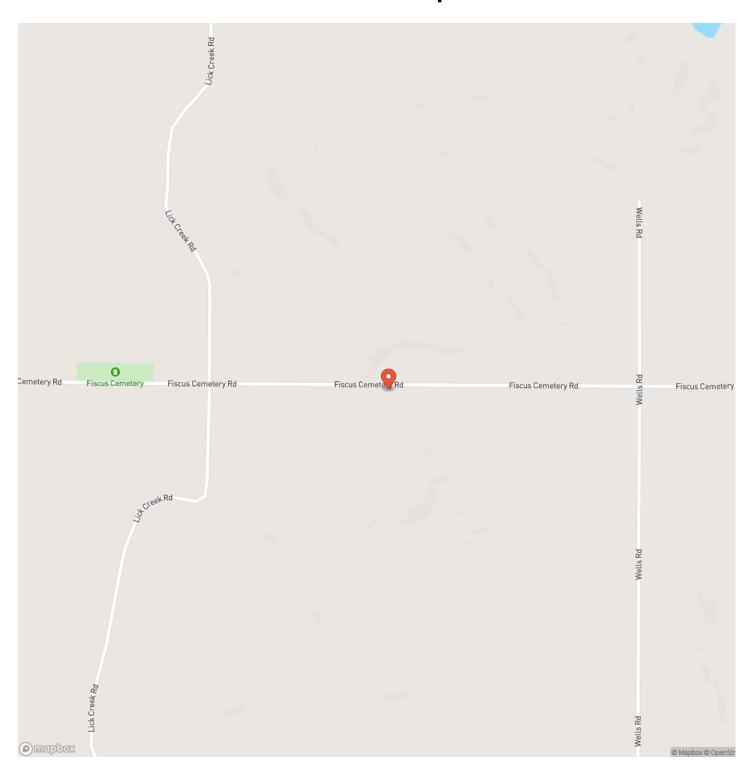






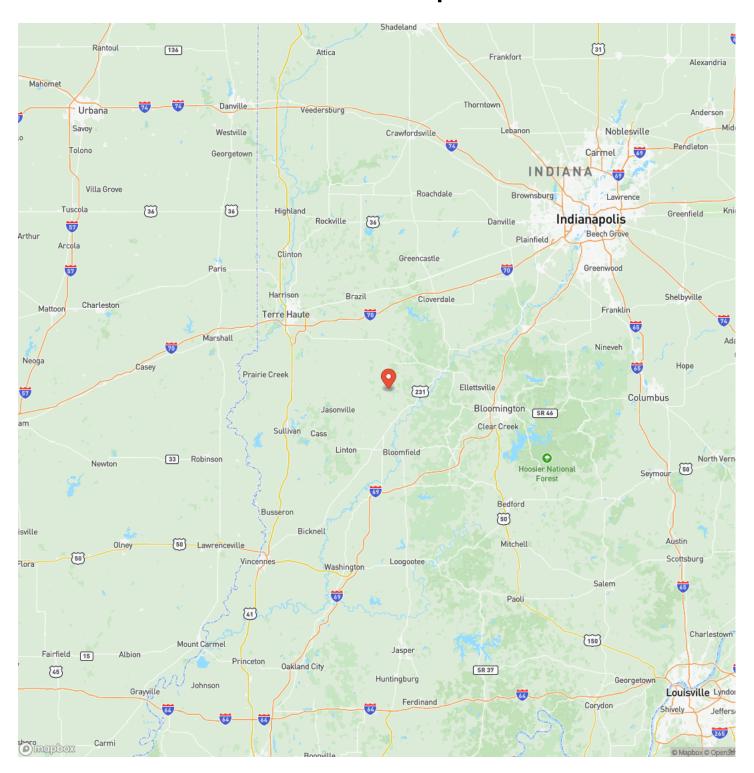


Locator Map



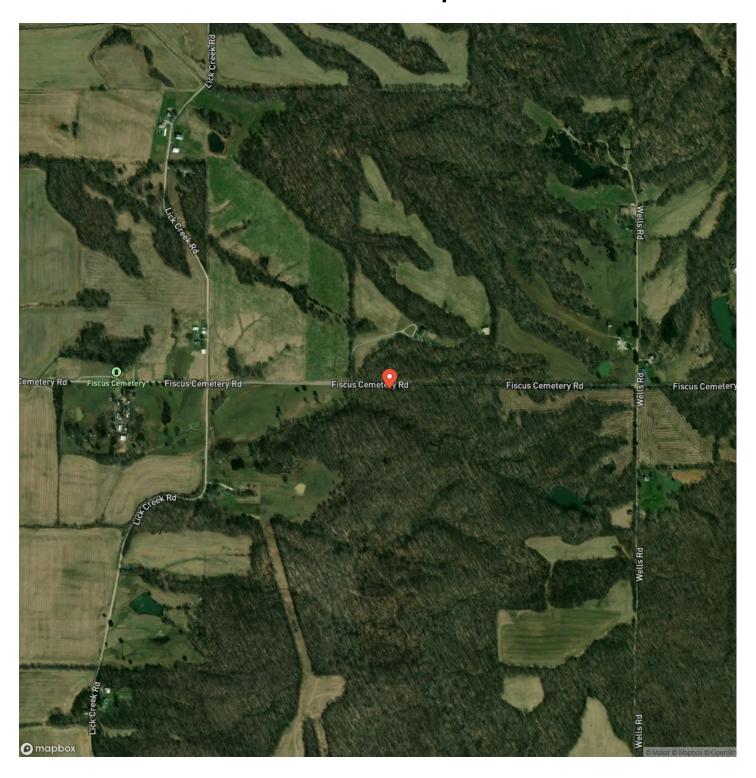
