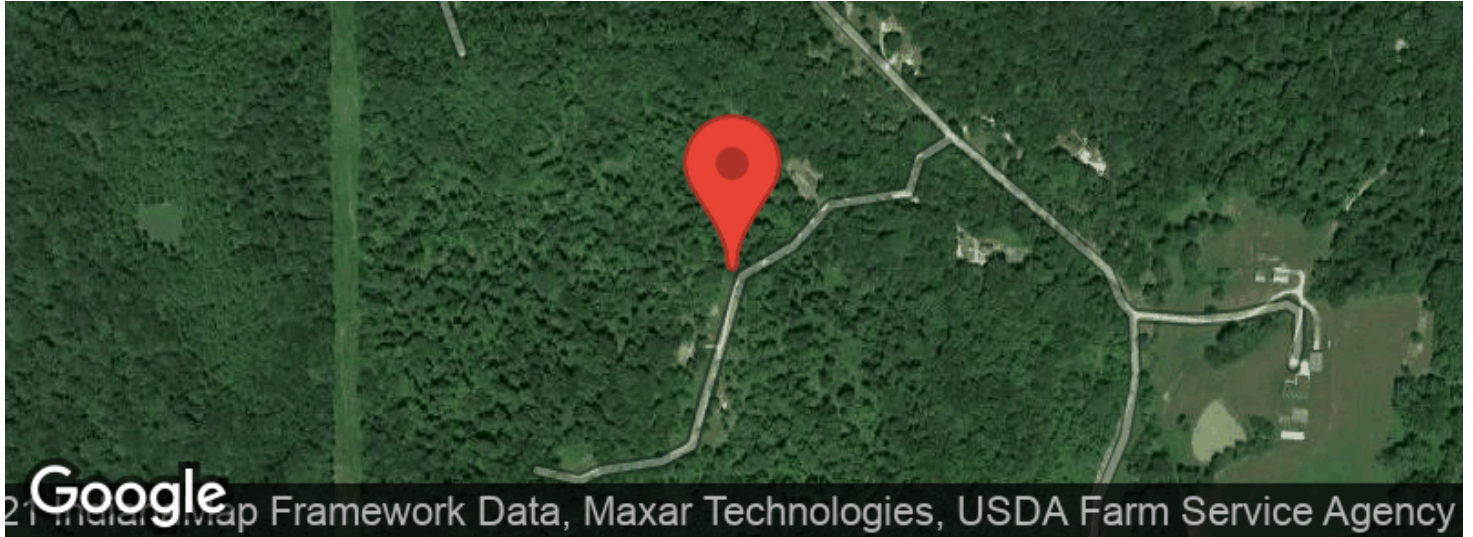




Locator Maps
