- **Pond Ownership:** The owner holds 2/3 ownership of a pond, adding to the recreational and aesthetic value of the land.

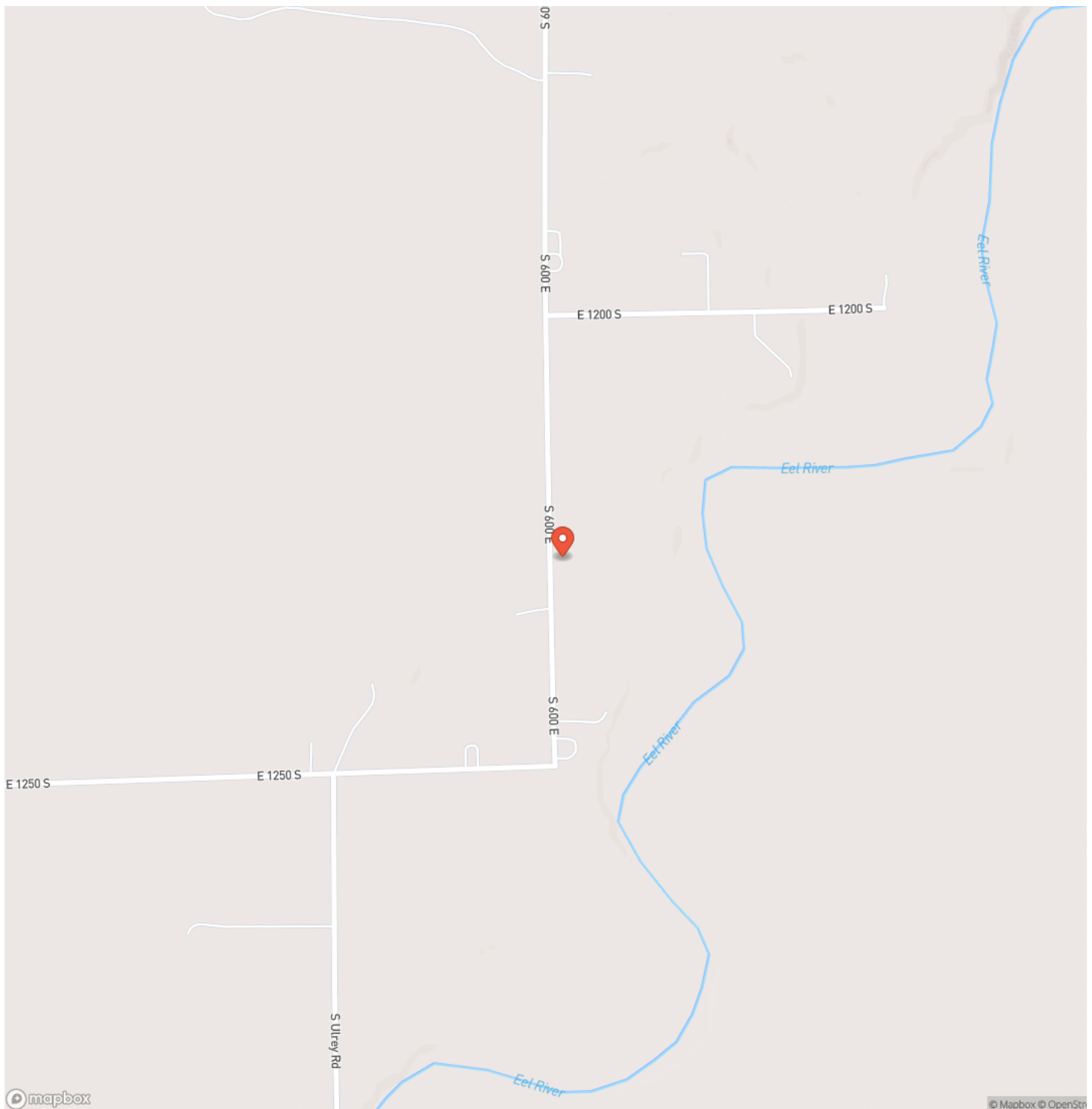

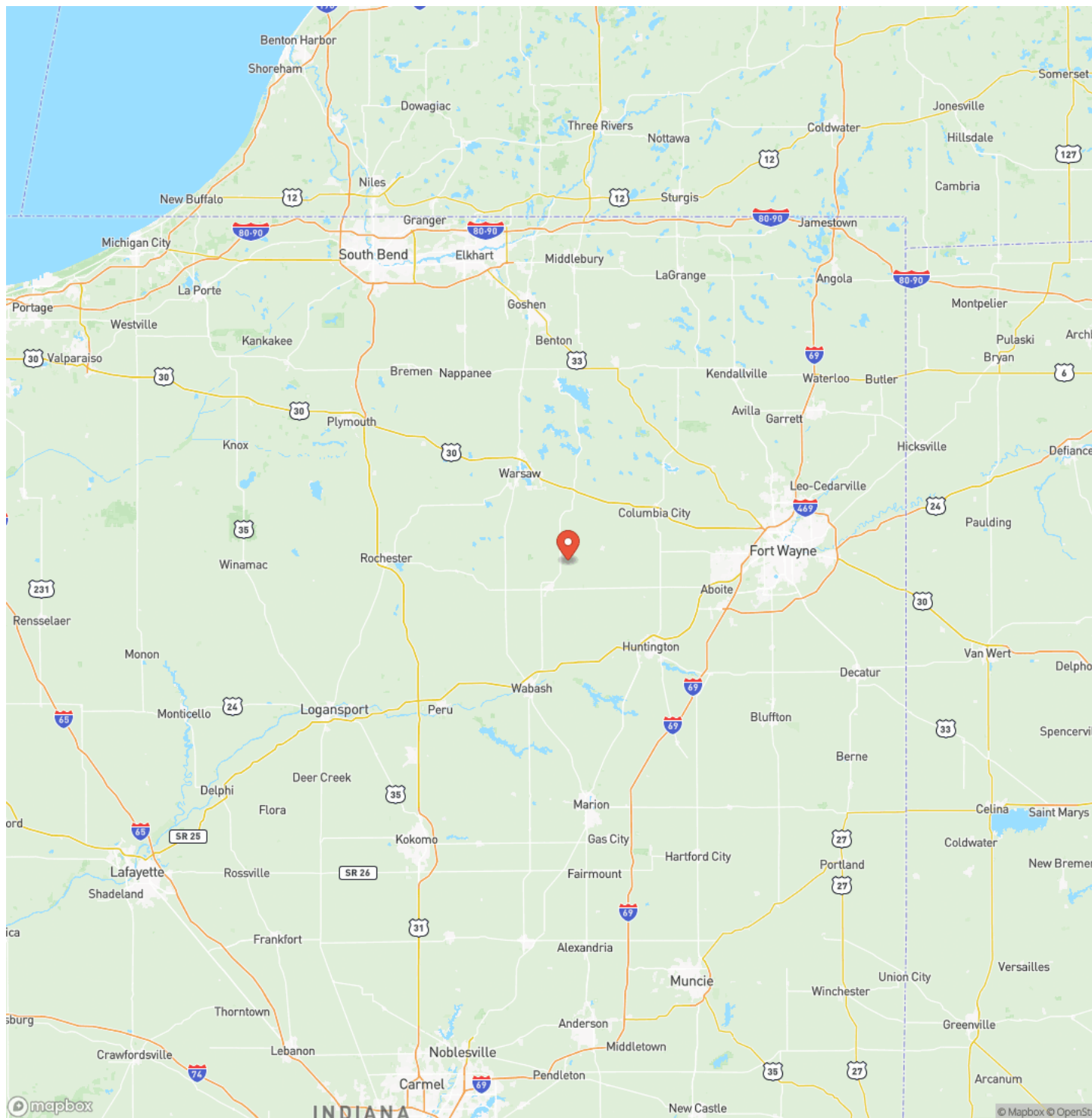

Locator Map

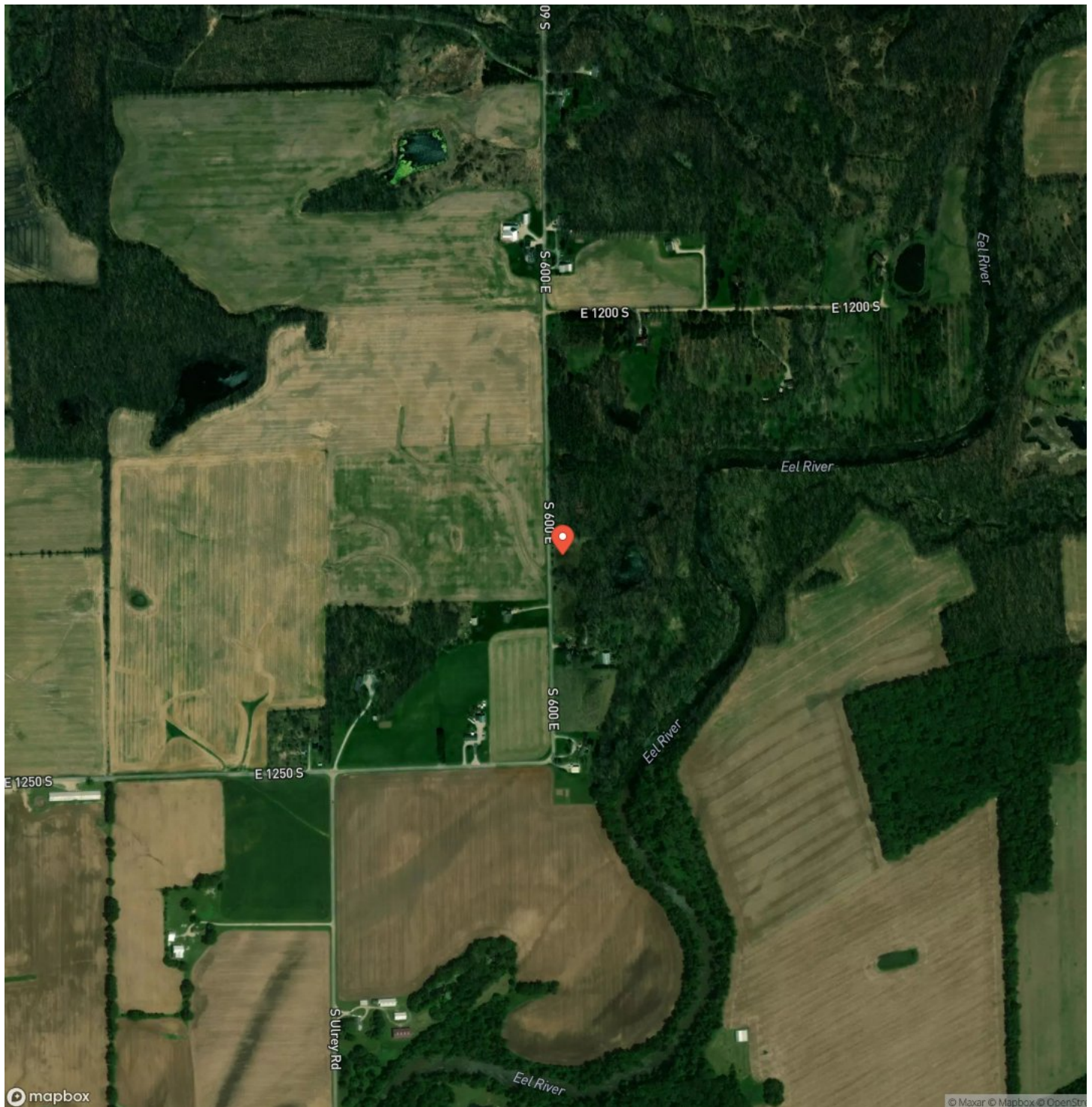
