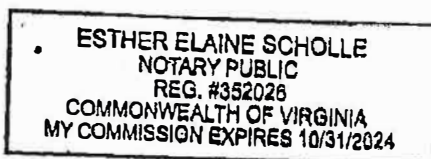

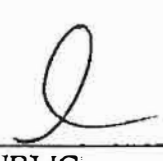

Legal Description
