DEED

THIS DEED, made and entered into September 17, 2003, by and between LESLIE E. THOMPSON (Widower), Grantor, and PATRICIA LOUISE THOMPSON PELLET, LARRY RAY THOMPSON, KIM THOMPSON FARMER, and JOHN EDWARDS THOMPSON, Grantees:

WITNESSETH THAT the Grantor, for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable considerations paid by the Grantees, the receipt of which is hereby acknowledged, first reserving unto himself a life estate in and to the hereinafter described lands, has bargained and sold, and by these presents does hereby bargain, sell, and convey unto the said Grantees, their heirs and assigns, in fee simple, those certain lots or parcels of land hereinafter described:

PARCEL NO. 1:

FORK TOWNSHIP, WAYNE COUNTY, NORTH CAROLINA, and more particularly described as follows:

Beginning at the R. T. Gurley Estate corner, in the center of a ditch and 105 feet from the center of U.S. Highway #70, and running thence with the said105-foot right-of-way S. 58-54 E. 5 feet to a stake; thence continuing S. 58-54 E. 94.5 feet to a stake; thence N. 31-06 E. 200 feet to a stake; thence N. 58-54 W. 197.7 feet to a stake, said stake being S. 58-54 E. 5 feet from the center of the ditch, the R. T. Gurley Estate line; thence from said stake, 5 feet from the center of the ditch, S. 04-17 E. 106.04 feet to a stake; thence S. 05-38 W. 65.6 feet; and thence S. 17-38 W. 56.3 feet to the stake previously mentioned on the

Thompson & Wife, Edna Askew Thompson, Fork Township, Wayne County, N.C.," prepared by Bobby Rex Kornegay, Registered Surveyor, dated May 9, 1988, which will be found duly recorded in Plat Cabinet I, Slide 214, Wayne County Registry, to which reference is hereby made.

And being the same property as First Tract conveyed to Leslie E. Thompson and wife, Edna Askew Thompson, by James W. Thompson and wife, Carolyn Ellis Thompson, and Leslie E. Thompson and wife, Edna Askew Thompson, by Deed dated June 1, 1988, and recorded in Book 1201, Page 625, of the Wayne County Registry.

Being all of Tract No. 3 containing 6.38 acres, more or less, as shown on the map entitled, "Property of James W. Thompson & Wife, Carolyn Ellis Thompson, and Leslie E. Thompson & Wife, Edna Askew Thompson, Fork Township, Wayne County, N.C.," prepared by Bobby Rex Kornegay, Registered Surveyor, dated May 9, 1988, which will be found duly recorded in Plat Cabinet I, Slide 214, Wayne County Registry, to which reference is hereby made.

And being the same property as Second Tract conveyed to Leslie E. Thompson and wife, Edna Askew Thompson, by James W. Thompson and wife, Carolyn Ellis Thompson, and Leslie E. Thompson and wife, Edna Askew Thompson, by Deed dated June 1, 1988, and recorded in Book 1201, Page 625, of the Wayne County Registry.

FORK TOWNSHIP, WAYNE COUNTY, NORTH CAROLINA, and more particularly described as follows:

Beginning at a stake in Massey's Branch 200 feet N. 69° W. from the intersection of a ditch with the run of said Branch which ditch is a boundary of the First Tract above described, and runs N. 86 1/2° W. 524 feet to another stake in Massey's Branch; thence Northeastwardly and Southwardly along said Branch to the point of beginning, containing 1 1/2 acres according to a survey thereof made by E. L. Parker, Surveyor, on January 8, 1941. And being the same property described as Second Tract in that deed to Alvin R. All of Grantor's right, title, and interest, the same being a one-fifthteenth (1/15th) undivided interest, but not limited to that, subject to the life estate of Irene B. Askew.

GRANTHAM TOWNSHIP, WAYNE COUNTY, NORTH CAROLINA, and more particularly described as follows:

Beginning on High-Way at the Crossing of High-Way 102 and thence along the New High-Way S 1 E 2241 feet and S 15 W 500 feet

to Falling Creek, thence with Creek N 66 W 340 feet and N 54 W 350 feet to a stake Ruth B Bordeoux corner thence with her line N 11 E 2500 feet to the High-Way thence along High-Way N 79 30' E 400 feet to the beginning containing 30 acres. And being the same property described as Tract Two in that deed to Irene B. Askew, dated October 11, 1950, and recorded in Book 363, at Page 7, of the Wayne County Registry. And being the same property described as Parcel No. 4 in that Deed from Irene B. The conveyance of the heretofore described parcels of land is made subject to all liens and encumbrances, ad valorem taxes, restrictions, easements, and rights of way of record.

TO HAVE AND TO HOLD the aforesaid lot or parcel of land and all privileges and appurtenances thereto belonging to the Grantees, their heirs and assigns, but first reserving the life estate of the Grantor.

And the Grantor covenants with the Grantees that Grantor is seized of the premises in fee simple, has the right to convey the same in fee simple, that the title is marketable and free and clear of all encumbrances, except those set forth above, (this conveyance is particularly subject to the life estate of the Grantor) and that the Grantor will warrant and defend the title against the lawful claims of all persons whomsoever.
