Septic tank was only 1/4 full of water at the time of opening, no water was reaching distribution box or laterals. House is vacant at this time. Hydraulic load tested and all 3 laterals took water. Ran water from the house and it did not reach septic tank. Tested flow from septic to distribution box with garden hose. All information is current to the time of the inspection.


