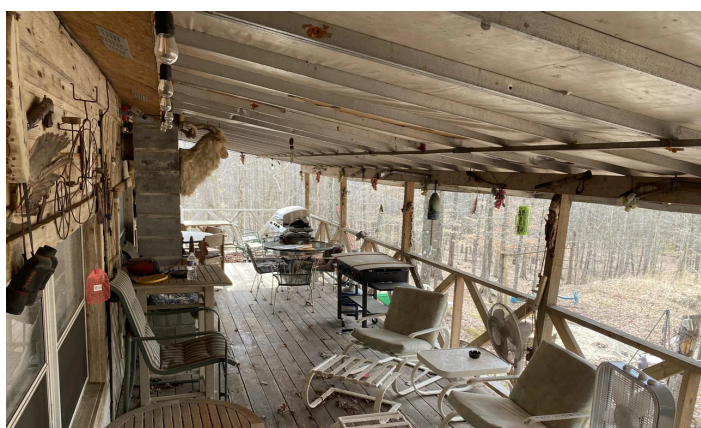

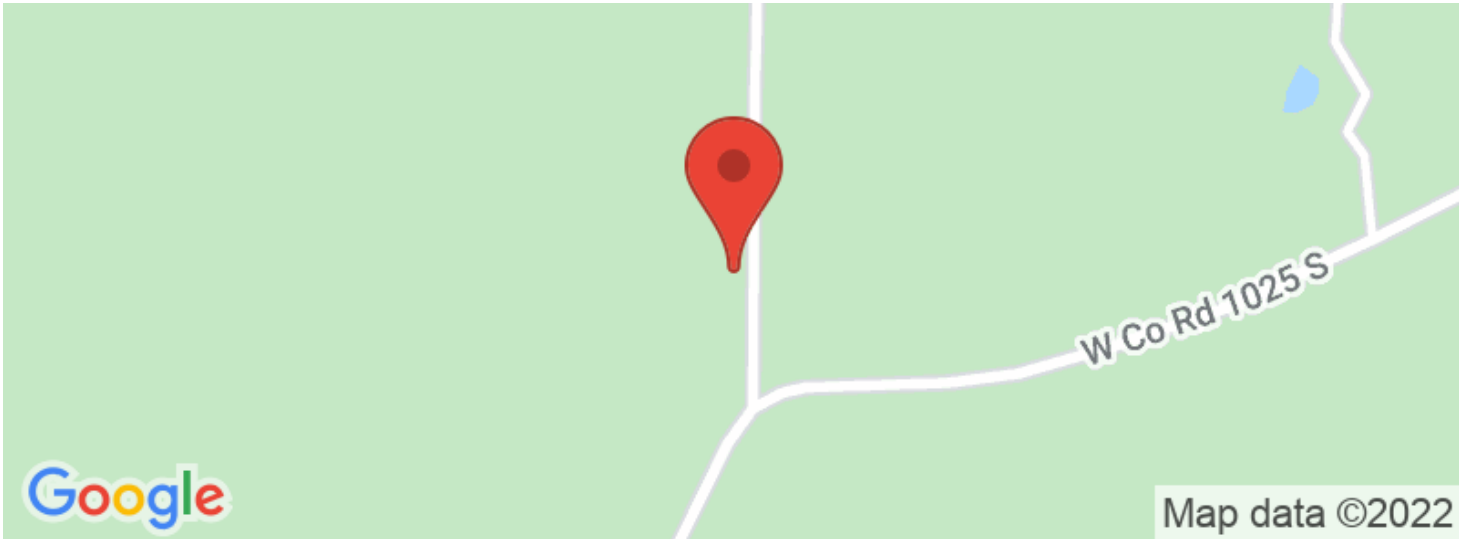

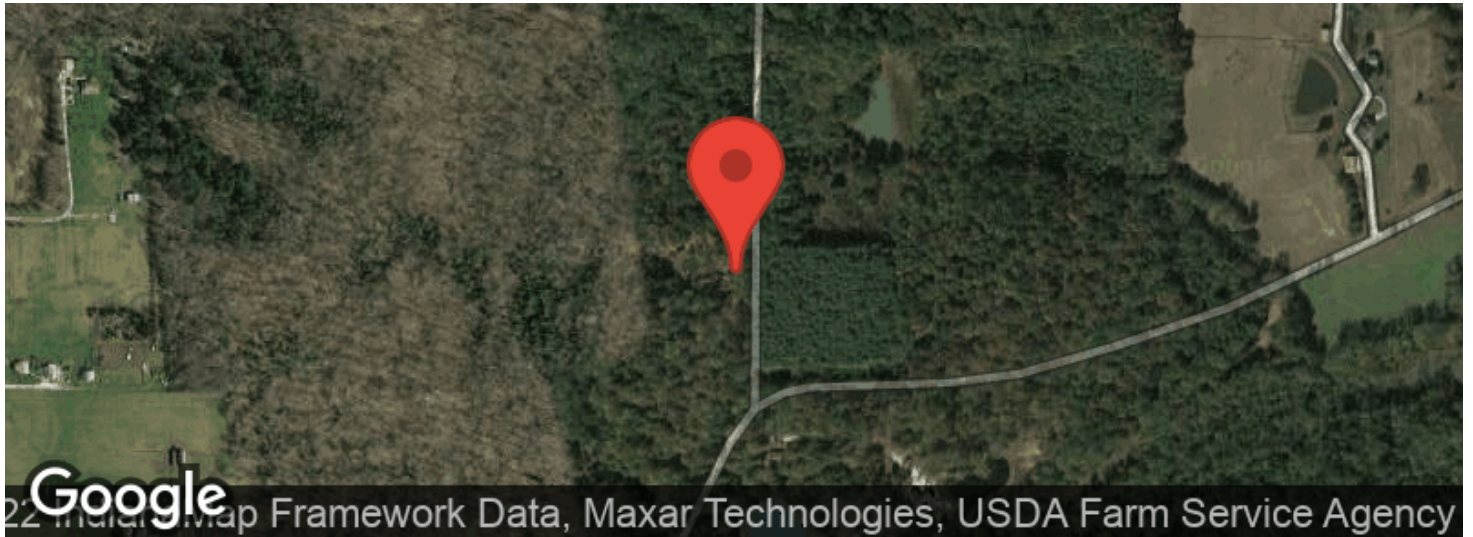


## Locator Maps
