This exceptional property showcases a newly constructed custom home, a 2,700 sq ft guest house and workshop, a historic mill site, an old barn and the distinctive Blackwater Station, originally built for the movie Lawless. Complementing the residences are six fenced pastures with shared cross fence watering troughs, two wells, a beaver pond, duck pond and the shared Elders Millpond. In addition, you also have the Little White Oak Creek and Pete Branch meandering through the land. Designed for both comfort and self-sufficiency the estate also features underground propane tanks, a whole-house Generac generator, Spectrum WiFi service and ample space for livestock, recreation and relaxation.

The main residence offers complete privacy and stunning views of your pastures, sunsets and surrounding wildlife. Inside you'll find a flowing open design that balances rustic warmth with refined finishes. The kitchen opens to the family room showcasing wood-accent beams, custom built-ins and an electric fireplace you can use year round. A sunroom filled with natural light provides the perfect setting for peaceful mornings or quiet evenings. The luxurious master suite is a true retreat complete with a flexible adjoining room ideal for a dressing space, nursery, secondary closet or workout area. The spa-style master bath features heated floors, dual vanities and a Smart mirror with dimming, heating and Bluetooth features. You will also enjoy the dual shower, custom walk-in closet with built-ins and a hidden safe room. Additional highlights include spray foam insulation, two 500-gallon underground propane tanks, on-demand hot water, separate HVAC systems and a smart garage camera system. The 3-car garage includes a half bath, pull-down attic stairs and abundant storage-ideal for seasonal decor and equipment. The butler pantry, walk-in pantry, laundry room and mud room are all separately designed for ease and organization making daily living effortless.

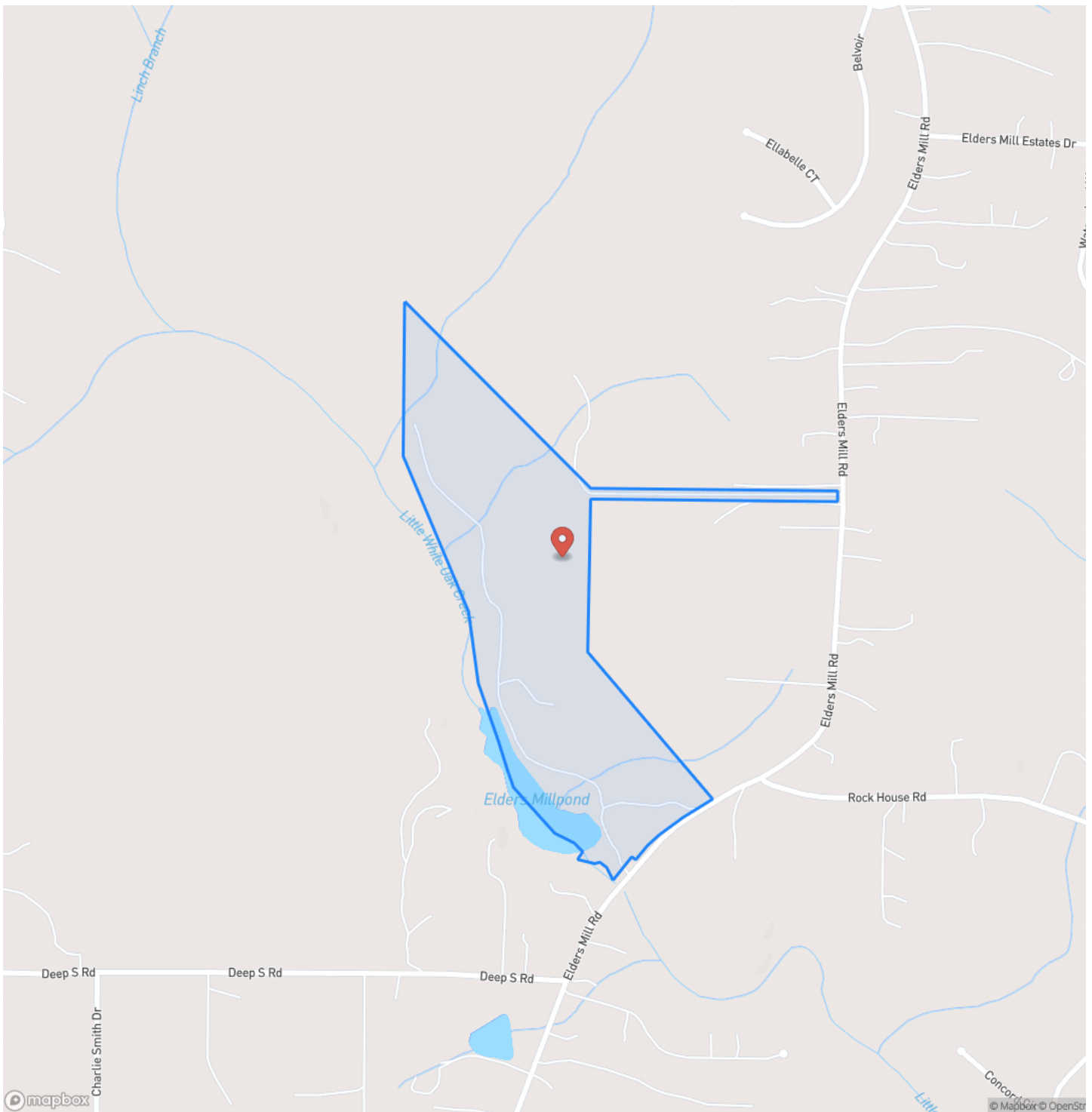

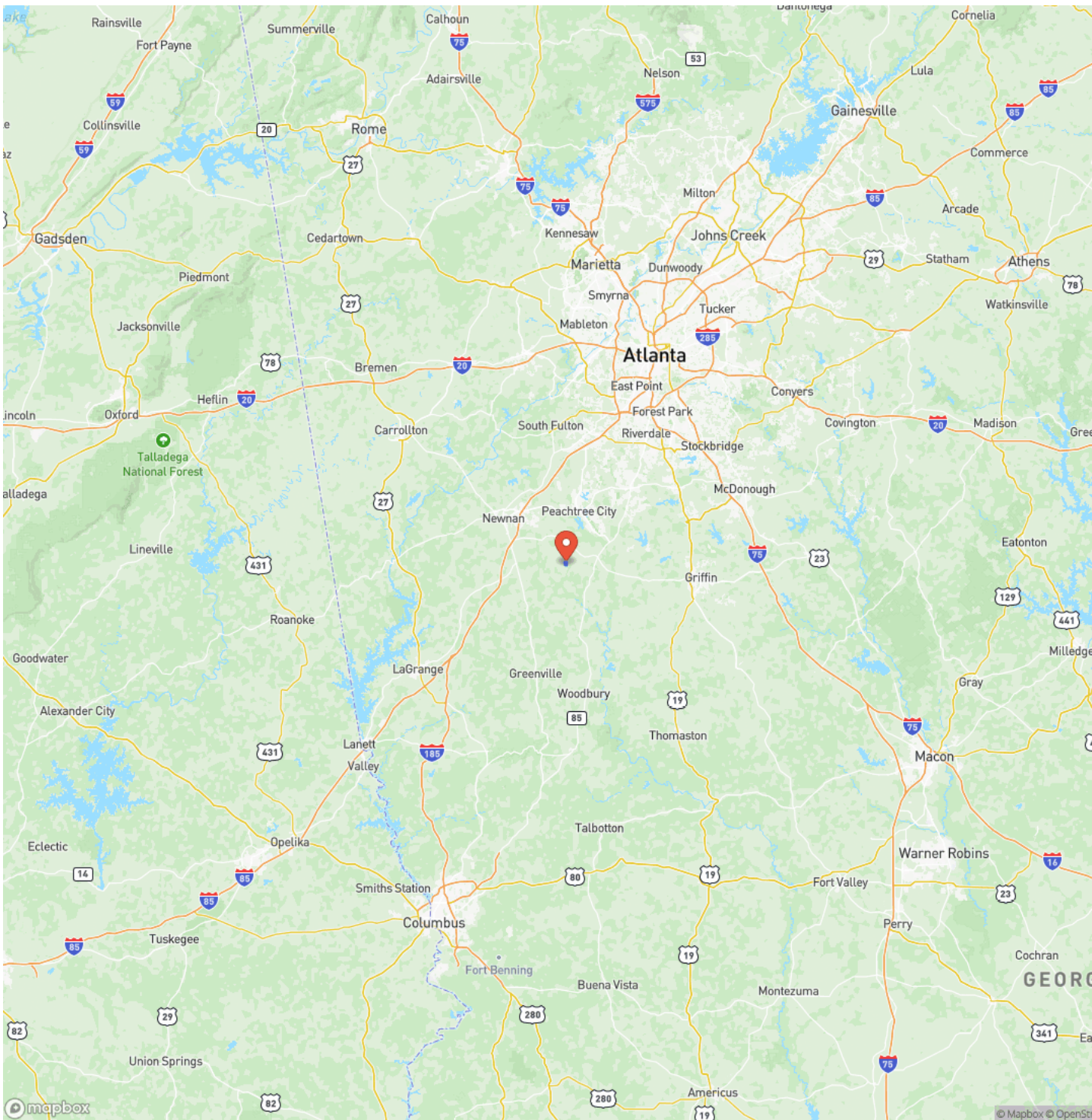


Locator Map
