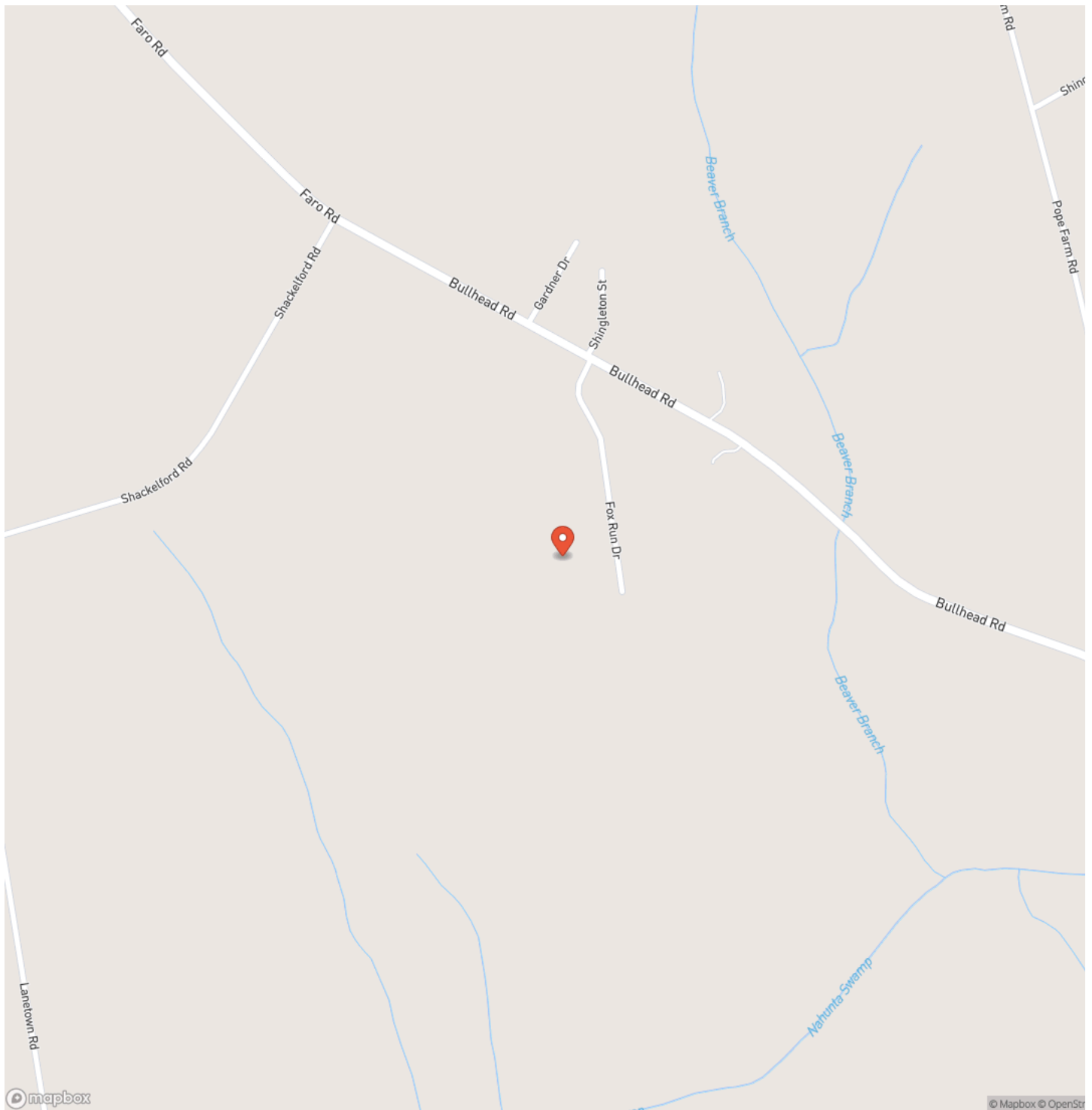

Locator Map

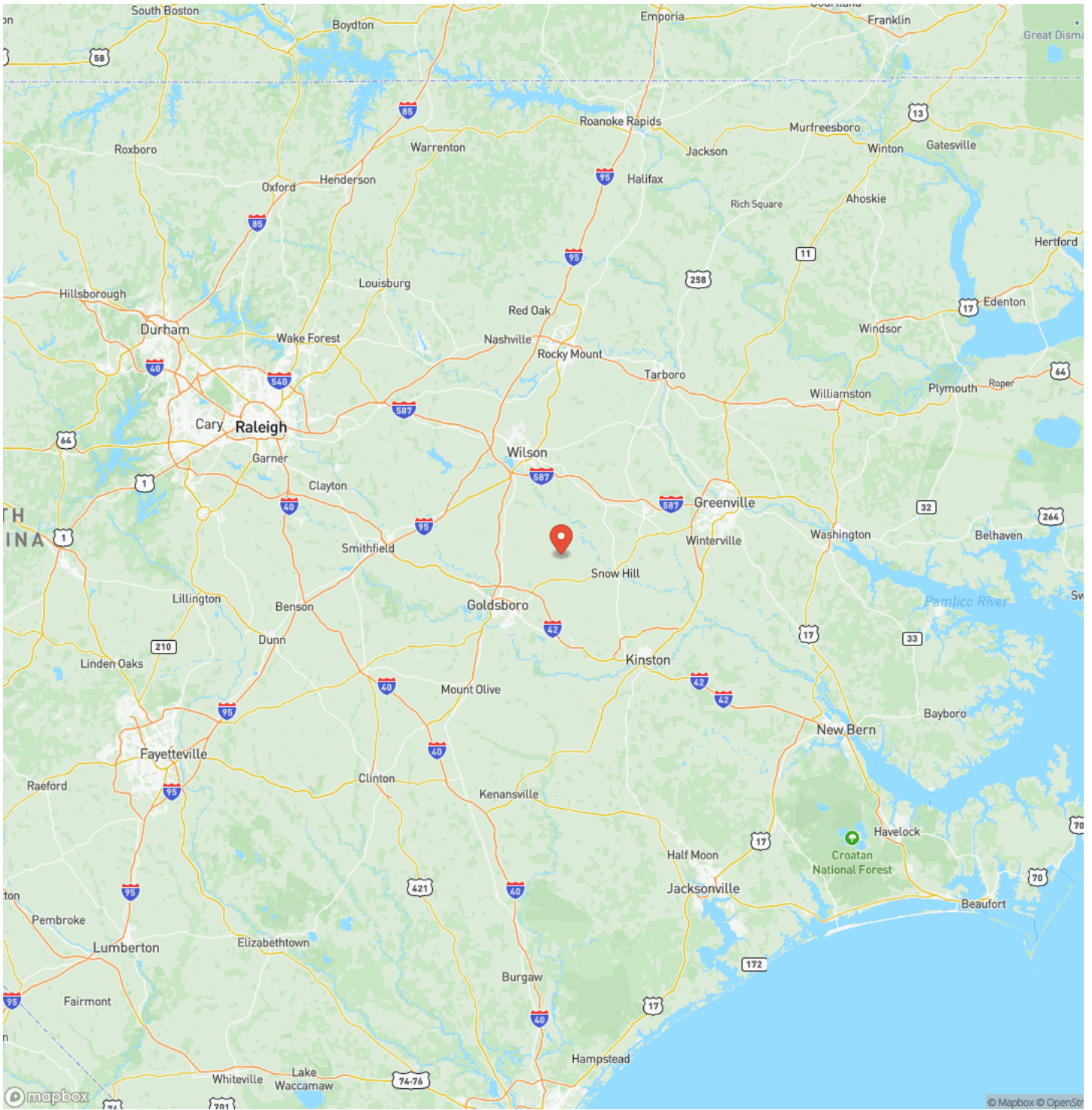
