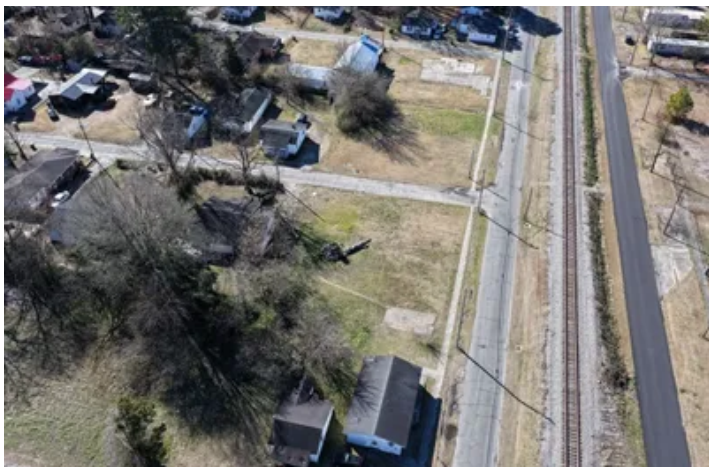

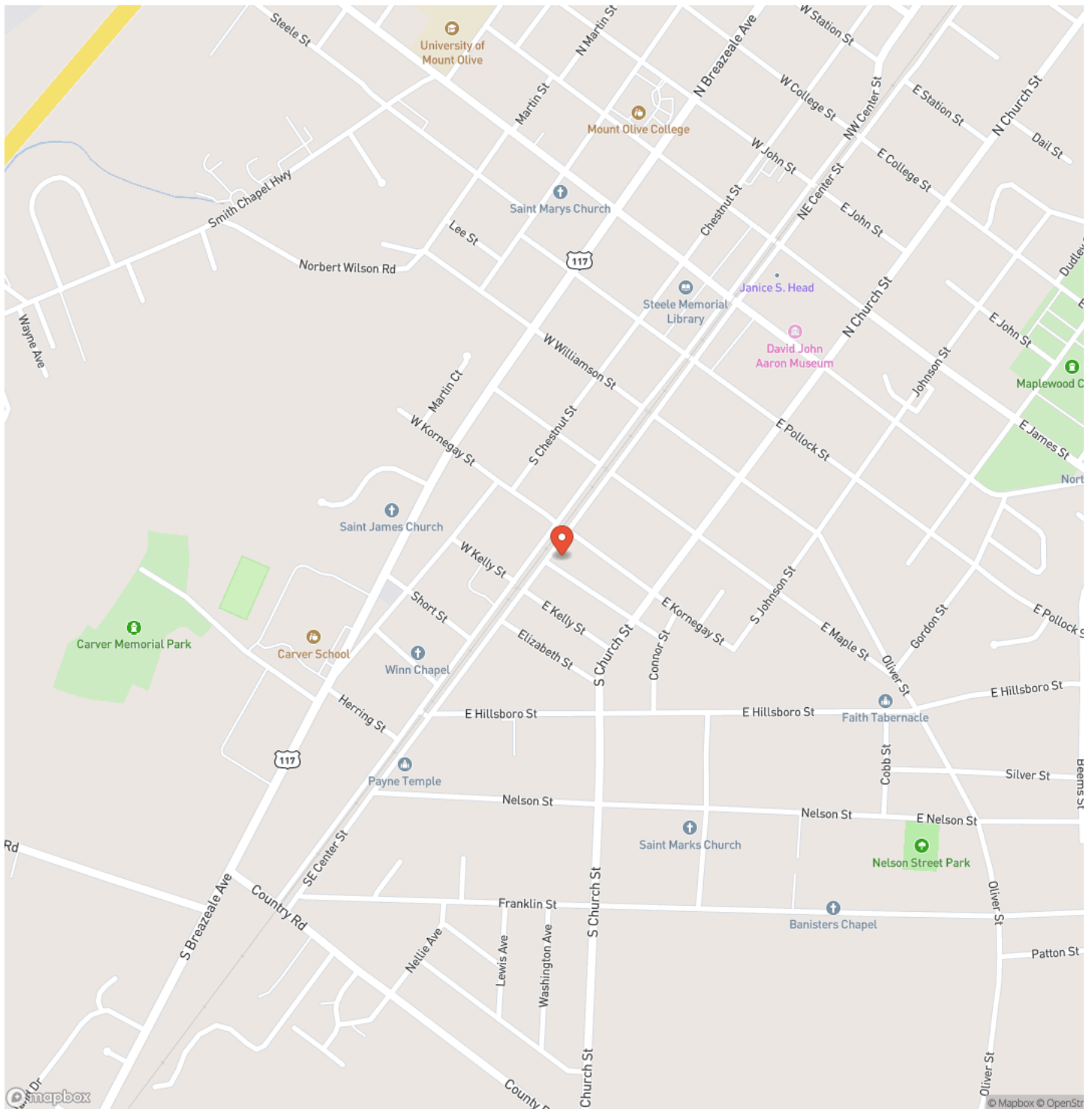

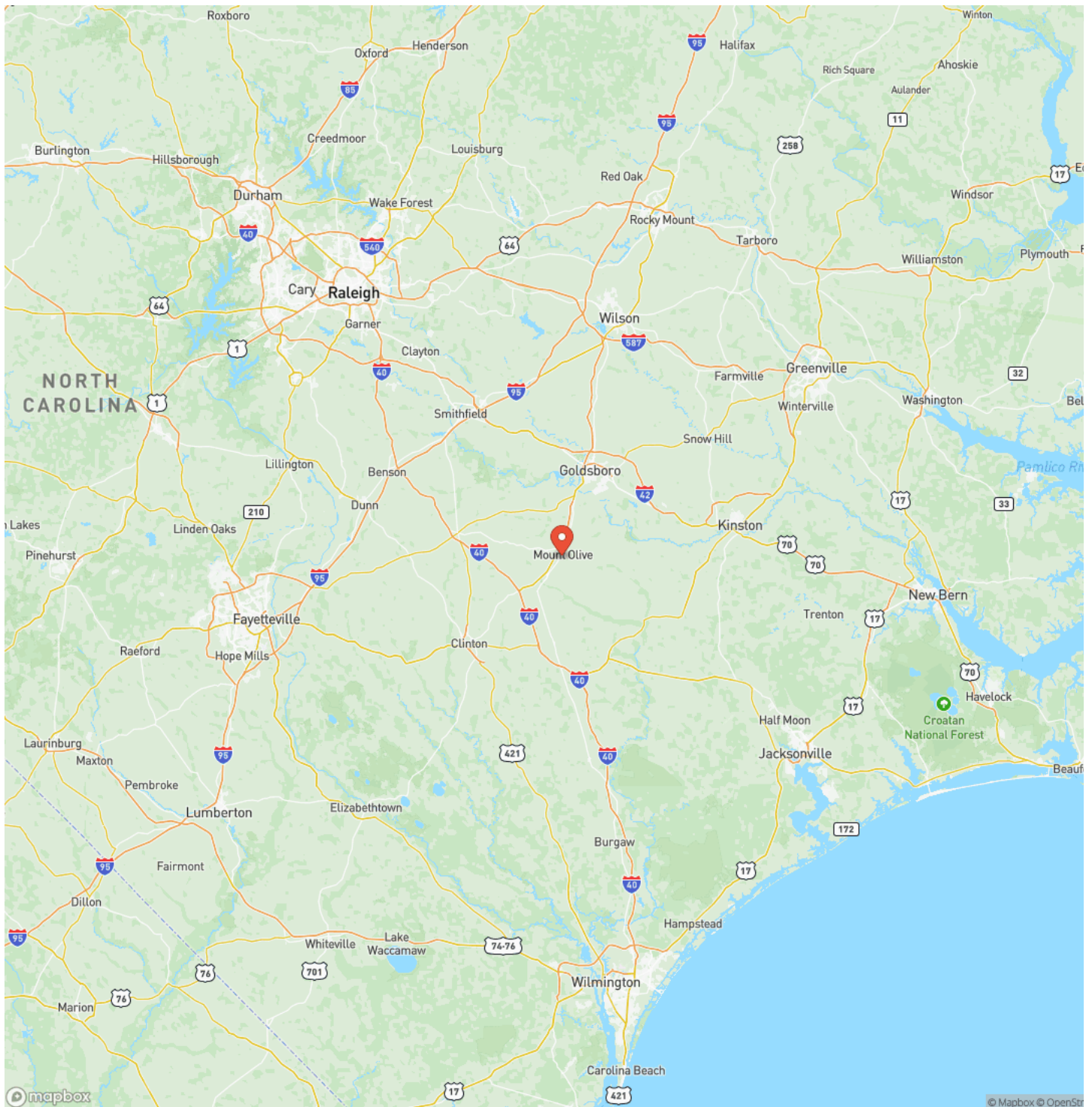

Locator Map



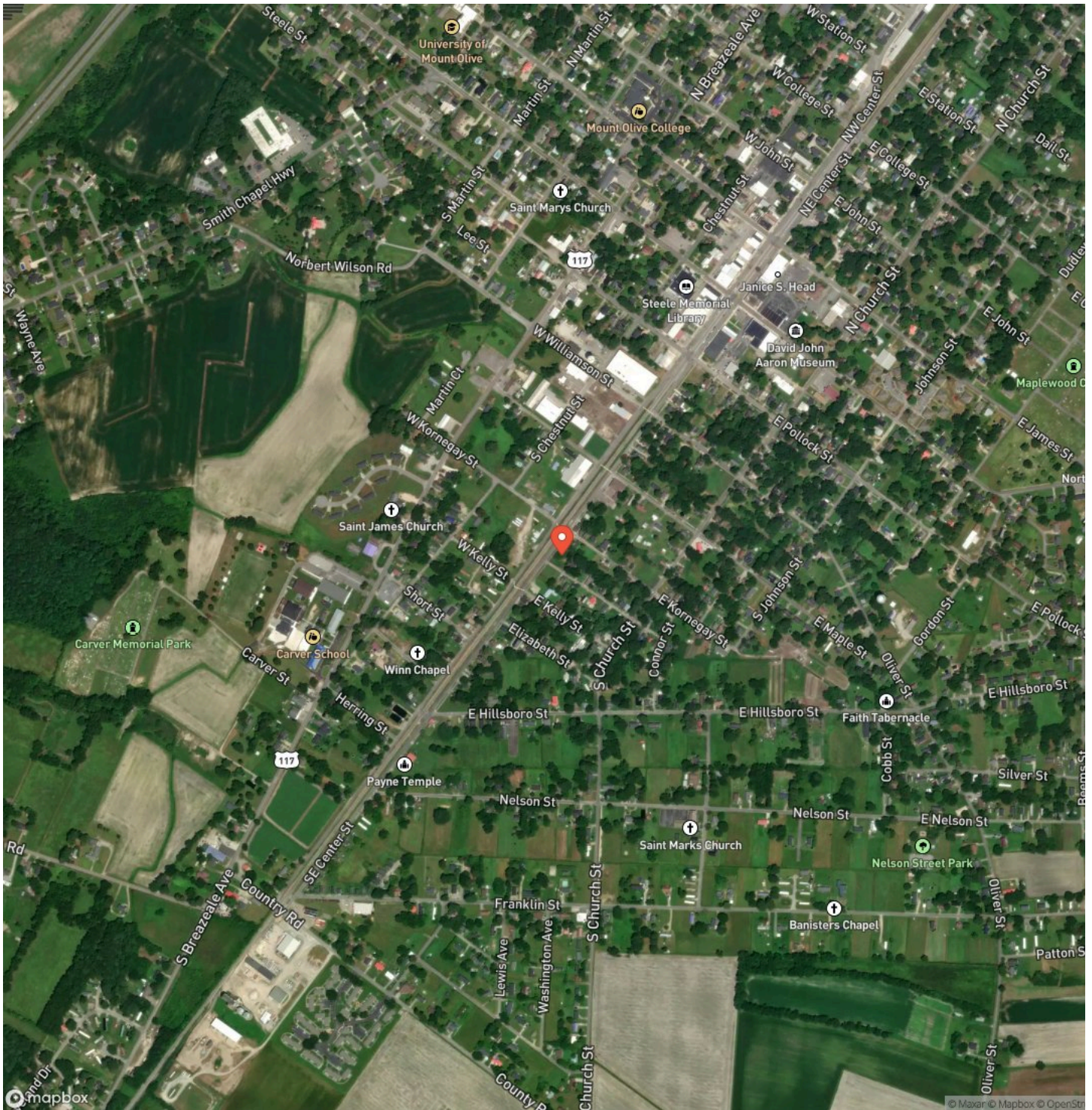
